


James D. Wolfensohn 1997 Business Leader of the Year

James D. Wolfensohn has been President of the World Bank since June 1, 1995. During his tenure at the Bank, he has traveled extensively to gain a personal understanding of the challenges facing the World Bank and its 180 member countries in the post-cold war era. His travels have offered him the opportunity not only to visit the Bank's development projects, but also to meet with its government clients, students, teachers and local representatives of business, labor, media, non-governmental organizations, religious and women's groups.

Mr. Wolfensohn's tenure at the World Bank is noted for the strategic alliances created between the Bank and the many governments it serves, the private sector, civil society, regional development banks, and the United Nations. In addition, during his presidency, Mr. Wolfensohn launched (with the IMF) the multilateral debt relief proposal for heavily indebted poor countries. He has also worked to increase the Bank's effectiveness in fighting poverty around the world and to meet the needs of the world's rapidly changing global economy through a major reform program—The Strategic Compact. This program moves the Bank closer to its clients by shifting resources to front-line lending and operations services.

Prior to his work at the World Bank, Mr. Wolfensohn was the President and Chief Executive Officer of James D. Wolfensohn Inc., an investment firm founded to advise major corporations in the United States and abroad. Prior to starting his own investment firm, Mr. Wolfensohn was an Executive Partner at Salomon Brothers and head of its Investment Banking Department. Additionally, Mr. Wolfensohn has held a series of senior positions in the finance industry. Throughout his career Mr. Wolfensohn has been associated with a variety of cultural and volunteer activities and organizations. These include Carnegie Hall, the John F. Kennedy Center for the Performing Arts, the International Federation of Multiple Sclerosis Societies, the Business Council for Sustainable Development, the Rockefeller Foundation, and the Population Council.

A native of Australia, Mr. Wolfensohn holds B.A. and L.L.B. degrees from the University of Sydney. He also received his M.B.A. from the Harvard Business School. Mr. Wolfensohn is married and has three children.

Mr. Ponnambalam:

GOOD MORNING. AND THANK YOU AGAIN FOR JOINING US TODAY.

IT IS MY PLEASURE TO BE INTRODUCING THE GEORGETOWN SCHOOL OF BUSINESS' BUSINESS LEADER OF THE YEAR, JAMES D. WOLFENSOHN. EACH SPRING, THE STUDENTS OF THE BUSINESS DAY STEERING COMMITTEE SELECT THE BUSINESS LEADER OF THE YEAR. IT IS IMPORTANT TO FIND A LEADER IN THE BUSINESS COMMUNITY WHO HAS STORIES TO SHARE AND LESSONS TO TEACH. IT IS ALSO CRUCIAL TO FIND A CURRENT LEADER: ONE STUDENTS WILL RECOGNIZE EITHER FROM CLASSROOM EXPERIENCES OR FROM THEIR EVERY DAY LIVES.

ONE CENTRAL THEME THAT IS DRILLED INTO ALL STUDENTS FROM THE DAY WE ARRIVE AT GEORGETOWN IS THE IMPORTANCE OF EXAMINING ISSUES WITH AN INTERNATIONAL PERSPECTIVE. THE INCREASED INTERDEPENDENCE OF NATIONAL ECONOMIES AROUND THE WORLD HAS ONLY ADDED WEIGHT TO THIS THEME. TODAY WE ARE HONORED TO RECOGNIZE MR. WOLFENSOHN, WHO HAS ESTABLISHED HIS CAREER AS AN INTERNATIONAL INVESTMENT BANKER WITH A PARALLEL INVOLVEMENT IN DEVELOPMENT ISSUES AND THE GLOBAL ENVIRONMENT.

SINCE BECOMING PRESIDENT OF THE WORLD BANK IN 1995, HE HAS TRAVELED EXTENSIVELY TO SEE FIRST-HAND THE CHALLENGES FACING THE BANK, AND

ITS 180 MEMBER COUNTRIES, IN THE POST-COLD WAR ERA. THE BANK, WHICH REPRESENTS APPROXIMATELY 7 PER CENT OF THE DEVELOPING WORLD'S TOTAL OUTSTANDING DEBT, HAS COMMITTED \$2 BILLION TO EASE THE DEBT BURDEN ON HEAVILY INDEBTED COUNTRIES.

MR. WOLFENSOHN HAS ALSO LAUNCHED A MAJOR REFORM PROGRAM—KNOWN AS THE STRATEGIC COMPACT—TO IMPROVE THE BANK'S EFFECTIVENESS IN FIGHTING POVERTY, AND TO MEET THE NEEDS OF A RAPIDLY CHANGING GLOBAL ECONOMY. THE COMPACT AIMS TO SHIFT RESOURCES TO FRONT-LINE LENDING AND OPERATING SERVICES, TO HAVE THE BANK MOVE CLOSER TO THE CLIENT THROUGH DECENTRALIZATION, AND TO OFFER A BROADER RANGE OF PRODUCTS.

PRIOR TO JOINING THE BANK, MR. WOLFENSOHN SERVED AS PRESIDENT AND CHIEF EXECUTIVE OFFICER OF JAMES D. WOLFENSOHN INCORPORATED, HIS OWN INVESTMENT FIRM ESTABLISHED IN 1981 TO ADVISE MAJOR UNITED STATES AND INTERNATIONAL CORPORATIONS. HE HAS ALSO BEEN EXECUTIVE PARTNER OF SALOMON BROTHERS IN NEW YORK, WHERE HE SERVED AS HEAD OF ITS INVESTMENT BANKING DEPARTMENT.

THROUGHOUT HIS CAREER, MR. WOLFENSOHN HAS ALSO CLOSELY INVOLVED HIMSELF IN A WIDE RANGE OF CULTURAL AND VOLUNTEER ACTIVITIES, ESPECIALLY IN THE PERFORMING ARTS.

HE HAS SERVED AS CHAIRMAN OF THE BOARD OF BOTH NEW YORK'S CARNEGIE HALL AS WELL AS THE JOHN F. KENNEDY CENTER FOR THE PERFORMING ARTS IN WASHINGTON, DC. HE CURRENTLY SERVES AS CHAIRMAN EMERITUS OF BOTH VENUES. IN MAY 1995, HE WAS AWARDED AN HONORARY KNIGHTHOOD BY QUEEN ELIZABETH II FOR HIS CONTRIBUTION TO THE ARTS.

BORN IN AUSTRALIA, MR. WOLFENSOHN HAS SERVED AS AN OFFICER IN THE ROYAL AUSTRALIAN AIR FORCE, AND WAS A MEMBER OF THE 1956 AUSTRALIAN OLYMPIC FENCING TEAM.
