

Below is some brief information for your meeting with Mr. Bissell at $11.00 \ \text{am}$ on October 8th.

- Mr. Bissell was appointed a member of the Inspection Panel on August 1, 1994, along with other two members. They have staggered terms of appointment for three, four and five years, and Mr. Bisell's was for three years.
- 2. Mr. Bissell served as the Chairman of the Panel from August 1, 1996, to July 31, 1997. He completed his service with the Panel on July 31, but to ensure continuity, as you know, Mr. Bissell was retained by the Panel as an adviser until October 10th, i.e. this coming Friday. Otherwise, he is currently providing advisory services to IUCN Interim Working Group on Large Dams.
- 3. During his tenure with the Panel, Mr. Bissell was inspector-in-charge of Requests for Inspection relating to four claims: Arun III Hydroelectric Project in Nepal (together with Mr. Umana), Emergency Power Project in Tanzania, Jute Sector Adjustment Credit in Bangladesh and the Itaparica Resettlement and Irrigation Project in Brazil.
