The Effective Governance for Economic Development (EGED) conference will bring together experts in developing evidence-based policies and reforms from across the region. Participants will share (i) lessons on the interface between data production, data analysis, and use of data for public policies, (ii) progress in evidence-based policy implementation, and (iii) approaches to strengthening the role of civil society. Presentations will focus on pressing challenges such as gender inequality, resource allocation, and public administration. Experts will show how cutting-edge analytical methods greatly improve the capacity of governments to create policy solutions.
