1. Country participation

- 48 countries in the Eurostat-OECD PPP Programme
- United Kingdom now contributing via the OECD
- For ICP 2021, Georgia and Ukraine are linked to the global comparison via Eurostat

2. Survey implementation status

- ICP 2021 integrated into the regular Eurostat-OECD PPP rolling survey programme:
 - 6 consumer goods and services (2 per year) with slightly different timetable in Eurostat and the OECD
 - Machinery and Equipment: same list, different schedule in Eurostat and the OECD
 - Construction: specific ICP survey conducted by 11 Eurostat countries + USA + Ukraine and Georgia





3. Data transmission

- All the data sent at least once
- Prices (last revision beginning of October):
 - prices from 2022 surveys replaced 2019 prices (House and Garden & Transportation, Restaurants and Hotels)
 - corrected prices following last validation
- HOV (June 2023)
- Annual PPPs and Expenditures sent for 2017-2021 for all the countries except Ukraine and Georgia (2017&2021 only)





4. Data to be revised

Prices

- 2022 surveys are not yet finalised for all the countries coordinated by the OECD
 → end of November 2023
- COE is in validation phase → end of November 2023

HOV

- The Rents survey is in validation phase → end of November 2023
- Annual PPPs and Expenditures
 - 2020 and 2021 calculated in December in the regular programme
 - 2019 recalculated for non-European countries due to correction on the Health PPPs
 - → end of December 2023 Beginning of 2024





5. Metadata

- Not yet sent
- To be sent by the end of the year





6. Workshops and meetings

- Virtual Eurostat Country meetings for the consumer goods surveys held in September 2023
- Next EU PPP Working Group in November 2023
- OECD: no meeting since last May





7. Outreach / announcements

- Revised Eurostat-OECD Methodological Manual on PPPs
 - All chapters revised by Eurostat and OECD, involving countries
 - Currently at proofreading and formatting stage
 - Intended release by the end of 2023
- Commission Regulation as regards the adjustment of the list of basic headings used for Purchasing Power Parities
 - Proposal to be discussed in the PPP Working Group in November 2023
 - to be adopted in 2024
