

Dear Lew,

I recently had the pleasure of spending several days at the International Rice Research Institute (IRRI) at Los Banos. IRRI is doing a good job of attacking two problems: improving rice yields at a time when productivity is in doubt; and helping farmers find practical ways to protect the soil and water on which long run production depends. You might be interested in the enclosed report on IRRI's work that I wrote for my Committee.

My principle purpose for writing, however, is to alert you to a problem which surfaced during my visit to IRRI, namely their concerns regarding a proposed World Bank loan to Viet Nam for, among other things, the purchase of agricultural pesticides. IRRI sources reported that their Viet Namese counter-parts were very concerned lest the proposed loan for pesticides swamp their still unconsolidated success in establishing won and The Viet Namese were integrated pest management (IPM) systems. also concerned that pesticide misuse, already serious in Viet Nam, could balloon and could pose new and bigger threats to farm families' health and result in pest resistance buildups.

Viet Nam is just beginning to make the transition from Soviet-sponsored pest control systems that relied on heavy use of dangerous pesticides. A big loan from the Bank, aimed too exclusively at the increase of rice productivity, could damage years of work unless special efforts are made establish a safer and more modern system. The hope of the Viet Namese with whom IRRI is working is that the Bank will ensure that training in proper pesticide use for Viet Namese farmers and regulators, the design of appropriate laws and regulations, and support for IPM research and extension will be required by the loan agreement.

Following my return from East Asia, I had several helpful talks with Bank personnel in your South East Asia office. They assured me that they totally share IRRI's concerns and are working with Dr. Peter Kenmore of FAO to make sure that Viet Namese control over the choice and use of pesticides is appropriate, that farmer

training is provided for, and that IPM practices will be supported and promoted. They also pledged to continue to work closely with IRRI and, if necessary, will not hesitate to reduce pesticide import supply if loan conditions are not met. I have so informed IRRI. We in the Committee are pleased with these reactions which seem to be fully consistent with the Bank's new operational directive on agricultural pest management. We understand that the latter is in the final stages of preparation. We must not lose this opportunity to help the Viet Namese adopt strong policies promoting sound pesticide management.

More generally, I would like to signal for you a serious and continuing problem with Bank pesticide loans as seen by our Committee and by the environmental community: it has not usually been the design of such loans that causes difficulties, but failure to provide followup that is strong enough and persistent enough to ensure that Bank conditions for pesticide choice and control and farmer training are observed. Loan recipients also need to perceive readiness on the Bank's part to suspend disbursement promptly if loan conditions are not met. I bring this to your attention because Bank toughness and consistency on the observance of pesticide loans is one of those central issues on which the Bank's environmental credibility rides. In this case, we're glad to see things moving along the right channels and hope that they continue in that direction.
