NOTICE OF AGREEMENT TO PURSUE DISPUTE RESOLUTION

Cameroon: Nachtigal Hydropower Project (P157734) and Hydropower Development on the Sanaga River Technical Assistance Project (P157733) – World Bank Accountability Mechanism

1. On October 19, 2022, the World Bank Board of Directors approved an Inspection Panel recommendation to investigate the Cameroon Nachtigal Hydropower Project (P157734) and Hydropower Development on the Sanaga River Technical Assistance Project (P157733).
2. On October 26, 2022, I wrote to the Parties in this case, offering the opportunity for dispute resolution, pursuant to paragraph 11(a) of Resolution No. IBRD 2020-0005/Resolution No. IDA 2020-0004 (the “AM Resolution”) and paragraph 30 of Resolution No. IBRD 2020-0004/Resolution No. IDA 2020-0003 (the “Panel Resolution”).
3. To facilitate the Parties’ ability to make an informed decision, as AM Secretary, acting as head of the Dispute Resolution Service (DRS), I led a DRS team on a mission to Cameroon to meet with the Parties from November 3 to November 5, 2022, in accordance with paragraph 7 of the DRS Interim Operating Procedures.
4. Pursuant to paragraph 11(b) of the AM Resolution and paragraph 31 of the Panel Resolution, I hereby inform the Executive Directors, the Inspection Panel and World Bank Management that the Parties voluntarily agree to pursue dispute resolution.
5. Pursuant to paragraph 12(a) of the AM Resolution, I hereby convene the dispute resolution process and the Inspection Panel shall hold its investigation in abeyance as set forth in paragraph 32 of the Panel Resolution. The process will be facilitated by the DRS in order to reach a mutually agreed solution between the Parties. Pursuant to paragraph 12(e) of the AM Resolution, at any stage in the process the Parties will have an opportunity to agree whether Bank Management may be present as observers.
6. Pursuant to paragraph 12(g) of the AM Resolution, the maximum length of the dispute resolution process is one year from the date of this notification, December 1, 2022. If both Parties agree, the process may be extended for up to an additional six months.

7. This matter has been assigned Case Number 22/03/DRS.
