



ACCELERATING SUSTAINABLE AND CLEAN ENERGY ACCESS TRANSFORMATION (ASCENT)

IN EASTERN & SOUTHERN AFRICA

Eastern and Southern Africa accounts for more than half of the world's unelectrified population and nearly a quarter of the global population without access to clean cooking. Accelerating energy access in the region is crucial not only for unlocking its potential and achieving its development goals, but also for global progress towards SDG7, the Sustainable Development Goal focused on achieving affordable, reliable and sustainable energy access for all.



A UNIQUE COLLABORATION PLATFORM

ASCENT is a multi-year, multi-billion-dollar program aimed at scaling-up energy access in Eastern and Southern Africa. It leverages the strengths of the entire World Bank Group (IDA, IFC, MIGA) and facilitates collaboration with development partners, the private sector, climate and impact financiers, governments, utilities, and energy service providers, as well as beneficiary communities.

KEY FEATURES OF ASCENT

- Will provide access to electricity to 100 million people and access to clean cooking to 20 million people.
- \$5 billion financing envelope with a goal to mobilize an additional \$10 billion from public and private sources.
- 20+ countries in Eastern & Southern Africa
- 7 year (FY24-30) timeframe

Scaling Distributed Renewables and Clean Cooking



Expand energy access with DREs and clean cooking technologies, including healthcare facilities and schools
