ARE COMMUNITY-BASED HEALTH WORKERS BRINGING US CLOSER TO HEALTH FOR ALL?

Tuesday, February 11, 1986

TOPIC: Health service delivery programs using minimally-trained community-based health workers (CHWs) have been developed in many countries in recent years. These programs are expected to improve the cost-effectiveness of health care systems by reaching large numbers of previously underserved people with important basic services at low cost.

Dr. Berman will discuss the results of a recently completed review assessing the cost-effectiveness of large-scale community-based worker programs in the People's Republic of China, Indonesia, India, Peru, Thailand and Jamaica. Commissioned by the World Bank, the study suggests that CHW programs have succeeded on some of their objectives but not in others. CHWs increase the coverage and equity of service delivery at low cost compared with alternate modes of service organization. However, they do not consistently provide services likely to have substantial health impact, and the quality they provide is sometimes poor. Large-scale CHW systems require substantial increases in support for training, management, supervision and logistics. The evidence suggests that, in general, their potential has not been achieved in large routine programs. Further development of these programs is needed to reinforce their successes and assure that they are adequately supported as an integral component of the basic health system.

SPEAKER: Peter A. Berman, Ph.D., is an Assistant Professor in the Department of International Health at Johns Hopkins University School of Hygiene and Public Health. Previously Dr. Berman served as UNICEF's Project Officer and Program Associate in Indonesia.
