SUBJECT: Nutrition Component Support -- TRP-2 Ghana

PHN finds itself with some excess resources for operational support to the regions prior to the end of FY93, with an April 30 deadline for requesting the funds. We have suggested to Mr. Nickesen that it might be useful to send a nutrition consultant to supervise the implementation of the nutrition component of the Northern Region Pilot Project under TRP-2 for approximately 2 weeks. We had earlier helped with drafting the TOR for an evaluation of the component, and while this mission will not replace the need for technical evaluation assistance, it could be useful for advancing the progress of the nutrition component.

My understanding from our budget officer, Auriol Jackson, is that we can cover up to \$2100/week, which in this case would constitute the consultant's salary. This would necessitate the division's picking up travel and living costs, which may be unrealistic given the time in the fiscal year. Mr. Nickesen was in agreement that this would be a helpful input to the project if resources were available.

I will be happy to draft the TOR and forward it to our budget officer if this proposal is acceptable. Please don't hesitate to call with questions. While I am out of the office on Wednesday, I am reachable at home (301-718-5136). Alan Berg would also be available tomorrow.
