Je puis néanmoins vous indiquer que nos services seront prochainement en mesure de formuler leurs conclusions, et je tiens à vous assurer que nous ferons tout notre possible pour vous les communiquer ainsi qu'aux autres bailleurs de fonds et aux autorités gabonaises au mois de janvier. Pour notre part, notre éventuelle participation à cette opération dépendra des résultats de notre évaluation; mais nous ferons certainement tout ce qui est en notre pouveir pour apporter une contribution appréciable à un projet ferroviaire viable. décision du Gouvernement français d'augmenter sa contribution, elle constitue sans nul doute une étape importante vers la solution du problème de financement du projet. En effet, même si l'évaluation peut démontrer que l'investissement est dans l'intérêt du développement économique du Gabon. un projet de cette taille comporte nécessairement des incertitudes dont les risques ne peuvent pas être tous laissés au Gouvernement gabonais. Il est donc essentiel que des aides comme celle de la France acceptent de prendre en charge une part importante du coût du projet à des conditions permettant de minimiser ces risques. Votre lettre est donc particulièrement opportune au moment où nous sommes en train d'achever notre examen du problème.

Dear Mr. President,

I acknowledge receipt of your letter dated November 7, 1972, concerning the Museum of Negro-African Art you wish to establish and I would like to say that I share your concern for preserving and enhancing the cultural heritage of West Africa.

As far as we are concerned, we are not in a position to indicate at this stage whether we shall be able to participate in this operation. But I share your view that a project of this type may have a considerable impact, though difficult to estimate, on the development of tourism in Senegal.

As you know, a Bank mission recently visited Senegal and several other West African countries to examine the possibilities of involving our institutions in the development of tourism in the region. A second mission is, in principle, scheduled to visit your country early next year to discuss the detailed studies necessary to complete the preparation of an infrastructure project to develop the Petite Côte in which we might be interested. This mission will certainly discuss the Museum project with your colleagues and determine its possible impact on our program.

Dear Mr. Reinhardt:

This is in reply to your letter dated November 24, 1972 regarding measures that might be taken to encourage the flow of private capital and technical knowledge to developing countries. In this connection, you refer to the discussion that my associates and I had with the delegation from APPI last July concerning this subject and state that you assume that in discussions you plan to have with selected governments you would be free to disclose to them on a confidential basis the substance of our July discussion, including the views I expressed on that occasion.

As you doubtless know, I have also received a letter from Dr. Abs enclosing comments of APPI on certain cases in which the Bank and IDA have made loans to countries which have nationalized or otherwise expropriated foreign interests. As I state in my reply to Dr. Abs, which is being sent today, implementation of the Bank's policy presents difficult problems, necessarily involves a large element of judgment and must allow the Bank to plot a course through controversial and highly sensitive issues raised by parties with diametrically opposed interests. In view of the highly sensitive nature of these issues, the basic disagreements involved and their political implications, as well as the nature of my relationships with the Executive Directors and the Governors of the Bank and IDA, I think it would be appropriate that our views on these issues be expressed directly to governments, rather than through APPI or any other third party. I should add that I already have made my views known to several governments and expect to make them known to others as suitable occasions arise.

If your Directors' Committee would like to discuss these matters further, one or more of my colleagues would be ready to meet with them again.

I regret, of course, that we have not yet been able to persuade APPI of the reasonableness and consistency of all the positions we have taken and I hope that the attached comments will resolve at least some of the doubts. The implementation of the Bank's policy presents difficult problems, necessarily involves a large element of judgment and must allow the Bank to plot a course through controversial and highly sensitive issues raised by parties with diametrically opposed interests. Given the nature of the issues involved, it is perhaps not surprising that both investors and expropriating countries on occasion criticize our action. Bear Mr. Secretary:

Reference is made to the letter dated September 27, 1968 from the Sational Advisory Council on International Monetary and Financial Policies, concerning the United States Government's approval of certain sales by the Bank of portions of its loans. That letter infermed us of the approval of the United States Government to such sales by the Bank in an aggregate principal amount of not more than \$1,500,000,000. Under this authorization we have sold portions of loans in the aggregate principal amount of \$1,477,341,248.11. Thus, the balance in the authorization is \$22,558,751.89. In order to continue these sales and to avoid delay in completing any of them, we wish to obtain a further authorization from the United States Government prior to the full utilization of the present authorization.

We hereby request that the Government of the United States increase the amount of approval given in the Council's letter of September 27, 1968, by \$100,000,000 to an aggregate principal amount of \$1,600,090,000.

Dear Mr. President,

I have now returned to Washington and I wanted to write to you to thank you for the kindness and hospitality extended by your Government during my recent visit to the Sudam. The program arranged made it possible for me to learn at first hand a great deal about your country.

I thought I would also take this opportunity to summarize some of the main points we discussed during our meeting. First of all, let me repeat my heartfalt congratulations to you and your Government for the tremendous achievement of ending the armed conflict in the Southern Sudan. As you know, a Bank mission is presently visiting the Southern Region, and when we have their findings we shall consider the most appropriate ways in which the World Bank Group can assist in the reconstruction and development of this potentially productive region.

In fact, one of the most vivid impressions I gained from my visit was the great potential for further development of agriculture and irrigation in your country as a whole, and the high degree of efficiency and expertise displayed by your Government in the management of the existing development schemes in the agricultural sector. Among developing countries, particularly those in Africa, the Sudan is singularly well endowed with agricultural land, water and a large pool of trained and experienced manpower. These strong favorable impressions have confirmed my view that we should press shead with the implementation of the Rohad Irrigation Project. We are actively assembling the remainder of the financing required for this purpose, and we expect to propose to your Government very soon a date for holding definitive negotiations for an IDA credit for this project.

Second, with the cesssion of hostilities in the South, your Government is now well placed to turn its attention and resources to the economic development of the Sudan as a whole to an extent which may not have been possible previously. Moreover, the goodwill engendered, abroad as well as at home, by this very important achievement should make it possible to mobilize new resources, domestic and foreign. You asked me whether the Bank was ready to help the Sudan in its efforts to increase the amount of aid coming from other external sources, and I confirmed that we had been in contact with countries interested in membership in the Consultative Group and that we were planning a meeting of the Group under the chairmenship of the Bank in about six months to review your country's development needs and plans and to discuss possible sources of finance.

In this connection, Sudan's own capacity to finance its development will play an important part. While I was struck with the potential for further development in the Sudan, I also became aware during my visit that in managing the economy and the public finances your Government faces severe problems which inhibit the successful exploitation of this potential. Until the Sudan can achieve some significant public savings by stemming the growth of recurrent expenditure, obtaining additional revenues and increasing the profitability of the public enterprises, it will be difficult to find the domestic and foreign resources required for even the most sorely needed development investments.

Lastly, even given a greater effort on the part of both your Government and the donors of external assistance, the likely flow of resources will probably not be adequate to provide for all the investment plans which were discussed during my visit. There is thus a need to assign economic priorities to all the various competing demands for investment funds and other scarce resources. This need was perticularly clear to me in the case of the transportation sector. Under the US37 million IDA credit for highway maintenance which was signed last September, a substantial sum of money is provided for technical assistance to your Ministry of Transport to help in the preparation of an investment plan for the transportation sector and to improve the coordination between various types of transport. Studies will also be undertaken to identify about 500 km of roads having the highest economic priority, and fessibility studies of these roads will be carried out with a view to construction being financed by further lending by us or others. Thus we are already preparing to assist your Government in making some of the difficult choices which confront you in the field of transportation investment.

As I teld you moreover, we are prepared to help your Government if necessary in obtaining expert advice and assistance in overall economic planning and the analysis of investment priorities on a broader scale. I understand your Government has already approached the United Mations Development Programme with a request for technical assistance for the Ministry of Planning. If you wish, the Bank is prepared to act as executing agency of this project to assist UMDP in recruiting experts of the highest possible qualifications and ability.

In conclusion, Mr. President, let me thank you again for a most interesting, informative and pleasant visit. I can see that a great opportunity exists for the Sudan to address itself to its economic development. The World Bank Group is ready to provide substantial help in this endeavor, though, as in any country, the most important element will be what the Sudan can do for itself in the stewardship of its own resources.

Thank you very much for your letter of November 17 and the attached copy of an article from the "International Currency Review" on the Greek Drachma.

The article obviously used external debt calculations contained in the last two economic reports of the World Bank which have been discussed with the Greek Government (IMA 36e of May 28, 1971 and EMA 49a of March 22, 1972). However, the conclusions of both these reports are quite different from what the authors of the article seem to imply. In addition, the figures given by the authors on Greece's recent development would not in any way seem to constitute a "gloomy warning".

I was very pleased to learn that the Khanabad Irrigation Project has now been ratified by the Parliament and am sure that your authorities will soon complete other necessary steps, so that IDA can declare the credit effective. As I mentioned during our discussions in October with your Foreign Minister, Afghanistan can derive full benefit from development projects only if these projects are implemented promptly and efficiently. It therefore seems to us a matter of some urgency that appropriate action be taken to resolve the general ratification problem in order to avoid in future the type of delay which the Khanabad Project has experienced. As promised in our meeting, the Bank's legal staff has recently conveyed to your authorities some information on how other countries have streamlined their ratification procedures, and I would hope that similar action will soon be taken in Kabul. If this is done, projects scheduled for consideration by our Executive Directors in the next few months will not experience the same delay in ratification which has been so costly in the case of Khanabad. In my absence, Mr. Gunter R. Wiese advised you by cable on November 15, 1972 that the Association would consider the points raised in your letter. In addition, Mr. Wiese informed you that any change in the interest rate agreed upon between the Government of Bolivia and the Association may only be made by agreement between the Government and the Association, and that any loans to ranchers made at an interest rate of less than 12 percent would not, for the time being, qualify for reimbursement from the credit accounts.

We have now reviewed the situation, and propose to initiate discussions with the Government of Belivia on the possibility of introducing a system of indexing on the loans being made to the ranchers. For this purpose, a mission will visit La Paz in the course of the next week.

I very much hope that these discussions will result in an early resolution of the interest rate problem in Bolivia.

Dear Mr. Minister:

I was pleased to have had the opportunity during the Annual Meetings to have an exchange of views with you on a number of issues of mutual interest, including the possibility of New Zealand becoming a member of IDA. On that occasion, I advised you that because of the long delays and involved procedures required for increases in IDA resources to become effective, we proposed to request Part I members to appoint Deputies before the end of the year to discuss IDA's Fourth Replenishment covering our fiscal years (ending June 30) 1975, 1976 and 1977. Letters have already been sent to IDA's Part I members requesting them to appoint Deputies, and Sir Denis Rickett in a letter written to you in my absence has invited New Zealand to appoint an Observer. We do hope, however, that New Zealand would see its way to becoming a member of IDA and thus be able to participate as a Part I member in these discussions.

During our recent conversation, you mentioned that despite the fact that New Zealand's foreign exchange reserves are at their highest level ever, an obstacle to New Zealand's membership in IDA arises from the uncertainties regarding the impact on New Zealand's balance of payments of Britain's entry into the Common Market. Actually, the effect of IDA contributions on New Zealand's balance of payments would be rather small because, as Attachment I shows, actual calls on contributions are likely to take place over a period of some 10 years.

We plan to hold the first meeting of the Deputies designated by Part I members in the middle of December. We hope that New Zealand would find it possible to make an early decision to join IDA, thereby expanding the multi-national and co-operative character of the Association and increasing its resources. I look forward to hearing from you.

of October 16, 1972, confirming the content of your cable of the same day according to which the Government of Spain has released, in convertible form, the remainder of \$6,393,000 (in 1960 dollars) of the 90% of the initial subscription to the International Development Association and the first instalment of \$833,333.33 (in 1960 dollars) of the contribution of \$2.5 million from Spain to the Third Replenishment. I warmly welcome this action of your government which, together with similar action taken by Ireland and Yugoslavia, has significantly increased the number of countries contributing to the resources of IDA and thus emphasized the cooperative character of the Association and given recognition of the need for providing development assistance to the low-income countries by the members of the Association which are enjoying higher and rising levels of income.

A few days ago, Sir Denis Rickett, Vice-President of the Association, wrote to ask you to nominate an official of your government as an observer in the negotiations for the Fourth Replenishment. I hope this nomination will be forthcoming shortly.

I also hope that your government will give serious consideration to the possibility of changing the status of Spain from a Part II to a Part I country, thus giving formal expression to its growing financial strength and recognition of the commitment of the international community to assist in the development of poor nations. If this should not prove possible at present, I trust that Spain will nevertheless make again a contribution to the replenishment of the resources of the Association.

Thank you very much for your letter of November 2, 1972, bringing to my attention the project which Dr. Green and his associates in
Oklahoma are undertaking in Harar Province in Ethiopia. Although the
project appears to be one which should make a valuable contribution to
economic and social progress in this area of Ethiopia, I do not see any
means by which we can at this time directly provide the type of assistance which Dr. Green requests.

You and Dr. Green, however, will be interested to know that we have recently completed negotiations for an IDA Credit to the Government of Ethiopia which will finance activities directly complementary to those which Dr. Green and his associates are planning to undertake. Our Credit will assist in establishing facilities for the marketing and slaughtering of livestock in a large area of the country, including part of the Province of Harar. The Covernment of Ethiopia has not itself, however, proposed that any part of our Credit be used to provide the specific assistance which Dr. Green requests. I note, however, that AID has agreed to investigate the possibility of providing grant assistance for the purpose and I hope that they will be able to do so. If it should turn out that neither AID nor any other source within the United States should prove able to provide the relatively small amount of assistance required, and if the Government of Ethiopia should then request that we provide it within the framework of a future livestock development credit, we would of course be prepared to give serious consideration to such a request.

Dear President Kenyatta:

In June 1971, you were kind enough to write me a letter in which you expressed a strong interest in the proposal to organize an international research effort directed to the development of animal production in Africa, and offered to give all possible encouragement to the establishment in Kenya of an animal disease laboratory which would be part of that effort. As I wrote you at the time, the proposal was then being considered by the Consultative Group on International Agricultural Research.

The Group subsequently entrusted the development of the proposal to an African Livestock Subcommittee; the Subcommittee consists of governments and organizations interested in giving financial support to the proposal, and the World Bank provides the Chairman. The Subcommittee, in turn, selected a team of scientists, headed by Dr. William Pritchard of the University of California, to make recommendations concerning the scope and organization of such an animal disease laboratory, and to carry on discussions with the authorities of the East African Community looking toward its establishment at Muguga in Kenya in such a way as to benefit from Community facilities there.

During the spring and summer of 1972, the Pritchard mission, as you know, carried on discussions with representatives of the Kenya Government, and with representatives of the East African Community and of the Governments of Tanzania and Uganda. At a meeting of the Community Council on July 20, however, the conclusion was reached that the Community was not in a position to be host to the proposed laboratory. More recently, the Consultative Group has considered the matter further and has decided that efforts to establish the laboratory in Kenya should be continued.

As you know, the Consultative Group is also studying proposals to establish an integrated African Livestock Research Institute at some appropriate location or locations within Africa. The Consultative Group is of the view that the proposed animal disease laboratory in Kenya, which would concentrate on development of vaccines to protect cattle against East Coast fever and trypanesomiasis should be so organized that it would become a sub-unit of the integrated Livestock Research Institute, if and when established. This conforms to your own view of the character of the laboratory, as set forth in your letter to me of June 16, 1971. Obviously, the laboratory once established would maintain close cooperation with related research efforts in the East African Community as well as other parts of Africa.

I hope, Mr. President, that you maintain your interest in having this laboratory established in Kenya. Upon your confirmation that this is so, I will be glad to arrange for an appropriate delegation representing the Consultative Group, including a senior official of the Bank, to visit Nairobi promptly to pursue discussions of this matter further with your authorities. I will await your reply, Mr. President, with keen interest.

I am deeply indebted to you for the very cordial reception Sir John Crawford received from you and your Government. I am particularly grateful for the time Your Majesty took to have an audience in which Sir John could learn directly of your aspirations for agriculture in Iran and your comments on how the Bank could more effectively assist in its development.

I have reviewed the proposals Sir John presented to you, the Prime Minister and your Ministers and am in full agreement with them. He proposes a pragmatic and comprehensive approach which views agriculture and rural policy as a whole. The special emphasis on agriculture in the Fifth Plan is seen as a priority for the total program encompassing the production, welfare and employment aspects. All the elements of the program are seen as interacting with and being complementary to each other. We believe that such an approach is valid and would provide a context in which particular elements can be seen in proper perspective.

If Your Majesty agrees, we intend proceeding with the establishment of a Task Force, which we expect will commence its operations in January. The Task Force will not be a unilateral Bank effort, but rather Bank staff working with Iranian officials on joint studies on key issues of mutual concern, bringing to bear their experience where this is considered feasible and helpful. The Study Teams should help to develop a closer working relation and understanding on agricultural and rural sector policies between the Government of Iran and the Bank and would endeavour to produce practical proposals for implementing these policies. An outline of these study proposals in the terms which were discussed and agreed in Tehran is being sent to the Managing Director of the Plan Organization and the Ministers concerned.

I am particularly pleased that agreement has been reached on the nature and scope of the Task Force's activities and the manner in which it will operate. This, of course, would not have been possible if it were not for the assistance given Sir John by your Ministers and their officials. It is my hope that the Task Force will make a constructive contribution to dealing

with some of the farm and non-farm problems of the agricultural sector and thereby improve rural living standards.

Sir John will visit Iran periodically to supervise the work of the Task Force. It would be most useful if he could have an occasional opportunity of reporting to Your Majesty on its progress, and I should be most grateful if this could be arranged when it seems appropriate.

The Banque Nationale Suisse is further requested to agree that the International Bank may freely convert the proceeds of such borrowing into any foreign currency. On its part, the International Bank agrees that it will pay the interest on and the principal of the bonds in free Swiss francs.



PROPOSAL FOR SETTLEMENT OF GHANA'S EXTERNAL DEBT

(Formulated at Meeting of Creditor Governments in London, October 9-11, 1972)

- 1. Following the decision made at the end of the 1970 Ghana Debt Conference, the representatives of Belgium, France, the Federal Republic of Germany, Italy, Japan, the Netherlands, Norway, Switzerland, the United Kingdom and the United States of America have met again. They have studied with interest the IBRD Updating Memorandum on Ghana's Current Economic Situation and Prospects, and have reviewed developments in the economy since the beginning of the year, and including the recent budget statement.
- 2. They recognize the constraints imposed on Ghana as a result of economic policies in the past. They are sympathetic with the Ghanaian objective of growth through self-reliance, and are encouraged at the indications of progress in carrying out these intentions. They wish to reassure Ghana of their continuing goodwill towards her.
- 3. They note in particular the large volume of external debt accumulated by Ghana and the limited volume of prospective foreign exchange resources available for debt service, imports and other payments.
- 4. They are anxious to assist Ghana in dealing with her problems and in achieving an adequate rate of growth and an early restoration of normal external economic and commercial relations.
- 5. In the light of the above considerations the Governments of the countries concerned make the following proposals for a settlement of the problem of the medium-term debt incurred before 24 February 1966:
 - a) All payments, other than moratorium interest, due under medium-term contracts covered by the Agreed Minutes of the 1966, 1968 and 1970 Debt Conferences which fall due on or after 1 July 1972 shall be rescheduled and there shall be a grace period of 5 years from 1 July 1972 to 30 June 1977.
 - b) The rescheduled amounts would be paid in thirty equal semi-annual installments starting on 1 July 1977 and ending on 1 January 1992.

- c) Interest during the grace and repayment periods would be payable on the outstanding amounts thus rescheduled at the concessionary rate of 2 1/2 percent per annum, and the higher moratorium interest rates provided for under the Agreed Minutes of the 1966, 1968 and 1970 Debt Conferences would no longer apply.
- d) For the purpose of ensuring equity between medium-term creditors Ghana would as a matter of priority bring up to date until 30 June 1972 payments due under the Agreed Minutes arising out of the 1966, 1968 and 1970 Debt Conferences.
- e) For administrative convenience and in accordance with customary practice in rescheduling arrangements, the creditor countries recommend that the Government of Ghana should not request measures of relief from countries for whom total payments due as defined in paragraph 5a) amount to less than \$2 million.
- f) The creditor countries expect that, in accordance with customary practice, the Government of Ghana will not make rescheduling arrangements with other creditors at terms less favorable to Ghana than those set forth in this proposal.
- 6. The Ghanaian authorities would for their part continue and intensify their efforts to improve the economic situation, thereby facilitating their access to the IMF's credit facilities.
- 7. They would also clear the arrears of short-term external debt as quickly as possible strictly on a non-discriminatory basis as between creditors, and would for the future limit the amount of short-term external debt to be contracted.
- 8. The creditor countries, noting the declared intention of the Government of Ghana to negotiate participation in foreign-owned industries, assume that prompt, fair and effective compensation will be offered to the nationals of the countries concerned.
- 9. The creditor countries believe that these measures should contribute to the restoration of normal aid relations. Ghana's need to attain a reasonable rate of economic growth and to improve her capacity to meet her international obligations over the longer run are recognized. The potential donors among them would welcome an early meeting to consider in the light of the debt settlement the provision of increased development aid, consistent with Ghana's self-help efforts.

10. The participants agreed to ask the IBRD to transmit these proposals on their behalf to the Government of Ghana and expressed the hope that the IBRD would continue to use its good offices in the search for a solution to this problem.

Your Imperial Majesty:

In your speech from the throne at the opening of the 1971/72 Session of the Ethiopian Parliament, you referred to the draft law defining the relationship between landlords and tenants and expressed the hope that the deliberations already started on the draft law would be successfully concluded during that parliamentary session and that the draft law would be promulgated.

Those of us in the World Bank Group involved in assisting agricultural development in Ethiopia shared your hope and have followed with interest the progress of the draft law in Parliament. We saw the proposals not only as a welcome beginning in reforming land tenancy and other land use arrangements, but also as an effort to implement the country's Third Five-Year Development Flan which observes that "very little progress in agrarian reconstruction and development, particularly in peasant agriculture, can be made under the existing conditions of tenure and farm size".

Our interest and concern with this problem has been heightened by the findings of a substantial mission from the Bank which made a survey of the Agricultural Sector in Ethiopia in the Fall of 1971. The need for the mission arose out of the recognition of the critical importance of agriculture to the development of Ethiopia and to improving the welfare of the majority who live in the rural areas and depend directly on the land for a living. So close was the cooperation between Ethiopian Government ministers and officials and the members of the Bank's Mission that the resulting report can rightly be regarded as a joint product.

The draft report of the Agricultural Mission is being studied by the appropriate authorities in Ethiopis and will be discussed with them by members of the Bank's staff towards the middle of November. The report proposes a strategy, policies, and projects for agricultural development. It also confirms that the slow rate of progress in agriculture is likely to persist until improvements in the tenure system are made, and it recognizes the great difficulties faced in solving this fundamental impediment to Ethiopian social and economic progress. All of us appreciate that in a matter of such high national importance your personal support and leadership are the main hope for achieving the needed changes.

In my recent address to the Board of Governors of the Bank, I stressed that our assistance must increasingly be geared to economic development which will benefit the masses of the mainly rural poor in our less developed member countries. We are already assisting the development of agriculture in Ethiopia through a growing number of projects, and I expect the Agriculture Sector Report to provide the vehicle for an expanded program of further assistance.

I am therefore writing to let you know that I strongly share your concern for bringing about changes in the tenure system as soon as possible, and I very much hope that the present Parliament will act favorably on the legislation before it and thereby make possible the expanded assistance to Ethiopian agriculture which we stand ready to provide. We shall follow with interest the progress of the draft law during the parliamentary session.
