# International Comparison Program (ICP) Technical Advisory Group (TAG)

- A Research Agenda document was produced following the recommendations of the "Friends of the Chair" (FOC) established by the UN Statistical Commission at the conclusion of the 2011 round of ICP.
- At the conclusion of the 2011 ICP, the UNSC established the Friends of the Chair (FOC) group at its 45<sup>th</sup> Session held in 2014, to carry out an evaluation of the 2011 ICP. The FOC group presented its preliminary report to the UNSC at the 46<sup>th</sup> Session held in 2015, and its final report at the 47<sup>th</sup> Session held in 2016.
- Particular aspect of FOC report refers to extensive commentary that followed the release of results from these two cycles. "A certain challenge arose from the cumulative effect of the two ICP rounds (2005 and 2011) which took the ICP from a one-time "snapshot" created by each solitary benchmark into a kind of time series-like environment with the requirement of time consistency." (Paragraph 12, E/CN.3/2016/9, UN, 2015)"
- Consequently, FOC recommended that no major methodological innovations are introduced for the 2017 ICP cycle to ensure comparability of results over time.
- TAG followed this recommendation and ensure that no major methodological changes were introduced during the 2017, 2021 and the current 2024 cycle.

The FOC identified a list of research topics that are essentially limited to fine-tuning methods and procedures:






#### Research Items for Immediate Term – 2017 ICP
