SUBJECT: Bank Contributions to Charities Including United Way

I am replying to the questions raised by Mr. Paul Arlman, Executive Director, in his memo to you of November 15, 1988, concerning the Bank's United Way Campaign.

- 1. The combined Bank/Fund contribution to the United Way mentioned in the Institutional Investor article (\$325,000) is a close estimate of last year's actual <u>staff</u> contribution of \$327,213. According to a report prepared by the United Way Headquarters of the National Capital Area, Bank <u>staff</u> contributions totalled \$249,627 and Fund <u>staff</u> contributions totalled \$77,586, for a combined contribution of \$327,213.
- 2. In addition to staff contributions, the World Bank/IFC corporate donation to the United Way was \$100,000 in 1987. The funds come from the President's (EXC) budget. (United Way funds have been included in the EXC budget since 1984; prior to that time they were provided for in the Staff Activities budget under PMD.)
- 3. The World Bank does contribute to other charities. The External Relations Department contributes approximately \$7,000 each fiscal year to charitable institutions in the local area. Beneficiaries have included the American Red Cross, Project Hope, and a number of smaller service organizations such as Iona House and the National Institute of Dyslexia -- many of which are assisted by World Bank staff volunteers. These contributions are an integral part of the Bank's community relations program. This program is designed to enhance understanding of the Bank in the Washington area, and to demonstrate our commitment to helping improve the quality of life of some of the less-privileged members of our immediate community.
- 4. The overwhelming majority of the Bank's charitable contributions are channelled through the United Way. These donations are then directed to the final beneficiaries in accordance with donor instructions. Staff are advised that they may designate a beneficiary or beneficiaries from a list of United Way member-agencies around the world, including LDCs (e.g., the Philippines, India, Thailand, Venezuela, Jamaica). This year's campaign has a special focus on world-wide disaster relief. A letter to staff dated

September 29, 1988 from this year's chairman states that staff may use the campaign "to donate to relief in one or several of the world's countries suffering from recent natural disasters." In addition to the United Way Campaign, staff occasionally take the initiative to launch their own fund-raising efforts for specific causes both in the local area and abroad (e.g., disaster relief for Bangladesh floods, famine in Ethiopia, Mexican earthquake, volcanic eruption in Colombia, and hurricanes in Jamaica and Nicaragua).

5. This year's United Way campaign is scheduled to end on December 31. Funds will be disbursed to beneficiaries after July 1st of next year. An annual report is prepared by the United Way which includes a list of the beneficiaries and the amounts they receive.

Please let us know if we can furnish any additional information to Mr. Arlman or to others who may be interested in the Bank's charitable and/or volunteer activities.

SUBJECT: Bank/IFC 1987 United Way Campaign

1. The 1987 Bank/IFC United Way campaign got off to a slow and rocky start, picked up some steam along the way, and managed in the end to achieve a most respectable if not record-breaking showing. Final results indicate that 56.5% of Bank/IFC staff contributed \$249,669, only 1.5% lower than the previous year's record 58% participation rate, and \$54,199 lower than the previous year's record dollar amount of \$303,866. The approximately \$50,000 difference in total contributions was due primarily to the fact that there were almost 800 fewer potential contributors, an outgrowth of the reorganization. Comparative figures for the past five years are as follows:

As you know, these funds are in addition to those raised in the Bank for other charitable purposes, both international and domestic. Children's Hospital was a prime recipient of funds raised within the Bank last year.

- 2. Our results compare favorably with those of the IMF, where 52.5% of staff contributed \$77,236, an average of \$81.73 per contributor. (This was the first year we topped the IMF in percentage of contributors.) They also compare favorably dollarwise, if not percentage-wise with those of the Inter-American Development Bank, where 66% of staff contributed \$43,782, an average of \$47.38 per contributor.
- 3. In addition to providing a smaller pool from which to solicit, the reorganization took its toll in other ways. The campaign got underway later than usual which put us out of phase with the overall metropolitan campaign. The new reorganizational structure and the wholesole shift of staff from one part of the Bank to another made a shambles of the carefully-crafted organization of campaign coordinators and volunteers which had been built up over the preceding years. Former volunteers were

hard to locate, new ones difficult to enlist, and both groups reluctant to volunteer time and effort while feeling their way with new jobs and supervisors. Those not pleased with the results of the reorganization (this included contributors as well as volunteers) saw non-participation as a way of "striking back," albeit in an inappropriate, unrelated way. There were a number of people, including some on the Steering Committee, who suggested that we not have a campaign but I think our business-almost-as-usual decision was a correct one. We did enrich the United Way coffers by almost \$250,000; we did engender some positive spirit among our co-workers, and we did sustain a respectable base upon which this year's campaign can build.

- Past campaigns have used multiple-prize raffles to encourage participation. In the spring of 1987, the Steering Committee decided to feature an auction as part of the 1987 campaign. Unfortunately, the auction chairman was one of those who left the Bank as a result of the reorganization and, in her absence, the operation collapsed. We managed to salvage enough of the raffle/auction idea to offer two "grand" prizes -- a vacation trip to Great Britain and a two-for-one trip on the QE II--and we used an honor system for participation, distributing a raffle ticket to each staff member and urging any who had not yet contributed to do so before submitting their raffle ticket. Before we announced the raffle, 45% of staff had contributed \$233,719, compared with the 56.5%, \$249,669 final figures. Thus, the raffle appears to have been responsible for much of the 11% last-minute surge in the participation rate. (Although the per person contribution of this 11% was only \$39.20, the additional amount raised was \$23,909.) We also did a holiday desk-to-desk distribution of an elephant good luck charm and accompanying fable. It is unclear how many dollars this effort added but, judging from verbal and written feedback, it resulted in considerable goodwill. Some individual units had their own miniraffles or other forms of inducement, all of which seemed both to improve office ambiance and to increase participation.
- 5. In former years, the Bank has sponsored at least one loaned executive. Last year, again most likely because of the reorganization, no one volunteered and, after consultation with Mr. Cosgrove and others, we decided not to attempt to recruit one. A volunteer has been identified for the upcoming campaign and I suggest we re-join the program. The Steering Committee had previously recommended that the loaned executives's salary come from Bank-wide funds during the period he or she is working for United Way headquarters but, in the absence of a loaned executive last year, the recommendation was not implemented. We think such a practice would make it easier for managers to permit individuals to participate since, although there would still be the loss of an employee's time, there would not also be a monetary loss. I suggest this recommendation be implemented as part of the upcoming campaign.

- The Steering Committee itself (a volunteer group of exchairmen, loaned executives and other interested parties) also suffered as the result of the reorganization. In revitalizing it this year, I suggest that we institutionalize some membership. I think there should be a representative from: (i) Personnel (Carol Word served last year and she proved very helpful in assisting us in our efforts to reconstruct work units and find volunteers and coordinators; I suggest she serve again); (ii) Administration (it would facilitate our efforts to ensure cooperation from building guards, the Print Shop, and other parts of the Bank where cutting through red tape quickly is essential; I suggest David Steel; (iii) Public Affairs (where publicity in Bank's World, the Weekly Bulletin and other publications -- kept to a mininum last year -- can facilitate communication; I suggest Aguirre-Sacasa or his appointee); (iv) the IFC (I suggest Judith Riorden from Mr. Ryrie's office); (v) the President's office (where the evidence of support-from-the-top is invaluable; I suggest Linda McLaughlin); and (vi) the 1818 Society and the World Bank Volunteer Services since we would like to integrate our efforts with those of these two groups.
- 7. Your support of the 1987 campaign was very helpful and I trust will continue this year. Volunteers and coordinators work from the bottom up but it is also important to receive endorsement from the top down. Stressing the campaign at the President's Council meetings inspires Senior Vice Presidents to do so at their staff meetings and so on down the line. A number of managers arranged to have presentations at staff meetings last year and I suggest that it be encouraged this year--especially when there is sufficient time to permit arranging for an outside speaker from one of the client agencies of particular interest to World Bank staff. Management support of ancillary activities is also important whether the activity be at the division or department level or Bank-wide such as the raffle or a fun run, a new activity being contemplated this year.
- 8. Jack Lowther, who was responsible for putting together the superb volunteer organization two years ago and who hopes to recreate his effort in the reorganized Bank, has been selected as this year's campaign Chairman. He will be assisted by Yosef Hadar whose ebulliency can once again be expected to account for at least five percentage points and \$10,000.

The Steering Committee had previously recommended that the loaned executives's salary come from Bank-wide funds during the period he or she is working for United Way headquarters but, in the absence of a loaned executive last year, the recommendation was not implemented. We think such a practice would make it easier for managers to permit individuals to participate since, although there would still be the loss of an employee's time, there would not also be a monetary loss. I suggest this recommendation be implemented as part of the upcoming campaign.

- The Steering Committee itself (a volunteer group of exchairmen, loaned executives and other interested parties) also suffered as the result of the reorganization. In revitalizing it this year, I suggest that we institutionalize some membership. I think there should be a representative from: (i) Personnel (Carol Word served last year and she proved very helpful in assisting us in our efforts to reconstruct work units and find volunteers and coordinators; I suggest she serve again); (ii) Administration (it would facilitate our efforts to ensure cooperation from building guards, the Print Shop, and other parts of the Bank Where cutting through red tape quickly is essential; I suggest David Steel; (iii) Public Affairs (where publicity in Bank's World, the Weekly Bulletin and other publications -- kept to a mininum last year -- can facilitate communication; I suggest Aguirre-Sacasa or his appointee); (iv) the IFC (I suggest Judith Riorden from Mr. Ryrie's office); (v) the President's office (where the evidence of support-from-the-top is invaluable; I suggest Linda McLaughlin); and (vi) the 1818 Society and the World Bank Volunteer Services since we would like to integrate our efforts with those of these two groups.
- 7. Your support of the 1987 campaign was very helpful and I trust will continue this year. Volunteers and coordinators work from the bottom up but it is also important to receive endorsement from the top down. Stressing the campaign at the President's Council meetings inspires Senior Vice Presidents to do so at their staff meetings and so on down the line. A number of managers arranged to have presentations at staff meetings last year and I suggest that it be encouraged this year--especially when there is sufficient time to permit arranging for an outside speaker from one of the client agencies of particular interest to World Bank staff. Management support of ancillary activities is also important whether the activity be at the division or department level or Bank-wide such as the raffle or a fun run, a new activity being contemplated this year.
- 8. Jack Lowther, who was responsible for putting together the superb volunteer organization two years ago and who hopes to recreate his effort in the reorganized Bank, has been selected as this year's campaign Chairman. He will be assisted by Yosef Hadar whose ebulliency can once again be expected to account for at least five percentage points and \$10,000.

- Mr. William G. Tull, President, American Security Bank and Chairman of the 1987 United Way Campaign of the National Capital Area, and Mr. Oral Suer, Executive Vice President, United Way of the National Capital Area, have asked to see you concerning the Bank's institutional contribution to this year's United Way Campaign. Last year's contribution was \$100,000, and they are likely to ask you to increase this amount. (Our recommendation is that we contribute the same this year as last.)
- In addition to the institutional contribution, Bank staff are again mounting a campaign to solicit contributions from staff members. Last year, 58% of Bank staff contributed more than \$300,000, record highs in both categories. Although we have set no targets for this year's campaign, we hope to match last year's record, though we recognize that this may be overly ambitious.
- Because of the reorganization, the Bank/Fund Executive Committee decided that the start of this year's campaign should be delayed about a month, roughly from October 1 to November 1. The reconfiguration of work units and the internal transfer of so many staff have made it difficult to line up agency volunteers and coordinators. As Round II draws to a close, however, Bill Cosgrove and others in personnel are assisting us in locating last year's volunteers and we are recruiting others in units where none presently exist.
- The reorganization also affected our ability to provide a Bank loaned executive to United Way headquarters. put a notice in the Weekly Bulletin asking interested staff members to contact us but we received no response. (Last year we selected our two loaned executives from among the 12 or so who answered a similar "ad".) We were not surprised since we anticipated that staff leaving the bank would not be interested and that those staying would be reluctant to be away from their new jobs for three months. We discussed the situation with United Way headquarter staff who fully understand this year's situation and look forward to our participation again next year.

- 5. Yosef Hadar, the Bank's United Way Coordinator, and I met last week with Thomas Ernst, a retired Xerox manager who is serving as this year's Loaned Executive to the Bank. We reviewed practical and logistical matters, a tentative timetable for the campaign, and the ways in which the United Way headquarters in general and Mr. Ernst in particular can assist us. Mr. Ernst will sit in on our Executive Committee meetings to offer advice and moral support.
- 6. At a later date we would like to talk with you about your role in this year's campaign. We expect this effort to parallel that of previous years with the exception of the delayed start and the probable substitution of an auction for the raffle. It is likely that we will ask you for the same sort of involvement as last year's, e.g. a communication to all staff, one or two personal appearances at a Bank-wide function and perhaps an auction item.
