

Dear Dave:

I completely agree with your suggestion that selected staff members of the Bank Group be seconded to less developed countries to participate in policy oriented research and analysis. At the same time, this would provide capable officials of developing countries with experience in the Bank Group's operations. In fact, we are already engaged in such an exchange to a limited extent, although not on a reciprocal basis.

At the present time, approximately 25 staff members are on assignment to planning ministries and other agencies in a number of developing countries, for periods of two to three years. This staff provides technical assistance while gaining valuable grass roots experience in the development process. We have also launched a program in recent years whereby competent government officials from less developed member countries join the Bank as full-fledged staff members for an agreed period of two to five years. They share with colleagues in the Bank their country experience and, at the same time, gain a broader perspective of economic development. This exchange has been quite successful and is certain to expand in the future.

You will appreciate that a direct exchange of Bank staff and developing country officials is difficult to arrange, but it has my full support. Thanks again for your thoughts on this interesting and important subject.

Dear Mr. Minister:

Thank you for your letter of July 22, 1974, which enclosed an application for program loan assistance. Since your letter was received you will, I know, have discussed this matter at length with Mr. Shahid Husain during his visit to Nairobi.

Let me assure you that there is clear recognition in the Bank of the particularly severe impact of changes in world prices upon Kenya's balance of payments. You are, however, aware that the World Bank very? rarely engages in program lending. It is our view that to justify program loan assistance, not only must a need from a balance of payments point of view be established, but, in addition, there must be a program of policies and investment plans which justify financial support. The economic analysis contained in our Basic Economic Report had already suggested that fundamental changes are required in the structure of Kenyan economic development if its impressive growth rate is to be maintained and at the same time the balance of payments gap is to be kept within manageable limits. It is our view, therefore, that the changes in international prices has aggravated an already worrying balance of payments problem in Kenya. Your letter and its enclosure confirm that this is also the view of your Government. You confirm that the Government has taken very determined steps in the budget and in other policy statements to deal with the country's short-run problem. Since, however, there are elements of the problem which can only be solved over the longer term we shall need to have a clearer understanding of the policy measures which are being taken or are being considered to bring about the structural changes contemplated.

I understand that our staff have already held preliminary discussions with your Ministry on some of these matters, and that they will be writing to Mr. Ndegwa shortly to suggest specific actions to be taken in preparation for the appraisal and negotiation of the proposed loan. If we can obtain understandings on these important policy and program issues, I would hope to recommend a loan to the Executive Directors of the Bank in the first half of 1975. I note that the application enclosed with your letter is for a program loan of \$100 million. While I recognize that Kenya's resource gap is large, in the context of the sizeable lending program we are planning to finance projects which are already under consideration, the amount of the program loan will have to be limited to the range of \$30-40 million which I understand Mr. Husain has already discussed with you.

Please be assured, Mr. Minister, of my very genuine concern over the serious balance of payments problems which confront Kenya and of our intention to be of maximum assistance to you inssolving these problems within the financial constraints imposed upon us.

Dear Madam Prime Minister:

As you know, I have been deeply concerned about the disastrous effects of the changes in the international economic situation on the prospects of many developing countries. Among these, India stands out both because of the serious impact of the deterioration in its terms of trade on the virtually stagnant economy and because of the vast number of human beings involved. India's external capital requirements have risen sharply just to assure maintenance of the present economic level; external assistance at a level substantially above recent years will be necessary to achieve even a minimum rate of economic growth and to bring about modest economic improvement for the benefit of the Indian people. Unfortunately, the prospects for mobilizing the required additional external resources on appropriately concessionary terms are more remote today than they have ever been before.

It is against this background that I told the Minister of Finance some weeks ago that I have been considering recommending to our Executive Directors a significant increase in the amount of World Bank lending to India in addition to the IDA resources which we hope to be able to continue to make available. But I am concerned, as you must be, that borrowing on Bank-type terms from the World Bank or from other sources would mean an increase in India's already heavy debt service burden and foreign exchange requirements in the future.

I have given considerable thought to the circumstances in which India could prudently incur substantial additional debt on Bank-type terms and in which it would be prudent for the World Bank and other lenders to increase their lending to India on such terms. Our analysis of these questions has led me to conclude that it would be indeed beneficial for India to borrow from the Bank — and reasonable for the Bank to lend — if such actions were in support of a systematic and effective program of adjustment to the present crisis, more specifically a program of economic and financial measures to increase the volume of exports and the domestic production of foodgrains, fertilizer and energy. It would seem that only such a program could give reasonable prospect of Shrimati Indira Gandhi, India

narrowing India's external payment gap in due course while investment is being maintained at a level which would permit a moderate rate of growth. It is in support of such a program that the additional Bank lending could serve to facilitate essential economic adjustments while strengthening at the same time India's ability to service a significantly larger volume of external debt.

It is clear, however, that even with substantial additional Bank borrowing India must still look to other sources to cover a large part of its substantial additional resource requirements. It must look to increased assistance from other members of the Consortium and to large sums from the Rupee bloc and from oil producing countries. There is sympathetic understanding of India's problems among Consortium countries and willingness to continue to help; however, there is also considerable disappointment with the progress achieved in recent years and a feeling that continued and increasing development assistance would be sensible only in support of effective adjustment programs. This concern is therefore relevant to the sustained flow of bilateral assistance from the Consortium, and to the mobilization of continuing support for the size of our IDA program in India.

I know that these matters already weigh heavily on your mind. Aside from making the adjustments required in general economic and financial policies, I am told your Government is now in the process of defining programs to increase rapidly the production of foodgrains, fertilizer, and energy, and to accelerate the growth of exports. It is only on the basis of such programs that India can afford substantial new borrowing from the Bank and others, and it is only on the basis of such programs that India's many friends may be persuaded to increase their aid efforts. I have asked our representative Mr. Gilmartin to explore with your officials how we can provide concrete assistance to your Government in formulating and refining relevant policies and programs of action designed to ovarcome specific problems affecting food and energy production and the operations of India's export industries. If you wish me to pursue the matter further, the Annual Meeting of the Bank and Fund in September would present an opportunity to discuss with your Finance Minister how the Bank Group's lending can most effectively support your objectives in these critical areas.

On July 8, I received a message from Mr. Nurul Islam, the Deputy Chairman of the Bangladesh Planning Commission, stating that he was writing "in response to the suggestions which have been made from time to time by the Bank as well as by the bilateral donor countries in the course of the last two years about the need for constituting an Aid Group/Consortium for Bangladesh". He said his Government was now prepared to accept that suggestion and he asked the Bank for "concrete proposals" on this subject, "including the composition of and procedure for the formation and effective action of the proposed Aid Group."

On July 10, I replied to Mr. Islam, saying that it had been "a matter of mounting concern to us and to Bangladesh's many other friends that there does not exist a formal organization to assist in mobilizing external resources for the development of Bangladesh." I said that I was gratified that his Government had taken the initiative in asking for the establishment of an Aid Group and that I would undertake to do everything possible to assure the creation and effective operation of an Aid Group.

Since then we have had further exchanges of communication with Mr. Islam, as a result of which we have agreed on a list of countries and international institutions which should be invited to participate, as members or as observers, in an Aid Group, and Mr. Islam has asked the World Bank to act as its chairman.

This is a particularly important moment for creation of an Aid Group for Bangladesh, for that country faces not only an immediate and serious payments problem but the long-run need for a greatly enlarged capital inflow, if its minimum development needs are to be met. An Aid Group should play an important part, not only in coordinating the efforts of Bangladesh's friends, but also in raising additional external resources to assist in the economic development of Bangladesh. Accordingly, I have accepted Bangladesh's invitation to organize an Aid Group, to be convened at an early date, and am pleased to have the Bank accept the responsibility of chairmanship of the Group. Attached is a list of the countries and institutions which Bangladesh and we have agreed should be invited to participate in the Aid Group. The countries have been selected because there is reason to believe they will be interested in assisting the economic development of Bangladesh, and because it is hoped that they will be prepared to do so through the concessional development aid which Bangladesh will require over the coming years. Among the institutions is the IMF. The object of this letter (similar communications have gone to the countries and other institutions) is not simply to inform you of the actions being taken towards creation of an Aid Group, but more particularly to invite the IMF to participate in the Aid Group. I would appreciate a response at the earliest moment. If, as I hope, the decision is taken to participate in the Aid Group I would be grateful to know the name of the official to whom we should address future correspondence on this subject.

I am in consultation with the Government of Bangladesh concerning the timing of the first meeting. Meanwhile, we shall be circulating to interested parties within the next week or ten days an extensive report on the economy of Bangladesh. Moreover, we have in preparation a note on the current financial and economic position of the country, which we hope to circulate in September. In due course these will be followed by a recommendation with respect to the aid requirements of Bangladesh.

If, as I hope, the decision is taken to participate in the Aid Group I would be grateful to know the name of the official to whom we should address future correspondence on this subject.

Dear Madam Frime Minister:

I would like to thank you for your letter of July 15, 1974, which was delivered by Ambassador Kanakaratne. I appreciate very much your kind comments about the Bank staff's work in Sri Lanka's behalf. As you may know, I personally follow the affairs of Sri Lanka with particular interest.

I am very much aware of the impact on Sri Lanka of the unprecedented increases in the prices of essential imports and also of the important measures your Government has taken to combat their adverse effects. I am glad to learn that you are giving attention to the measures needed to improve development prospects in the longer run. In this connection, I quite agree that a sound program for expanding food production rates a very high priority and I share your view that adequate and timely supplies of fertilizer are essential to the success of such a program. It is indeed the fact that the progress of the agricultural sector lies at the heart of Sri Lanka's development prospects - through both substituting local production for imported foodstuffs and earning foreign exchange by exports - that led us in the past month to intensify our discussion of agricultural policy with your officials, a dialogue which I hope will before long have beneficial results.

Regarding the Bank's participation in financing the proposed urea fertilizer plant, the matter has been the subject of considerable discussion between your officials, the Asian Development Bank and our Bank. We have reviewed the feasibility study by the Japan Consulting Institute, which was made available to us in June 1974. Unfortunately, as you note, construction and operating costs, as well as fertilizer prices, have increased dramatically since the study was completed in January 1973. Thus, the data on which the study is based, particularly investment and operating costs and financing requirements, need thorough revision and the economic benefits of the project must be reassessed. I understand that the British firm, Scientific Designs, has been employed by the Asian Development Bank to revise the cost estimates of the project, and that it has been proposed that representatives of the Asian Development Bank, the World Bank and other prospective lenders meet with Government officials in Colombo around the middle of August to review various aspects of the proposed project, including the new cost estimates. I am pleased to inform you that the Bank will be represented at this meeting.

Once the economic visbility of the project is established, we will be willing to consider participating in the financing. I fully appreciate your desire that we move forward on the same schedule as the Asian Development Bank, which I understand would like to make a commitment by the end of this calendar year. I can assure you the Bank will proceed as expeditionally as possible. On the other hand, I understand from my staff that a number of questions remain, including those related to feedstock, project size and markets. In view of this, and because appraisal work in the field will not be completed until Fall at the earliest, it is most unlikely that I would be in a position to propose this project to the Executive Directors by the end of this calendar year.

As for the order of magnitude of possible financing by the Bank Group, I think we sust await the revised cost estimates and economic benefit calculations before discussing figures. However, given the severe constraint on IDA funds from which allocations will have to be nade to Sri Lanka, our participation will necessarily have to be modest. I wish to assure you nonetheless that, if the Bank Group does participate and additional financing is still required, we will make every effort to assist the Government end the other partners in this venture in finding other sources of funds to fill the remaining financing gap. Indeed, when your Ambassador called on our Senior Vice President on June 26 to discuss this subject, the latter specifically suggested that some of the oilsurplus countries, which were showing interest in investment in fertilizer capacity, ought to be approached and involved in the project in Sri Lanka. I hope that this matter is being pursued.

Mr. Meiner has seen your invitation to visit Sri Lanka. I know he plans to do so at the earliest opportunity.

Dear Mr. Deputy Chairman,

I an writing in response to your Government's Aide Messoire about Hangladesh's requirement for additional foreign assistance, and the requests you made in your covering letter dated July 16, 1974. Let me say immediately that we agree with your basic assessment of the situation, especially as it concerns the next few months. While there may be sense scope for easing the situation by cancelling expiring letters of eredit, through short-term assistance from commercial banking channels, and through other measures, it is apparent that, above and beyond what you can achieve through these means, Bangladesh still will need substantial additional each foreign exchange resources to meet bills for goods already ordered.

In your letter, you made two specific requests. First, you asked for speedy establishment of an Aid Group, and a first meeting as soon as possible. You have, since then, asked us to convene a meeting at the time of our Annual Heeting in Mashington in late September. Unfortunately, this is not feasible. Both immediately before and during the Annual Heeting our staff, and those attending the Annual Heeting, would aisply be unable to give adequate time and attention to an Aid Group meeting. In any case, an Aid Group meeting in late September would not help to raise the resources required to help Hangladesh over the next two or three months. As Mr. Diamond has already cabled to you, we propose to hold the first Aid Group meeting as soon as possible after the Annual Meeting. Incidentally, I am today informing the countries and institutions agreed upon between us, of the decision of Hangladesh to have an Aid Group and of its wish to have the World Bank chair it; I am stressing the urgency of such a Group to your country's development and urgently soliciting their interest in participating in it. I am giving a copy of this invitation to your Ambassador in Washington.

Your second request was to accelerate the processing, and to increase the amount, of our next program credit. As for timing, we will put the credit to our Board in Hovember, perhaps earlier. As for the amount, you have already been informed that we will increase the amount to USSSO million, and that we will consider a further increase, subject to the requirements of vital projects. Unfortunately, the evailability of His funds in the first half of this fiscal year procludes the possibility of our going beyond USSSO million at this time. If, in the second half of this fiscal year, the rest of the IDS funds become available, we shall be propared to consider an additional program credit. Whatever the size of the program credit, however, Hangladesh cannot possibly benefit from distancements from it in time to meet the problems of the next few months. Thus it would seem that neither of the two proposals you made, even if it investigate to pursue them, would really andust Hangladesh in its investigate.

Heaminite I understand that Hangladesh is seeking shortterm commercial accommodation. Here importantly, I understand that you expect to have negotiations with the Fund this month, and that, if agreement is reached, additional cash resources will be at Hangladesh's disposal. Obviously such an agreement is of key importance but the Fund resources are not likely to meet all of Hangladesh's immediate needs. I would like to propose a way in which we might try to help applement what Hangladesh is already doing.

I suggest that I invite representatives of a small group of countries to neet with me in Mashington in mid-August to consider ways to provide emergency each loans. I have in mind inviting representatives of Ganada, Germany, Iran, Iraq, Japan, Mussit, the United Singdom and the United States. I think you will agree that it would be unfortunate if in finding on eccape from the present crisis, Sangladezh trapped itself into the beginning of a long-term debt problem in the form of a large short-term debt burden which might have to be continuously rolled over. Consequently, I would propose to advise potential lenders that later on we would try to arrange some sort of refinancing facility through the Aid Group, if emitable terms cannot be provided from the outset.

I assume you will agree that it would be necessary, before I could arrange such a meeting or expect an appropriate response, for so to be able to assure those whom I invite on two points: first, that your Government was resolved to reach an understanding with the Fund and that the prospects for it were good and, second, that your Government would do its utset to maintain the imports bill at the femaible minimum and to pursue policies which will place the country on a sound path to recovery and future development. I would be grateful if you would convey to se by cable as soon as possible both your reactions to this proposal, and if they are favorable, your assurances on the matters covered in the preceding paragraph.

#### Dear Chuck:

Thank you for your letter of July 27. I very much agree with you that it would be desirable for countries and agencies interested in providing reconstruction development and assistance to Indochina to consult together at an early date. Fartly to explore the best means of organizing effective consultations, I have asked Bernie Bell, who assumed his new duties as Vice President for East Asia and Pacific Region only last month, to discuss this matter with the Asian Bank, Japan and interested governments in Europe; he is currently traveling, partly in connection with those discussions.

We have been thinking that there could be advantages in arranging a meeting of donors at the time of our Annual Meeting of Governors, when a number of the officials concerned may be visiting Washington. It is clear that several donors will insist on maintaining the informality and low profile of last October's meetings if they are to attend.

Our objective is to meet together with as many donors as possible with a view to maximizing development assistance for the countries of Indochina, and I believe you share this view. August is not an easy month for some governments, particularly those in Europe, to focus on a delicate problem such as aid to Indochina. Nevertheless, I do expect progress toward organizing an international meeting within the next few weeks and will be in touch with you again as soon as there are further developments to report.

Dear Mr. Secretary-General:

Thank you very much for your letter of July 25, calling to my attention the sentence in the draft report of the Technical Group on the Transfer of Real Resources which suggests that a fund might be established to provide quickdisbursing concessionary assistance to the poorest countries. The draft report is as suggested by the Chairman and will form the basis of discussion at the meeting on August 12-13. I am certain that it will not be the intention of the Technical Group to in any way suggest that the center of gravity for the emergency operation be shifted from UN Headquarters to any other UN agency.

As I understand it, the members of the Technical Group fully recognize the important role the UN Emergency Fund has to play. They are concerned, as am I, that the best efforts of the United Nations and its Agencies, regional organizations and bilateral contributors, may fall short of the requirements of the poorest countries. The study of the prospects of the developing countries, which we released recently, highlights the very large requirements for additional capital. In our estimate, the requirements of the low income countries for additional capital will rise from the approximately \$3-4 billion for the twoyear period 1974-1975 to approximately \$8 billion in 1980. Against this requirement we must consider that the present projections of Official Development Assistance from OECD countries show a continuing decline as a percentage of GNP.

I am certain that the Technical Group will take full account of your concerns and will wish to assure that no suggestion they make could be interpreted as being in competition with the UN emergency operation. I will instruct my representative to the meeting accordingly.

- All payments to the Association required under the Development Credit Agreements, at the date of this letter, had been made except payments amounting to the equivalent of \$169,720, as per the list attached.
- At June 30, 1974 all effective development credits arising on or before that date were recorded in the accounts. Credits approved but not yet effective at June 30, 1974 amounted to the equivalent of \$520,300,000.
- 3. All liabilities of the Association, of which we are aware, are included in the appropriate classifications in the financial statements at June 30, 1974, and we have no knowledge of any litigation, pending or threatened against the Association, or any other contingent liabilities, of any important consequence.
- 4. We consider the grants for agricultural research projects to be appropriately disclosed in IDA's financial statements. It is not considered necessary to report the disbursed amount of these grants as an expense in the financial statements of the Association.
- 5. The Association has not entered into any contracts or agreements not in the ordinary course of business, nor have any other matters come to our attention up to the present time, which would materially affect the financial statements for the year ended June 30, 1974. In addition, we know of no event since June 30, 1974 which although not affecting such financial statements has caused or is likely to cause any material change, adverse or otherwise, in the financial position or results of operations of the Association.

6. Effective July 1, 1974, the IMF adopted a new method of valuing currencies in terms of the special drawing right (SDR). The new method is based on a standard basket system of 16 currencies and will apply for a period of two years. At the end of June 1974, the US dollar as used in the Association's accounts was equal to 0.828948 SDR. As from July 1 the dollar's value in terms of the SDR will change daily.

The agreement reached by the Committee of Twenty, which resulted in the change in the IMF's procedures, has specific application to the IMF. The question of its applicability to the Association is presently being considered by the General Counsel and the Controller; for the time being the Association is continuing to base its maintenance of value procedures on the present par value of the US dollar.

7. To the best of our knowledge and belief, all accounting and financial records and related data of the Association, including all minutes through July 31, 1974, have been made available to you, and as far as we know, none of them were withheld from you.

Mr. Munir Benjenk, the Regional Vice President responsible for Bank operations in Turkey, is visiting Ankara in the near future, and I am asking him to convey this letter to you and be prepared to discuss the matter if you so wish.

To help prepare for these discussions, the aide-memoire attached summarizes the initial thoughts of my colleagues on the present state of the relationship between Turkey and the Bank. In the spirit of the Bank's function in assisting development in the world, the aidememoire is candid in pointing out the difficulties encountered in lending some \$690 million to Turkey from 1970 to date, and in suggesting some conclusions which our past experience may offer for the future. There are at least three major areas of emphasis: the focus of present and future Bank lending, the arrangements for coordinating the preparation and implementation of projects, and the staffing of agencies which carry out Bank financed projects.

On a wider plane, however, I would also be very interested in learning your views on the future course of furkey's development and the role you would wish the Bank to plan in that regard. A basic understanding on that role would greatly enhance and speed up the contributions we could then make on individual projects.

If you think this might be helpful, I would be quite prepared to send senior Bank staff to Turkey in advance of my own visit to discuss both the matters raised in the attached aide-memoire and the Government's views as to the desirable role of the Bank in the next few years so as to deepen the understanding we could reach during our forthcoming meeting.

Dear Antonio:

I am writing you to express the hope that the Inter-American Development Bank in 1975 may increase still further the strong support that it is giving to agricultural research activities in the Western Hemisphere. In the context of the world food problem, it seems to me that this assistance being given by IDB is highly appropriate. The strengthening of national research programs, on which you and IDB place a high value, is of course a matter of utmost importance, and the help which IDB can give to these programs will, I am convinced, bring about significant advances in agricultural productivity in the Western Hemisphere.

It would be equally important, I think, for IDB's support of the work of the international agricultural research centers in the Western Hemisphere to continue and increase. Such assistance would be particularly opportune just now. The proposed programs of all the centers composing the international agricultural research networks for 1975 at present exceed by about \$6 million the amount of funds which we expect to have available for these programs, not taking into account contributions which may be available from the Inter-American Bank. If the present pattern of grants from other denors were to continue, the brunt of this deficit would have to be borne by the Western Hemisphere centers, perhaps to the extent of \$4 million or more. Grants from IDB might therefore fill a crucial gap.

The World Bank Group, let me say, also is increasing its participation in the financing of international agricultural research. Our authorized contribution for 1975 is expected to be up to \$4.8 million. While these funds are meant to be at the disposal of the entire research network, we are, as you know, supporting the programs of the Western Hemisphere centers, and will continue to do so.

Dear Mr. Prime Minister,

Thank you very much for your letter of June 14, 1974, which reached me earlier this month through your Embassy at Washington.

I assure you, Mr. Prime Minister, that I fully share your concern about the problems created for Lesotho by the recent repatriation of large numbers of Basotho workers from South Africa. We agree that such a repatriation calls for the most urgent efforts to provide employment on an emergency basis. It was in full realization of the need for expeditious action that my staff had earlier recommended that your Government avail itself of the offer of the United Nations Development Programme to rapidly mount a mission for (a) identifying and preparing a program of small, labor-intensive public works that could be used for creating relief jobs urgently. and (b) reviewing the problem of unemployment in a longer-range perspective. As our staff was not immediately available we felt that staffing such a mission by ILO experts would be satisfactory. We note, however, that your Government would prefer a small, World Bankled mission to identify an action program rather than a more comprehensive ILO-led mission which would address itself to both the emergency and the longer-term and structural employment problems. In response to your request, we are now making preparations for a mission of about six experts, to be led by a member of our staff, to arrive in Lesotho on August 25, 1974. If this proposal is acceptable to you, we will communicate the composition and other details of the mission to your Government in the near future.

While assuring you of our fullest cooperation in meeting the present emergency confronting your country, I should make clear that my staff and I feel that we can best assist your country by helping in the preparation and financing of investment projects which are designed to solve the persistent problems of Lesotho by generating economic growth and increasing employment opportunities. An example of our efforts in this direction is the recent approval by the Executive Directors of a \$4.0 million IDA credit for an education project which aims at manpower training and development. We are also active in the preparation of a road project, in association with the U.K. Ministry of Overseas Development, which will use labor-intensive techniques for constructing and The Honorable Chief Leabua Jonathan

improving mountain roads. In addition, we have scheduled a mission for August 1974, from our Nairobi office, to help identify and prepare a livestock project which would raise rural incomes but would also assist in controlling soil erosion. We hope that these efforts will result in projects that would make a meaningful contribution to the long-range development of Lesotho.

MEMORANDUM FOR MR. SETHNESS

Subject: Financial Disclosures

This is in reply to your memorandum dated July 11, 1974 regarding your suggestion that we explore the idea of a formalized system of financial disclosure by senior officials of the Bank.

It may be that you are unaware of the fact that on June 28, 1974 I instituted a new and comprehensive procedure which provides (a) a detailed set of rules of conduct for Bank staff designed to avoid any conflicts of interest, and (b) a formal procedure whereby all staff in Level J and above must file annual reports of their holdings of certain types of securities and other interests. (Staff in Level J and above includes the entire professional staff of the Bank, not just the senior officials.) I have also established a special committee which will review these reports and will be responsible for the administration of these new rules. For your information, I am enclosing a copy of the new rules, together with a form of the financial disclosure statement.

I recognize, as you do, the need for the staff of the Bank to avoid any suggestion of conflict between their Bank duties and private interests. In this regard, I call to your attention the following excerpt from my memorandum dated June 28,1974 to the staff on the new rules of conduct:

> ". . . it has to be recognized that the Bank Group is exposed to continuous scrutiny, which is likely to increase as the range of its activities expands, on the part of its member governments and their legislatures, the press and the public. There is thus a need to avoid real or apparent conflicts between a staff member's private interests and his duties to the Bank Group and thereby any embarrassment either to the staff member or to the Bank Group, as well as to have a procedure for dealing with such conflicts, should they arise. The attached rules are designed to meet this need."

As you can see, we have taken particular care to provide specific rules covering a wide range of staff activities and to provide a fairly elaborate system of administrative review within the Bank. Indeed, the system we have established is, as far as I am aware, far more comprehensive than that of any other international institution.

I believe that our new system provides the Bank's management which represents the member governments with the assurances in this matter which they are entitled to have and I trust therefore that it meets your objectives.

Dear Mr. Deputy Chairman:

Thank you for your messages of July 6 concerning the establishment of a Consortium for Bangladesh and of July 9 about negotiations for the assumption by Bangladesh of certain external debts.

As for the former, I have received your request with pleasure. It has been a matter of mounting concern to us and to Bangladesh's many other friends, that there does not exist a formal organization to assist in mobilizing external resources for the development of Bangladesh. I am gratified you have taken the initiative. I want you to know at once that we will come back to you quickly with concrete proposals for the establishment of a Consortium, including its composition, organization and timing.

Concerning your second message, lat me say that persuading the country creditors to agree to offer terms involving a grant element of no less than 64 percent was not a small achievement. It required four wonths of discussion and persuasion and resulted in acceptance from some countries which have never before provided aid on such soft terms. Let me add that, after the meeting in London in early June, Mr. Emapp personally discussed the matter with your negotiator and it was agreed that the Bank would inform other creditors of the views of Bangladesh regarding the grant element. We did just that, but, as Mr. Emapp had anticipated, we received no favorable response from the country creditors. The fact is that they had been pushed just as far as possible and I am satisfied that any effort to push them further would be both inappropriate and fruitless.

As for the Bank's terms, I have to say that we have very little further room for maneuver. I would be prepared to take a final step to reach agreement with you by giving the proposed Bank loan a grace period of ten years, instead of five, out of a total 30-year duration. This will not make a significant difference in the grant element, but will afford you additional relief in the early years. This is as far as the Bank can possibly go and reflects our wish to do the utmost for Bangladesh. Dr. Nurul Islam

Dear Orville:

Thank you for your memorandum. My staff has just prepared a study of "Fertilizer Requirements of Developing Countries" which advocates a strategy of cooperative ventures, very similar to the one you have outlined in your memorandum.

While my associates see a potential for joint ventures between oil producers, other developing countries, and sources of technical know-how in certain areas such as fertilizers, they do not see much scope for attracting OPEC investment in food and agricultural production in developing countries. Our feeling is that the appropriate strategy in the heavily populated developing countries is to assist and upgrade the activities of the small farmers, as part of an overall program of rural development. There are, of course, places in Africa and Latin America where an economic case could be made for attracting large foreign corporations to develop new areas for food and agricultural production, but we do not think that this is politically feasible at this time. Nor do we think that it would be possible to attract Arab funds into this area.

Dear Dr. Candam:

You will recall that I wrote to you about a year ago suggesting that you might preside over the inter-governmental inter-agency group that would be formed to exercise general supervision over the program for the control of onchocerciasis in West Africa once the program got under way. You said that you would be ready to consider this when the time came.

As you know, WHO has ande good progress in launching the program, and an advance fund of \$7-1/2 million has been organized by the World Bank to cover commitments during the first year. A plan of operations was agreed by the seven African Governments at a meeting in Accra last Hovember, the Program Director has established his headquarters in Guagadougou, and aerial spraying operations are due to begin in Hovember 1974.

Last week the donor and participating governments and international agencies interested in the program met in Faris to consider the arrangements for the overall management of the campaign, and in line with proposals put forward by the inter-agency Steering Committee, the meeting agreed that a Joint Coordinating Committee (JCC) should be set up to keep the program under review and to approve annual budgets. This Committee would be an informal bedy consisting of representatives of donor and participating governments and international agencies, it would have an independent chairman of international stature and it would be assisted by a secretariat provided jointly by the WHO and the World Bank. It would determine its own rules of procedure and would normally meet once a year in one of the participating or donor countries.

The Ivory Coast Delegation at Paris suggested that the first meeting of the JCC might be held in Abidjan early in 1975, and this was agreed. The Paris meeting also discussed the Chairmanship of the JCC, and the Delegation of Upper Volta put forward your name as a person emimently qualified to provide the guidance and leadership required. This proposal was seconded by the US Delegation and unanimously approved, and the World Bank, as Chairman of the meeting and on behalf of the four sponsoring agencies, was asked to extend an invitation to you.

I very much hope that you will be able to take this task on. While it should not make too heavy a call on your time, it will require considerable skill and diplomacy to maintain the requisite degree of governmental supervision Dr. H. G. Candau

without interforing with the day-to-day management of the campaign and to deal with the difficult technical and political issues which are bound to arise from time to time in a complex operation of this kind. I can think of no one who could handle such matters with greater authority than yourself.

So far as the financing of the sampaign is concerned, we are confident that we shall be able to mobilize the external resources needed to cover the costs of the first six-year phase (1978-79) which are now estimated at around \$54 million. All the original donors have made it clear that they are ready in principle to support the program on a continuing basis, and from the indications which the World Bank has received we would expect upwards of three-quarters of the financing required for the first six years to be obtained from these donors, together with the European Development Fund and the African Development Bank. An amount of around \$10 million still remains to be found, and we are in touch with a number of possible additional donors, including several of the OPEC countries. It will be our aim to have the financing arrangements completed before the first meeting of the JCC early next year.

Before taking a final decision on the Chairmanship, you may want to know more about what the job will entail, and Dr. Bernard and Dr. Bellerive of WHO will be happy to discuss this further with you. If it would be useful, Mr. Peter Wright of our staff, who was in the Chair at the Faris meeting, could also call on you around the end of this month when he expects to be in the vicinity of Geneva on holiday.

I am sending copies of this letter to Dr. Mahler, Mr. Peterson and Dr. Boerma, who join me in hoping that you will find it possible to continue your association with the onchocerciasis program.

#### Excellency:

As you have already been informed by Mr. Goodman's cable of June 26, 1974, I have concluded that it would be advisable to postpone the meeting provisionally arranged for July 9 to consider your Government's request that an aid-group for Laos be formed. I realize that this decision will be a disappointment to you, but I am hopeful that during the next several months sufficient progress can be made on several matters discussed below to enable us and the Asian Development Bank to organize and co-sponsor a fruitful meeting towards the end of the year.

I am mindful of the urgent and substantial needs of your country for external assistance, but I believe that these needs are more likely to be met when potential aid-givers can be provided an opportunity to consider the aid requirements of the Kingdom of Laos as a whole.

Since the signing of the cease-fire protocol in February 1973, I have carefully observed the efforts that you, Mr. Prime Minister, have personally made to re-unite your country and establish peaceful conditions. These conditions, which are prerequisites for a broadly-based program of reconstruction and development that could be supported by all potential aid-givers, were substantially fulfilled with the formation of a Government of National Union last April. However, I consider that the countries concerned would not be ready to give significant support to an aid-group for Laos until your Government is in a position to present to them its proposals for reconstruction and development for the whole Kingdom, together with an assessment of these proposals by the international agencies. As I am sure you know, assistance by the Bank Group itself would presuppose that we had had the opportunity of assessing the nature, scale and priorities of assistance required by the country as a whole. I do not wish to suggest that a detailed Plan of Development need be drawn up before such a meeting of an aid-group could usefully be held; indeed I would expect an aid-group to consider how it can provide assistance to your Government for this purpose. As it is, however, the visits of staff of the Asian Development Bank and the World Bank have necessarily been confined so far to the area formerly controlled by the Vientiene-side. I would, therefore, hope that events in the course of the next few months would permit us, in collaboration with the Asian Development Bank, to make the type of assessment mentioned above.

In order to keep ourselves abreast of progress in these matters Mr. Jean Baneth, who visited Laos in May, plans to return to Vientiane in the second half of July for a brief visit. He will also discuss with officials of your Government the most appropriate timing for an economic mission to visit Laos and the scope and composition of the mission. I trust this visit will be convenient to your Government.

In the course of determining whether the proposed meeting should be held as provisionally planned in July we have remained in close touch with the Asian Development Bank. I should make clear that President Inoue would have been willing to proceed with the meeting as proposed. However, he has expressed his desire to work in full cooperation with us and has accepted our recommendation for postponement.
