Dear Sir,

As we discussed, please find the following information on the budget to produce a 52-minute video on "Culture and development", an adaptation of your slide presentation.

## A. MAIN VERSION

To produce a 52-minute video-adaptation of a main version (French or English), the following budget would be necessary: (Taping and editing format: Betacam SP)

	Taping of the narration (1\2 day):
\$ 650.	Camera crew-equipment
\$ 350.	Prompter
	Preparation for Editing:
\$ 500.	Laboratory-pictures processing-enlargements
\$1.200.	Video-taping of the pictures(one day)

\$4,500.	Off-line editing (3 days\1,500.per day)

\*Total excludes the eventual costs for the rights of the pictures selected. This would be negotiated picture by picture. As the video is an educational program, most of the rights, if not all of them, should be granted.

## Option 1:

Regarding the number of images taken in Cairo, a taping on this location could bring a great deal of animation. In this case, the pictures presented in the slide show would be used for advance-work so even the angles selected could be respected in the new taping. If I could organize this taping during my next trip to Europe scheduled in February\March, there would be no extra charge for the travel portion from USA to Europe. The additional budget for this taping on Cairo location would be:

#### \$ 2,500.

(integrating the costs of round-trip Paris to Cairo, 3 days stay and local camera crew rental).

# Option 2:

Additional footage could be negotiated to increase the motion in the video. Those could be negotiated for example with National tourism offices. Here again the selection of the footage will be based on some slides presented in the show (Examples: Washington DC mosque; Saudi Arabia: Airport, La Méque; India: Taj Mahal; Koweit: Water Towers..). 5 to 7 minutes of those kinds of footage could make a difference in the rhythm of the show and would improve its audiovisual quality. The additional budget for their negotiation and exploitation would represent an additional budget of:

#### \$ 3,000.

Those budgets concern the main version of the video, English or French.

# B. ADDITIONAL LANGUAGE VERSION

If produced simultaneously, the budget for an additional language version should be:

#### Option 1:

\$10.000 for a second original version
(Taping and editing of the narrator in the second language)

#### Option 2:

\$ 5.000 for an adaptation with voice-over. (Audio-recording and editing of the translation)

If the agreements were signed by February 15, 1993, both versions could be produced by May 31, 1993.

Looking forward to discussing this matter further with you.
