Dear Mr. Labidi:

I am writing to you about the program for the control of riverblindness (onchocerciasis) in the Volta river basin. You know, I think, about the establishment of an initial fund of \$7.5 million to cover the first year's commitments which is made up of contributions from six Governments and the World Bank. This is all grant money and available to finance procurement in any part of the world. The fund will be administered by the World Bank and will be used to finance the expenses incurred by the World Health Organization as executing agency for the program of vector control. The UNDP and FAO are also giving the program their full support.

We are now giving our attention to the organization of the external financing required for the remainder of the first six years of the program (1974-79), and we are planning to convene another meeting of donor and participating governments and international agencies in Paris on June 26-27. I very much hope that you will be able to send a representative to this meeting, as you did last year, and we shall be issuing formal invitations early in May. The purpose of the meeting will be to review progress to date, to discuss the inter-governmental machinery for the management of the campaign and to review the costs and financing for the first six-year phase on the basis of revised cost estimates which the WHO is currently preparing (to take account of inflation).

The total cost for the first six years is now likely to work out at around \$50 million, including allowances for price escalation and contingencies, and we would hope to obtain about three-quarters of this amount from the initial contributors, all of whom have indicated an interest in continuing to support the program. However, we will need additional donors to provide the remaining \$10-15 million, and I wonder whether you might be able to consider recommending to your Board a small grant of up to, say, \$2 million from the African Development Fund. The program has the full

backing of the seven African Governments directly involved, and I am sure that participation by the Fund in this important regional project would be widely welcomed.

Mr. Peter Wright of our West Africa Regional Office has already discussed the program with Mr. Sakkaf and he will be happy to provide any further information your staff may require.

I appreciate the frank and cordial way in which you raise these questions and will reply in the same spirit. Although you do not mention countries by name, inquiry here in the Bank suggests that operations dealing with Iran and Saudi Arabia on the one hand, and with Kenya on the other, may recently have prompted some concern. I believe you know that I have myself given special attention to the Bank's relations with the first two of these countries, and it is possible that quite unintentionally the follow-up to these activities has given the appearance of not keeping Unesco in the picture. I can assure you that neither in the countries mentioned nor in any country would this be the Bank's intention. Beneath these specific incidents, I understand, there has been some continuing difference of opinion regarding the respective responsibilities of our two agencies for certain types of service to our member countries. Wisely, I think, our staff members have sought to suppress these differences and to emphasize the positive aspects of our cooperation. You wrote to me on March 8, 1974, calling attention to the need for

You wrote to me on March 8, 1974, calling attention to the need for a new effort to make available to developing countries inexpensive, reliable, and safe technologies, which they are capable of using, to supply water and dispose of waste, especially in rural areas. You proposed to sponsor or co-sponsor a conference of agencies and potential donors to review the problem and make proposals for operational and financial arrangements. As you know, by the time your letter reached the Bank, our staffs had agreed to attend an informal meeting in Montreal sponsored jointly by the UNDP and the International Development Research Centre of Canada to discuss all these matters. That meeting was held on April 9 and 10 and, judging from the report I have received from Michael Hoffman, it was a very useful exercise. I hope Dr. Dietrich will have given you an equally positive account.

Let me say at once that I agree fully with your judgment as to the need for new efforts to deal with the problems of technologies in water supply and waste disposal for rural areas that would meet the criteria stated in your letter. I also believe that the time is ripe for such a new effort on the part of the UN system and others whom we may be able to persuade to become associated with us. It seems to me, for instance, that this is clearly a subsector that ought to be made the object of substantial support by the UNDP under its global and regional programs. WHO has been able to provide much valuable assistance but not on the scale required, especially in the area you describe as the "transfer of knowledge and methods already available." Our own water supply projects have been almost entirely in metropolitan or other relatively advanced urban areas. In fact, we are just now engaged in an internal review of various means through which we could develop projects for rural areas. It is already clear that if we are to do snything significant along those lines. we will need to know a lot more than we now do about precisely the matters that particularly concern you.

I should like, therefore, to endorse your initiative and to say that the Bank wants to be an active partner in the work that lies ahead. The

Montreal group, I understand, felt that before convening a formal meeting, we would be wise to do a substantial amount of preparatory work. All our experience indicates that when approaching potential sources of financial support, it is essential for sponsors to have concrete, operationally sound, and thoroughly justified proposals that fill demonstrable gaps in existing programs or machinery. The international scene is littered with unfunded proposals to carry out general programs that are prima facie desirable. But you and we have demonstrated, in the case of the onchocerciasis campaign, that when a really good product is put before donors they will support it, even when aid funds in general are tight.

I believe that the steps proposed by the Montreal group to prepare a concrete program to deal with the problems of technology for water and waste disposal in rural areas are well conceived and that we would be wise to postpone the convening of a formal international meeting until we can see fairly clearly that we are going to have specific concrete proposals and what the nature of those proposals is likely to be. I would guess this might mean a meeting closer to mid-spring 1975 than to the end of 1974, but I think the slight delay is well worthwhile as I believe it will enable us to lay a solid foundation. This would also give us time to make some private soundings among the principal potential donors as to what sort of response we might expect. Again drawing on our experience, it is always better before calling governments together in the hope of persuading them to make financial commitments to have a pretty good idea of what your main potential supporters are prepared to do.

I hope that you will share my view as to how we should proceed. For my part, I should like to make the venture on which we are about to embark another demonstration that the agencies of the UN system, when the will to do so exists, can collaborate in mounting effective campaigns against some of the major scourges of mankind.

I should explain that the manner in which PL 480 statistics have been handled has varied over time. In the early days of the Consortium, a distinction was made between development assistance and what was regarded as relief or humanitarian assistance. As PL 480 was considered to fall into the latter category, statistics were not included in our reports. Subsequently, there was a move towards analyzing total assistance to India and in discussions with the USAID we agreed to include PL 480 Title I as part of the total volume of assistance from the US. However, PL 480 Title II continued to be left out, largely because it was regarded as part of private voluntary assistance for which statistics were not included in any official returns. An additional factor was that not only for the US but also for other Consortium sources. statistics were difficult to obtain as this form of assistance was not channelled through the Ministry of Finance, but instead was negotiated through a variety of private agencies, as well as in some cases directly with Central and State government departments. Donor governments also faced difficulties in identifying and defining for statistical purposes transfers through private groups. In preparing the recent Bank Staff Working Paper, we did in fact re-examine the possibility of including for the US data on PL 480 Title II, but it did not prove possible to get the statistics together in time.

In the first place, I sm happy to have the impressive statement in your letter that your Government regards rehabilitation in the droughtaffected areas as its first and highest priority. I want to assure you that we so regard it and that we plan to move quickly toward the formulation of a program on which you and we agree which will be genuinely responsive to rehabilitation needs in the area and then toward approval by our Board of an IDA credit for this purpose. In the second place, the most important consideration in our minds is that the project or program which we finance should effectively meet the need that the small farmers and herders of the drought-affected areas be put in a position to resume their agricultural production activities and to achieve greater productivity and higher incomes on a long-term sustained basis. If your Government is, for these purposes, prepared to resettle displaced small farmers in the Tigre and Wollo areas and in other nearby areas and, to the extent necessary, to alter the existing land ownership pattern and tenency relationships, we are entirely prepared to support this affort. With regard to the recent mission led by Mr. Krishns, the members of the mission and others of the Bank staff and management are now attempting to formulate an effective program which we plan to discuss with you in concrete and specific terms at a very early date. We hope that out of this work and our joint consideration of the results there will emerge a course of action which will be of real value in the immediate task of drought area rehabilitation, while further contributing to the long-term improvement of the economic and social well-being of the mass of the rural population of Ethiopia. Dear Mr. Minister:

I wish to thank you for kindly receiving my Special Representative, Mr. Adalbert Krieger Vasena, and our staff economist, Mr. Roberto González Cofiño, during their recent visit to Caracas. I also wish to express my appreciation for your letter of March 27.

The President, Dr. Carlos Andrés Pérez, your Government and you, Mr. Minister, should be congratulated for Venezuela's recent decision to make available at least 1% of GDP as financial assistance to other developing countries. I hope that this generous attitude of Venezuela will be shared in the near future by other countries -- including both the industrialized nations and those countries which have been substantially strengthened by the recent international economic evolution. We in the Bank are very pleased to see Venezuela playing a leadership role in what we hope will be a new and more fruitful stage in international development assistance.

In this new stage, the World Bank Group hopes to be able to establish a close partnership with your Government in matters of mutual interest, including those mentioned in your March 27 letter. I have especially noted the interest of your Government in receiving, in general, the technical support of the Bank. I can assure you that we will be willing to offer a response as positive and flexible as possible to the requests we may receive from your Government. Likewise, we will consider with deep interest the possibility of participating in investment projects where the Government may wish to receive the financial and technical support of the Bank.

In addition, as Mr. Krieger already explained to you, the Bank presently offers its member countries several possibilities of investing their excess foreign exchange resources. They offer an attractive yield to the investing country while also serving as an easy and expeditious way of transferring resources to developing countries. These possibilities include, among others, the purchase of Bank bonds and several co-financing schemes, under which the Bank and a country --or a group of countries--offer joint or parallell financing for investment projects under non-concessional conditions. These co-financing schemes may also be used to transfer resources on concessional terms where the World Bank Group and the co-financing country deem it appropriate. A country like

Venezuela could also transfer concessional resources by directly participating in IDA. Under most of these schemes the Bank performs all of the administrative and technical work required to identify, appraise, negotiate and supervise the investment projects.

In these activities, and in other similar to them, we will maintain a flexible position, with a view to collaborate with your Government in defining and implementing appropriate, mutually acceptable formulas. For this purpose we hope to continue in the very near future the dialogue started two weeks ago.

The problem of commodity prices is very much at the center of attention as we seek to define the prospects for the developing countries in the context of high and continued world-wide inflation, and its impact on the terms of trade of developing countries. If the current level of commodity prices were to decline over the next several years it would intensify the balance of payments difficulties the developing countries face at present. The proposed indexation of commodity prices to maintain the purchasing power of developing countries' foreign exchange earnings is a new and yet unexplored approach to the problem which requires careful consideration. The proposed method would substitute automatic price adjustments for presently operating market mechanisms. The draft study outline quite correctly points out that any such approach depends on agreement to control supply and that such agreements have been difficult to achieve in the past. Indexation also would have consequences for the allocation of development resources in the world economy. Because of the importance of the problem, and the uncertainty of any solutions, I welcome your offer of close consultations in the preparation of the study. As you know, the Bank's earlier analysis of factors which influence the export earnings potential of developing countries, transmitted to your office on February 28, 1973, stressed the importance of commodity agreements, free access to markets and the need for export diversification. The costs and benefits of indexation of commodity prices need to be measured against these approaches. Such an analysis can best be done by a careful analysis of commodity markets and of the benefits and costs of expanded primary commodity production.

I have instructed Mr. Wouter Tims, Director of the Economic Analysis and Projections Department, to prepare a note on the question of indexation of commodity prices, which we expect to send to you by mid-April. I would hope that this document, plus the material your staff is preparing, could be the basis for staff discussions by the end of April 1974. Based on these discussions we can then decide how we might contribute further to a thorough analysis of the proposal.

I well remember the good meeting we had some time back and appreciate the lively interest Indian journalists have continued to take in the activities of the World Bank. The press over the years has been good to the World Bank and to me, personally. I admire the high standards of professionalism maintained by Indian journalists and their keen sense of competition. I would be very distressed to think that I, or this institution, would be thought designedly to leak confidential documents through journalists, especially when improper use of these documents might be harmful to the development effort of India. Such use does not conform to the high standards of responsibility for which the Indian press is traditionally respected; it certainly does not conform in any way with the objectives of the World Bank. I do feel, however, that there is justice in your complaint that some journalists have received preferred treatment recently, though without any official Bank authorisation. (I would point out, however, that the New York Times report which you mention specifically states that it was not derived from a Bank source). I have therefore asked Mr. Merriam, the Director of Information and Public Affairs, to look into the matter of improving communications between us, and I look forward as a result to a better flow of information and discussion between us in future. Marcos President of the Republic of the Philippines Malacanana Manila, Philippines Dear President Marcos, Thank you for your long and interesting letter of March 6, 1974. All of us here are very concerned about the problems which the energy crisis has created for developing countries. Indeed, as Mr. Mapa may already have told you, the Bank staff has embarked on an intensive study of how the crisis affects our borrowing members and what we can do to help. In this context, I fully support your decision to reexamine your public investment program and I have asked Mr. Goodman and his colleagues to do everything they can to ensure that our future lending activities are designed to fit in with your revised program. Fortunately, the dialogue between your representatives and our staff on these matters can start immediately, both in Washington and in Manila. Over the next three months, teams are scheduled to come to Washington from Manila to negotiate six loans (for Penaranda-Aurora Irrigation, Rural Credit III, DBP Industry, Population, Power and DBP Shipping). The Penaranda-Aurora team, including Administrator Juinio, is here now and our future role in financing irrigation projects is being discussed in addition to the proposed project. Future lending possibilities will also be discussed with the teams coming for the other five projects. Our annual economic mission to the Philippines, led by Mr. Russell Cheetham, leaves for Manila this week. This mission will work jointly with your people to assess the impact of the energy crisis on the Philippines balance of payments in the years ahead, discuss possible changes in the public investment program and explore how our lending might be adapted to meet the needs. We are particularly interested in how the new situation affects investments in the transport sector and the mission will be paying special attention to that. After the mission returns to Washington, a special paper will be prepared which will assess the future growth of the economy in the light of the external financial

position and will provide recommendations on the type and level of lending which we might contemplate. I propose to review this paper myself around the middle of the year.

I was most interested in your account of the progress of your agrarian reform program. Mr. Knapp had already told me, after his visit in November, how impressed he had been by the way you were tackling these problems. The Philippines now seems well on the way to achieving the kind of success previously seen in Japan and Taiwan. As you know, I believe that nothing is of higher priority than bringing increased incomes to the poorer members of the rural community. We therefore look forward to continuing our support of your program. In this fiscal year, both our Penaranda-Aurora Trigation project and our Third Hural Credit project will provide such support.

May I now turn to your comments on the Philippine power program and our role in financing it. I am in full agreement with you on the need to diversify energy sources as a result of the rise in fuel oil prices. I also support your efforts to seek bilateral sources of finance and suppliers credits to supplement the funds which can be made available for this very substantial program from ADB and ourselves. As you know, we have been associated with the Mational Power Corporation since we made our first loan in 1957. As a major creditor, we are of course interested in the terms and conditions on which such bilateral finance is raised. During the forthcoming negotiations for the sixth power project I hope that your representatives and our staff can have a detailed discussion of the future power program and how it might be financed. Assuming broad agreement is reached, I am confident that consultation with us on the terms and conditions of future MPC borrowing from bilateral sources or suppliers credits should create no problem for you.

You mention in your letter that during appraisal of the sixth power project, we indicated that the size of our loan would be about \$50 million. I have consulted Mr. Goodman on this and he tells me that he and Secretary Virata agreed at the time of our annual meeting in Mairobi that our financing under the sixth project should be confined to the generating facilities at Pantabangan and the next slice of NPC's transmission program. Our present estimates suggest that the foreign exchange cost of these items will total about \$60 million and I therefore foresee a loan of about this amount. You also suggest that our administrative procedures on employing consultants and procurement have constrained your decision making and implementation of the accelerated power program. I have asked my associates here about this and they are not sure what is being referred to. We do in fact have some flexibility on these matters. For example, in a letter received here on March oth, MPC asked us (a) to approve the retention of ECI-EDCOP as consultants for the implementation of the Power Phase of the Upper Pampanga River Project, (b) to agree to a negotiated

Dear Dr. Hurtado:

I have asked the bearer of this letter, Dr. Adalbert Krieger, as my special representative, to discuss with you various alternatives for future cooperation between the World Bank Group and the Government of Venezuela.

As you are certainly aware, our institution is studying the effects of the recent increases in the prices of oil and other products on the economies of the developing countries. Our findings, although still at a very preliminary stage, are reported in the document that Dr. Krieger will be handing to you. This document estimates the additional foreign capital requirements of the developing countries resulting from these price increases, and puts forward some ideas for possible solutions.

We know that your Government is concerned with these matters, in fact this concern was expressed by the President of the Republic, Dr. Carlos Andrés Perez, in his inaugural address. I should greatly appreciate it if in your talks with Dr. Krieger you could discuss concrete ways in which your Government and the World Bank Group could make a joint effort to provide substantial assistance to the developing countries.

If you consider it appropriate, I should also appreciate your discussing with Dr. Krieger the proposal recently announced by OPEC, to set up a Development Fund.

I should also like to take this opportunity to state once again that it is our sincere wish that the World Bank Group will continue to cooperate with your country in its development efforts.

The agreement we have reached with Iran is certainly an encouraging beginning in our efforts to stimulate the oil producing countries to help developing countries to adjust to the increased costs of energy and of other imports. We hope that other countries will take similar action either jointly or singly, and we have informed them that the World Bank stands ready to help them in every way in such an endeavor. Certainly increased production of fertilizer is one of the key areas on which any available aid funds should be concentrated, particularly since the increased cost of imported fertilizer is hurting the developing countries almost as severely as the increased costs of fuel. The proposed interest rate of the proposed Iranian contribution to a Special Development Fund, would not be 7% or 8% as reported in the New York Times, but a much more concessionary rate. The exact rate has not yet been determined but I would expect it to be somewhat above the IDA terms although nowhere near conventional lending rates such as those mentioned in the Times article. Throughout my travels in the Middle East I was frequently asked about the fate of the IDA bill in the U.S. Congress. The oil producing countries, who now seem determined to make a considerable effort to help developing countries, are also quite anxious that their efforts should be additional to the expected capital flows from industrialized countries and not in substitution for them. All this enabled me to get a very clear impression of the great potential of your country, as well as some of its problems. I would like to thank you especially for your gracious hospitality at the dinner you gave for us all at the Gateway Hotel on February 11. The beautiful Sepik mask which you kindly presented to me on behalf of your Covernment will be displayed here at the Bank as a symbol of your new nation.

I have been informed that following your letter, your Government has taken measures aimed at reducing the distortions which recently affected the livestock sector, and that officials of your Government have maintained talks with Bank staff, arriving at an understanding on the issues mentioned in your letter. As a result, we expect to invite shortly representatives of your Government to negotiate the Fourth Livestock Project.

Before concluding, I would like to indicate to you that I have been much impressed with the success your Government has had in recent months in respect of its fiscal, monetary and incomes policies. I am looking forward to a continuation of these successful policies in the current year and to further cooperation with you in the important development task that lies shead in Paraguay.

I make use of this opportunity to express my appreciation to you.

I have the pleasure of addressing to you, and through you to the members of the Board, regarding the following:

My Government had the satisfaction of receiving the mission of the International Bank for Reconstruction and Development headed by Mr. Gunter K. Wiese, Director, LAG II, which included Messrs. Alberto Pavilla, Division Chief, and Jorge Hay, economist, whose discussions with the Economic Council were very cordial.

During the above discussions, Mr. Wiese stated that to contime processing the Fourth Livestock Project it was assential that the Government of Paraguay abolish the quota system for the slaughtering season, with respect to the number of head of cattle for export (industrialization).

In line with this recommendation, Mr. Wiese suggested that the quota system be replaced by a temporary and flexible tax on beef exports. My Government considers that the quota system is indispensable to satisfy the requirements of domestic consumption and protect against depletion of the herds, taking into account the necessities of the meat-producing industry, but within reasonable limits.

However, my Government assumes the obligation to the study, in the future, of a system which would be in line with the above recommendation.

Considering the points discussed herein, I wish to request, in a very special way, the approval of the Fourth Livestock Project, for US\$12.5 million, since this financing will contribute to strengthen the infrastructure of our livestock which has the important role of increasing boof exports and strengthening the balance of payments.

Thanking you for your kind cooperation, I make use of this opportunity to express my appreciation to you.
