## GLOBAL CONSULTATIONS

The World Bank Group (WBG) Gender Strategy is the culmination of two years of intensive internal and external engagement, starting with the yearlong [Accelerate Equality](#) campaign, followed by a year of external informal discussions and formal consultations. These included in-person consultations in 28 countries and engagement with representatives of over 600 entities from more than 110 countries.

External inputs were received from civil society organizations (CSOs), government representatives, parliamentarians, academia, private sector, philanthropies, feminist organizations, indigenous groups, UN agencies, multilateral development banks (MDBs), and other development partners. Thousands of stakeholders with diverse expertise were engaged through in-person meetings, virtual dialogues, an online survey, written inputs, and participation in global forums. These included the Women Deliver conference (WD2023) in Kigali, Women Political Leaders (WPL) summit in Brussels, the 21st meeting of the Organization for Economic Cooperation and Development – Development Assistance Committee on Gender Equality (OECD DAC GENDERNET) in Paris, the 67th session of the Commission on the Status of Women (CSW2023) in New York, the WBG and International Monetary Fund (IMF) spring meetings, in Washington DC, and annual meetings in Marrakesh.
