Dear Bill:

Thank you for passing on the concerns of your constituents on Bank lending to Chile. There has been a great deal of misunderstanding on this matter, and several points need to be understood.

First, the loans approved this week for small and medium-sized farmers and for the national electric company, will be of direct benefit to the Chilean people. The agricultural project will benefit 9,000 small and medium-sized farmers as well as currently unemployed rural laborers and their families (altogether some 54,000 people). The power project will lay the groundwork for extended rural electrification, and sustain a better livelihood for thousands more. From an economic point of view these projects are very promising: the rate of raturn on the agricultural loan, for example, is expected to be 27%. As you know, the Sank will carefully monitor these projects to insure that all its funds are used in accordance with Bank specifications. There was overwhelming . support for these loans from the 128 member governments represented on the Bank's Board. The developing countries, without exception, and regardless of the status of their relations with the present government of Chile, supported them.

Second, the economy of Chile, having gone through a very difficult period, is now showing improvement. In considering the loans, it was accepted by the Board that Chile is creditworthy by the Bank's standards. The country has repaid \$800 million of its foreign debt this year, has managed to avoid debt rescheduling, and has brought inflation down sharply in 1976. Also noteworthy is the evidence of declining unemployment. In the second quarter of 1976 unemployment in the greater Santiago area was as high as 192. The latest survey available shows an -- albeit preliminary -- figure of 132. Economic performance is certainly good enough to merit consideration of long-term loans for development by this institution.

Third, no member government, in considering these loans to Chile, took the position that the Bank should seek to alter the provisions of its charter requiring that loans must be considered solely on economic grounds. While many Board members have expressed their own, and their government's, concern

for human rights, there has been general agreement that as a subject for discussion and action this issue belongs in some other international forum, leaving to the Bank the work of long-term development. As you well know from your long service on the Foreign Operations Subcommittee, we are striving to make the Bank increasingly effective in development lending. That is our role. The Bank has been effective in helping the people of the countries it serves. It would not be effective as a political instrument. I think our Board is right in its insistence on maintaining the scope and improving the effectiveness of the Bank's service to developing countries.

As you know Bill, I very much appreciate your interest in the Bank, and particularly in insuring that it is both effective and accountable. I am glad of the chance to respond to you on this difficult, indeed, agonizing, and much misunderstood, issue. I hope you will let me know of any further questions you may have.

FOLLOWING IS TEXT OF MESSAGE TO BE DELIVERED TO MR. WILLY BRANDT FROM MCNAMARA. BEGIN TEXT. I HAVE BEEN INCREASINGLY CONCERNED WITH THE CURRENT DEADLOCK IN THE DISCUSSIONS BETWEEN THE DEVELOPING WORLD AND THE INDUSTRIALIZED COUNTRIES. I RECALL OUR CONVERSATIONS ABOUT THIS IN THE PAST, AND REMEMBER YOUR SINCERE CONCERN. THEREFORE IN CONSIDERING HOW TO BREAK THIS DEADLOCK I AM ANXIOUS TO MAKE A REFERENCE TO YOU IN A SPEECH THAT I PROPOSE TO MAKE IN BOSTON ON JANUARY FOURTEEN. THE RELEVANT PART OF THE TEXT IS QUOTED BELOW.

I am pleased to see from your November 24 letter the initiative you are taking with regard to the malnutrition problem, an issue in which the Bank itself is becoming increasingly concerned. We share your view that explicit nutrition policies are needed to bring about necessary improvement, and our own activities in the nutrition field are directed toward that end.

In this connection, the Bank would be pleased to participate in your upcoming International Study Symposium on "Policy Making and Flanning to Reduce Malnutrition". We would make appropriate staff available and finance their involvement. We would also be happy, in response to your request, to assist in the identification of other participants, particularly those from countries in which we are working with governments on nutrition projects. To the extent feasible, we also will try to meat your request that we contribute to the documentation of the case studies on which the symposium will focus. Copies of relevant published Bank materials will be made available in quantities needed. (In this regard, you may find of interest the attached report, "Malnutrition and Poverty" by Shlomo Reutlinger and Marcelo Selowsky of the Bank staff, which was released in late November.)

Although we would like to assist in these and other appropriate ways, we prefer not to be formally designated as co-sponsor. As you can imagine, the demands on the Bank for co-sponsorship of meetings far exceed our capacity to respond. Accordingly, we now only sponsor those meetings the Bank has initiated or in which the Bank plays a major substantive role.

Thank you, Warren, for sending the attached note and for your action in clearing up any confusion between "targets" and "best estimates."

I was disturbed, however, to read in the minutes of the meeting a reference to "pressures to produce projects." I cannot state too strongly that there should be no "pressures to produce projects" other than in conformity with accepted Bank standards. We should make this point clear to all Bank staff members.

There is, of course, for each Project Division and Department an operating plan prepared by that Division to carry out its responsibilities (and in the aggregate, the responsibilities of the Bank Group) to help meet the needs of the developing countries. The appropriate resources (staff personnel, administrative budgets, etc.) have been provided to carry out the operating plans. And it is the responsibility of the managers to either meet the plans or to propose changes in them. But under no circumstances will we permit achievement of the plan by violation of the quality of the standards on which the plan was premised.

I would like you to get together with Jim Kearns and organize a session with the Regional Vice Presidents so that we can dig into the question of any real or perceived "pressures to produce projects."



Dear Dr. Mahler:

Your letter of October 6, concerning the Special Programme for Research and Training in Tropical Diseases, arrived while I was in Manila for the World Bank's Annual Meeting. I left for a visit to a number of Asian countries soon after my return to Washington -just after we met at the ACC. Thus it is only now I am able to reply to you.

You asked, in behalf of UNDP as well as WHO, whether the World Bank would be willing to join the two organizations in co-sponsoring the Special Programme, and whether it would agree to serve as fiscal agent for the proposed Tropical Diseases Fund. I am pleased to say that I am prepared in principle to propose to the Bank's Executive Directors that the Bank agree to play these roles.

I say "in principle" for two reasons.

The first is that I would wish to be in a position to submit to the Executive Directors a more precise description of the financial implications of the Programme than seems possible at the moment. I assume that the financial projections will be refined at the meeting of potential donors which you are convening on December 8.

The second reason relates to the proposed task force and network approach of the Programme. There is a serious question in my mind whether this approach, which contemplates carrying out research and training for all six diseases in a large number of individual centers which vary considerably in their present quality and are widespread geographically, can be expected to provide the critical mass and to create and maintain the momentum necessary to produce optimum and timely results. Moreover, these characteristics, plus those inherent in the complex nature and scope of the Programme, will inevitably

confront the executing agency with a coordinating and managerial task of extraordinary magnitude. In the circumstances, and particularly because the proposed approach is experimental, in the sense that it has not been tried before on the scale contemplated, I would like to suggest that it would be prudent to make provision for approaching research and training activity for at least one of the diseases, in some different, proven manner. This might be, for example, to confide the attack on the particular disease to a single established (or even a new) institution with appropriate outreach activites. I do not believe that such a modification of the plan would or should delay the initiation of the general Programme, and I recommend it only because I am anxious that the Programme be a success. I am asking Dr. James Lee, the Bank's Environmental and Health Adviser, who will represent the Bank at the December 8 meeting, to raise this question with you and the UNDP.

As you know, the Bank staff who have been working closely with staff of WHO and UNDP in the preliminary planning for the Programme have been particularly concerned to ensure that the organizational and managerial arrangements proposed are sound and appropriate. I am glad to learn from them that they are satisfied on this point, and I very much welcome the willingness of WHO to serve as the executing agency. I am also gratified that, on the basis of experience in the riverblindness program, you and Mr. Morse feel that it would be helpful to have the Bank serve as fiscal agent. I am told that this was also the unanimous recommendation of the Working Group which met to consider the organization and financing of the Programme last July.

As to the possibility, which you also raise in your letter, of a financial contribution from the Bank, I cannot now make any commitment in that respect, and I understand that a postponement of this question will not have any negative consequences for the launching of the Programme.

I extend my good wishes for a useful meeting with potential donors next month. I would hope that the Tropical Disease Programme proves as successful, in its way, as MHO's smallpox eradication campaign, and I extend my warm congratulations to WHO as recipient of the Special Albert Lasker Public Health Service Award for its achievement in that respect.

Dear Mr. Deputy Prime Minister:

On my return to Washington this week, I have perused with considerable interest your letter of October 21 to me, which your associates handed to Messrs. Davar and Pollan during their visit to Ankara last month. I was very pleased to learn of your Government's proposals for further strengthening the close cooperation that already exists between Turkey and the Bank and for enhancing the contribution which the Bank can make to the success of your Government's economic development goals for the 1977-84 period. Messrs. Davar and Pollan have also conveyed to me, the gist of your discussions with them. I am appreciative of the valuable time you spent with them in these discussions.

It has been a matter of great satisfaction to me that in our last fiscal year, the Bank lending to Turkey reached a record level of \$212 million. I am hopeful that in the current year, we may be in a position to assist with about \$250 million, including financing for the Karakaya project. In principle, I would also like to envisage continuation of substantial lending for meaningful priority projects which would meet your Government's medium- and long-term development objectives of increasing the income levels as well as the quality of life of your rural and urban poor, generating increased employment opportunity and increasing foreign exchange earnings or savings to improve Turkey's balance of payments. Clearly, Turkey also has other development objectives. Undoubtedly, it will seek to attain them, through other projects financed either from its own resources or sources other than the Bank. However, in view of the substantial development potential that Turkey has and the magnitude of investments that your Government envisages to tap this potential, critical investment and policy choices will need to be made and sound economic management and fiscal policies adopted to ensure success of this huge effort. These matters are, I assume, being addressed to by your Government's economic and planning experts in the context of the exercise of drafting the fourth five-year development plan, that is in progress.

- (b) A review of financial and human resources, realistically needed for the successful achievement of various investments being proposed under the plan; adjustments may thereafter need to be made by the Government as regards the extent of the investments planned, in order to match desired development objectives with what can realistically be expected to be available;
- (c) A review of how and with what economic management and fiscal policies, can the required levels of domestic and foreign exchange resources be mobilized in time, to ensure a viable implementation of the next development plan; and
- (d) What role can the Bank play, given the choice of development projects which it would like to support, to contribute to the success of Turkey's next development plan.

As you may be aware, the Bank has been doing continuous economic and sector review work in Turkey. This would enable us to have an in-depth review of the draft development plan, when it becomes available. I can however very well appreciate your point that it would be more advantageous to your Government to hold a full-range discussion with the Bank on areas summarized above, before the draft plan is actually completed. Recognizing this, I am prepared to respond positively to your suggestion for high-level discussions and review between Turkey and the Bank. I also hope that this review would provide a basis for a continuing high-level dialogue in future, on policy matters germane to ensuring the success of your Government's economic development efforts.

I am confident that during the proposed high-level review, your Government will wish to focus not merely on obtaining new sources of fortign borrowings - including raising of loans and bonds in world capital markets but equally on the generation of sufficient domestic resources through methods that might promote equitable income distribution and a non-inflationary impact. I was therefore quite encouraged to learn from Messrs. Davar and Pollan, that to support an investment program of the magnitude that your Government envisages, it would be willing to consider arranging domestic resource mobilization through methods such as increased tax revenues, and payment of realistic prices by consumers for goods and services provided by

State Economic Enterprises (SEEs) - to enable these SEEs and the public sector in general to generate incomes sufficient to cover their full costs and contribute significantly to the financing required for their future expansion and modernization programs. At the same time, in order to ensure the successful achievement of your Government's development goals, it is equally important that ways and means, including legislation if necessary, be considered to foster growth of efficient institutions and administrative practices, as well as to attract and retain more efficient supervisory and managerial staff than what the civil service and the SEEs already have.

You will appreciate, Mr. Deputy Prime Minister, that for the highlevel discussions on the lines that you and I envisage to be successful, considerable and careful preparation work will need to be done on both sides. It will be particularly necessary to coordinate and ensure the participation of all relevant ministries and agencies, including the Finance Ministry and the State Planning Organization, in the preparation work as well as the review itself.

If such an approach was agreeable to your Government, it would help preparations on the side of the Bank if we could receive at your earliest convenience the guidelines issued by the Government for the preparation of the fourth Five-Year Development Plan which would, of course, be treated in confidence. It would also be helpful to receive a proposed detailed agenda for the high-level review you have proposed, taking into account the policy and sectoral issues mentioned above and others which may have to be discussed and clarified in order to achieve our common objective of maximizing the effectiveness and scope of the Bank's financial assistance to Turkey. Soon after the receipt of these documents, which would enable us to carry the necessary preparations on our side, I would be prepared to arrange for some of my senior staff to visit Turkey, say, in January, to finalize arrangements for the high-level review that you have proposed.

I shall appreciate your Government's reactions to my suggestions for advancing the proposal conveyed in your letter to me. Let me again say, how pleased I was to receive this proposal. I reciprocate your hope that this will further strengthen the continuing dialogue and cooperation already existing between Turkey and the Bank, and that it will enable both of us to contribute more meaningfully to Turkey's development in a more problem-free environment.
