Mr. Steckhan,

Please see attached letter which I have received from an old friend of mine, Mr. G. P. S. Macpherson, of Kleinwort, Benson Limited and also the reply which I have sent. I hope you do not mind me suggesting you as a point of contact here.

Phil Macpherson's brother, Lord Drumalbyn, who is to be visiting Washington, was Minister of State, Board of Trade, from 1963/64 in the last Conservative Government. During his time in office, he had a good deal to do with GATT and, I think, UNCTAD. If and when there is a change of government in the United Kingdom, I would expect he might be back in office and, accordingly, it might be quite useful for him to have made contacts in the World Bank Group.

Deer Phil,

Thank you for your letter of September 19 which I have just received. I must tell you that Molly and I have now left Washington as I have been transferred to the Suropean office of the World Bank which is located in Paris. Molly and I left Washington for Paris in May. We have not yet advised our friends of our move as we were waiting until we had found an apartment in Paris--not an easy job. We have now found one and will be moving into it in the middle part of Ostober. In the meantime, our address in Paris is care of the World Bank European Office, & Avenue d'Ións, Paris 16⁹.

As it happens, I was called back to Washington for two weeks to help out here while so many of our top staff are down in Ric. That is why I received your letter here and reply to it from here. I return to Paris on October 4.

I am sorry that we shall not be in Washington when your brother arrives on October 14. We should have liked to have been able to do something for him. I know that when he does reach Washington he will have very good contacts with the British Embassy and these will be able to introduce him to John Stevens's successor [E. W. Haude], etc. If by chance he should wish to meet some of the semior officers of the World Bank Group to discuss matters which might interest him, I know we would be very glad to arrange for him to do so. The people I have in mind are Richard H. Demuth and Michael L. Hoffman, Director and Associate Director of our Development Services Department which handles such matters as our relations with UNCTAD and GATT, both subjects in which I believe your brother was interested. Also, of course, Marty Hosen of IFC when you know well. If your brother should wish to pay a visit here, I suggest that when he arrives he should telephone my successor Rainer Steckhan who is now personal assistant to Mr. Woods. Steckhan's telephone number is Didley 1-3585 and I know that Steckhan will be delighted to be of any assistance.

Molly and I will hope to see Battie and you sometime in Paris. Please let us know when next you are to be there. All the best to you both.

Dear Dr. Lieftinck:

It is with considerable gratitude for a job well done that I acknowledge receipt of the report on the second, comprehensive phase of the World Bank Group's Study of the Water and Power Resources of West Pakistan, carried out under your direction. What has been achieved here is, I believe, a most important guideline program for action--directly touching the livelihood of more than 50 million people--so thoroughly backed by detailed analysis and assessment as to serve as a model for technical assistance of this kind in the development process. It was, as you say, a challenging experiment in comprehensive sectoral planning. The challenge has been admirably met and the results reflect the greatest credit on all who have been concerned.

The proposal to build a major dam across the Indus River at Tarbela is, ultimately, the centerpiece of the integrated program. You know, of course, of the substantial international support that has now gathered behind this proposal, and I think it should be clear that the work of the World Bank Group will have an historic significance as the mainspring of this great exercise in international cooperation.

The Tarbela project must be viewed in perspective as one part of the Study's broader program for agriculture, irrigation and power development in West Pakistan. The Study's observation of what is needed for success on the agricultural side is, I believe, of fundamental relevance to the development process generally. Besides assessing agricultural potential and the coordinated effort needed to realize it, the Study considers in detail alternative surface water storage projects, estimates the long-term growth of power demand and draws together a wide-ranging series of proposals for developing power resources on a scale necessary to meet long-term load growth. Over-all, the Study's identification of priorities and clarification of potential for growth should prove invaluable to the Government of Pakistan in making its decisions for the development of agriculture, irrigation and power over the next 20 years, and particularly in the Third and Fourth Plan periods up to June 30, 1975.

I share your appreciation for the assistance afforded your Group by the Pakistani authorities, in particular the Ministry of Industry and Resources, the Ministry of Finance, the Planning and Development Department of the West Pakistan Government and the West Pakistan Power and Development Authority (WAPDA). I also join with you in grateful acknowledgment of the major contributions made to the Study by the distinguished consultants working with the Bank Group and WAPDA. The World Bank, as you know, is continually building upon its professional experience and thus evolving its capacity to assist the aspirations of developing nations. The intensive effort which brought together this final study represents a further justification for the reputation, which we all value so highly, for thoroughness, objectivity, devotion and professional skill in the business of international development. For this my sincere thanks go to the members of the Bank staff who served with you.

Finally, a special word of thanks and appreciation to you, Dr. Lieftinck, for your unhesitating acceptance of this difficult assignment; for your unremitting attention to it despite other pressing demands on your time and talents; and for the always firm and effective leadership you provided throughout the long three and a half years the Study required. You may be justifiably proud of the result. I congratulate you.

I think we can count on the staff of the Bank to handle the economic problems and requirements of your country on their merits. Re your letter of August 16:

(a) Please send an invitation to Gouveia of the Banco Portugues do Atlantico--if he is to be the only representative of that Bank. It is a large and important one and should be represented if it wishes to be. I have not seen Gouveia (and probably will not in the 3 or 4 days remaining before I leave) but if I do I will so advise him.

(b) It is okay to handle Mr. Manuel Espirito Santo Silva's associate exactly as we have in the past.

(c) As I said in my August 9 note, if you feel it is not feasible to invite Mr. Walter Salomon (whom I've never met) on the basis that he is responsible for his own travel and hotel arrangements, that is that. I am disappointed at the results of the strenuous efforts which all of us in the Bank put forth in the effort to alleviate your foreign exchange problem in the current fiscal year. Perhaps there is some comfort in the thought that the magnitude of the debt service and the necessity of considering all possible alternatives for treating with the problem it presents, is now clearly recognized on the decision-making levels of all members of the Consortium. Some result from this fact will, in my judgment, emerge before the end of your current fiscal year. I remember talking to you about the disenchantment of the Consortium members with the situation in the subcontinent, but I must say it is more deep-seated than I had realized. Of course continuing progress on the program of decontrol combined with the buoyancy a good monsoon will bring, could improve the present feeling before the end of the year. I certainly hope this will be the case.

Your letter of July 10 and the enclosed staff paper are being examined and carefully considered. I think something constructive will come of this.

I would like to confirm that Louie and I are looking forward to seeing you for dinner on Tuesday, September 12. It will be a small group-not more than ten or twelve--in our apartment, so that we can relax and talk. I have talked to Sundars Rajan about this and believe it is in your schedule.

I will be in London during the first few days of August in an effort to reach an agreement on the size of the IDA replenishment. The discussions relative to the replanishment of the IDA fund are proceeding very slowly and I am more and more afraid the outcome may be another disappointment.

After the meetings in London I hope to take a holiday in Fortugal with Louie, although this will probably be interrupted once or twice by visits to Bonn or Paris on the IDA replanishment matter.

Dear Eddy:

Thank you for sending me copies of your letter to THE TIMES and of the several follow-up articles which appeared subsequently, all of which I found most interesting.

I have been very much aware of the contribution which desalination might make to economic progress in the developing world in general, and to solution of the problems of the Middle East in particular. We in the Bank now have in progress a study designed to tell us to what extent nuclear power generation and related water desalination can, taking into account both technical and economic considerations, contribute toward economic development now and in the near future. We are attempting to determine, on the basis of examination of research, manufacturing and operational experience to date, the technical and cost characteristics of the various technologies which have been and are being explored and how these may lend themselves to the circumstances in various developing areas. Lord Hinton, whom you probably know, is, in collaboration with members of our staff, carrying out this study. We expect that it will be completed before the end of this calendar year.

I do not wish to anticipate the conclusions of our study but, as you indicated in your letter, there is every indication that desalination technology has not yet progressed to the point where water produced would, when used for agricultural production, yield a return commensurate with its cost. On the other hand, in a world in which people cannot freely move to areas of greater economic opportunity and may be trapped in areas where physical and other resources are limited and where water, in particular, may be a major constraint, conventional calculation of returns on investment may not be entirely relevant.

There are doubtless a number of options which need serious exploration. Certainly one of them is the water desalination route which you have suggested. On the other hand, although water is the most pressing constraint, land suitable for cultivation within the boundaries of Israel and Jordan is not unlimited in extent. In the larger area of the Middle East there are unutilized water and land resources which might well offer superior economic alternatives. There are problems in addition to the technical ones, considerations other than the economic ones, and I favor thorough examination of all the alternatives.

I welcome the opportunity of corresponding or talking with you on this important subject from time to time in the future as it unfolds.

I have your letter of June 26. The delay in responding to it was occasioned by my occupation with a number of problems relating to the end of our fiscal year, which is June 30.

I have of course been familiar with your firm for many years and was aware of the fact that you have been aggressively building up an excellent organization for the distribution of investment securities and the private placement of bond issues. We are most appreciative of your participation in the underwriting and marketing of World Bank bond issues in Canada. It is only through the cooperation and assistance of organizations like yours that the World Bank can hope to be successful in carrying out its task of assisting in the financing of economic growth in developing countries. The three underwriting firms now managing our issues in Canada have, from our viewpoint, performed admirably in the past and I have confidence in their ability to continue to do so--always assuming the broad cooperation which they receive from the many good securities dealers throughout the country. There is no reason from my point of view why you should not discuss your position in the underwriting group with the managers. However, my position is -- and I am sure you will understand and appreciate it -- that where our syndicate managers throughout the world are doing a good job, we rely heavily on their judgment as to the participants in underwriting syndicates and the relative position of such participants. Thus, I doubt if there is much we can do in the way of assistance other than to wish you good luck in your efforts.

With respect to the underwriting syndicate for World Bank issues in the United States, I would encourage you to bring the matter of your becoming a participant in the syndicate up for discussion with enther or both of the syndicate managers. On the system of rotation which is followed, the mechanics of the next World Bank issue in the U.S. will be the responsibility of The First Boston Corporation. I would hope and expect that your approach for a participation in the U.S. group would receive sympathetic attention.

Proposal to Establish a Resident Economist in Colombia

The Bank activity contemplated by the attached (page 2 of the Area Department memorandum to the Economic Committee dated May 22) seems to me to be far removed from reality, i.e., we have loaned about \$217 million in the 5 countries since the beginning of time, of which \$135 million continues to be held by Bank/IDA, and it is proposed that in the current year alone we might possibly make commitments of \$156 million. The problem is further complicated, as far as I am concerned, by the "built-in" assumption that someone should finance a certain amount of local currency expenditures, but nowhere is it clearly stated that whatever financing the Bank provides (IDA might be different) would be used to finance the foreign exchange requirements.
