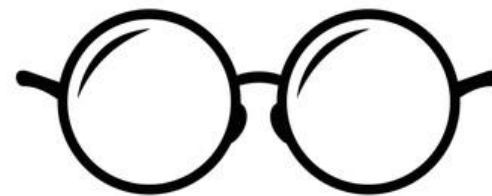

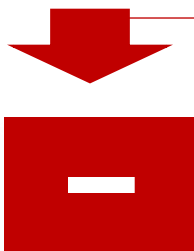

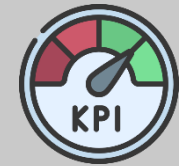

Percentage of private sector investments in climate projects

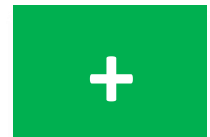
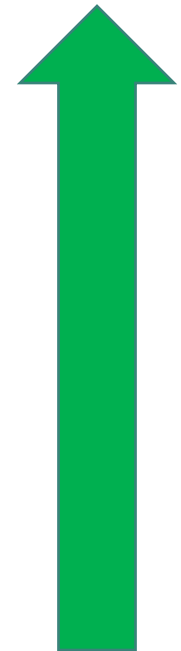


Ratio of climate financing directed to MSMEs
