1. Country participation

- 48 countries in the EUO PPP Programme
- For ICP 2024, Georgia, Ukraine and Moldova are linked to the global comparison through the ECP
- UK back to the ECP in 2026
- Kosovo is also part of the ECP and it is anticipated that they will participate at the level of household consumption again.
- Peru in OECD calculation from December 2028 onwards

2. Survey implementation status

- ICP 2024 integrated into regular Eurostat-OECD PPP rolling survey programme:
 - 6 consumer goods and services (2 per year) with slightly different timetables for Eurostat and OECD
 - Construction and Machinery and Equipment: different schedule in Eurostat and the OECD
 - Annual surveys: Compensation of Employees, Rents, Electricity and Gas, Education, same schedule





2a. Consumer goods and services surveys

For the year 2024:

- 2023 : Services; Furniture and Health
- 2024 : Food, drinks and tobacco; Personal appearance
- 2025: House and garden; Transport, restaurants, hotels (depending on the ICP 2024 release date, could be 2022 for the non-European countries for the survey on Transport, restaurants and hotels)

For the years 2022 and 2023:

All surveys from 2021 to 2024 will be used





2b. Construction survey

- Survey in 2024 for Eurostat the PPP WG discussed the interim results, with a particular focus on data validation
- Survey in 2025 for Eurostat; in 2026 for the OECD
- ICP survey (collection of prices for a list of materials, labour, equipment hire and support information) done in 2024
 - 13 countries coordinated by Eurostat including Georgia and Ukraine + USA





2c. Equipment goods survey

- Survey in 2023 for Eurostat and the OECD
- Survey in 2025 for Eurostat; in 2023 for the OECD
- 2024 results will be calculated as follows:
 - for Eurostat: the geometric mean of extrapolated 2023 data and backward extrapolated 2025 data
 - extrapolated 2023 results to 2024 to be used for OECD countries





2d. Annual surveys

- Compensation of Employees, Rents, Electricity and Gas, Education, Expenditure weights
- Questionnaires sent every year T for T-1, T-2 and T-3 at the beginning of the year (except for 1) Education: data taken from Eurostat and OECD databases 2) Electricity and Gas: data taken from Eurostat database, still questionnaire for non-European countries +UK)
- Results are included at the end of the year in the December annual calculation, T-3 being final, T-2 semi-final and T-1 provisional
- The year 2024 will be final in December 2027





3. Implementation of COICOP 2018

- New classification for annual PPPs for 2022, 2023, and 2024 to be published in December 2025: OECD follows same schedule as Eurostat
- Recalculation of past CGS surveys entering in the calculation of 2022, 2023 and 2024
- Detailed CPIs needed for the extrapolation of the survey results to the calculated years
- Issues for ICP 2024: some more aggregated BHs than the ICP classification
- Unable to provide BH PPPs for whole ICP classification as in previous rounds





4. Workshops and meetings

- Eurostat Country meeting for the consumer goods and services surveys held in March 2025 in Madrid and virtually in September 2025
- Eurostat-OECD Workshop in May 2025 in Paris
- OECD PPP meeting for non-European countries + UK in May 2025
- OECD PPP meeting for non-European countries + UK in October 2025 on COICOP 2018 implementation
- Eurostat PPP Working Group in November 2025
