





## Top 10 supplier countries by value




When looking at Projects that have not yet reached Bank Approval stage (Pipeline projects), we find +250 projects with a total proposed commitment amount close to \$50Bn.






The principle of value for money means the effective, efficient, and economic use of resources, which requires the evaluation of relevant costs and benefits, along with an assessment of risks, and non-price attributes and/or life cycle costs, as appropriate. **Price alone may not necessarily** 

represent value for money.

#### What are Rated Criteria?

Rated criteria are designed to ensure that the evaluation is comprehensive, transparent, and aligned with the objectives of the procurement. Since 2016, the Bank's Procurement Framework has permitted the use of Rated Criteria to evaluate Bids and Proposals.

#### **Since 2023**

International procurements using Bank Standard Procurement Documents must use rated criteria in their evaluations.\*

#### As of March 2025

International procurements must use specific minimum quality weightings based on their value and risk, meaning most international procurements will require a minimum 50% weighting for quality.





\*Note: Rated criteria is not mandatory for pharmaceuticals, vaccines, educational materials, future commodities and direct selection.


# Rated Criteria – A Game Changer for Promoting Value in World Bank Procurement

- Effective September 1, 2023, the World Bank will require the use of Rated Criteria as the default approach for most international procurements.
- The inclusion of key quality and sustainability criteria rather than using just the lowest evaluated price for award decisions.
- Rated Criteria create incentives for highly qualified bidders to participate in bidding.

## Where to use Rated Criteria?

All new International Procurements advertised or invited on or after September 1, 2023, using a Bank Standard Procurement Document\* must use Rated Criteria

\*However, application of Rated Criteria is **not mandatory** for:

- Pharmaceuticals
- Vaccines
- Off the shelf goods and educational materials (e.g., published academic textbooks)
- Future commodities
- Direct Selection

## KEY ADVANCEMENTS (II)

## 2025: Driving Change in Operations Procurement

Starting March 1, 2025, First, we will require a 50 percent minimum quality weighting for most internationally competitive procurement.

Second, for contracts with an estimated value over \$10 million, early market engagement will be an integrated part of our processes to attract high-caliber bidders and optimize procurement strategies.

Third, we will collaborate with clients to aggregate smaller contracts into larger packages and offer direct payment options to reduce supplier payment risks.

Starting September 1, 2025

Managing minimum 30% of labour costs to be allocated to employment of local workers.






# **Procurement-related Complaint Form**

- Submitting a Complaint
- In accordance with the <u>Procurement Regulations</u>, companies may challenge:
- The Borrower's selection documents, including Prequalification, Initial Selection, Request for Bids, Requests for Proposals documents.
- The Borrower's decision to exclude an Applicant/Bidder/Proposer/Consultant from a procurement process prior to award; and/or
- The Borrower's decision to award the contract following transmission of unsuccessful Bidder/Proposer/Consultant in the Notification of Intention to Award.
- Procurement-related complaints must be in writing and addressed to the Borrower; a copy of the complaint can be sent for the Bank's information and monitoring. # EARLY MARKET ENGAGEMENT

#### **Purpose**

Proactively engaging with prospective suppliers (before a formal procurement process has begun) is crucial to the success of any complex project. Effective March 1, 2025, Borrowers are required to undertake Early Market Engagement for all international procurements >\$10M.

This Fact Sheet highlights the importance of Early Market Engagement and offers practical tips to assist Borrowers to successfully undertake Early Market Engagement, whilst managing potential risks.

Early Market Engagement allows a Borrower to:

- · Communicate needs or requirements to suppliers;
- Openly and transparently discuss possible solutions:
- Consider cost/value impacts, benefits and risks of possible solutions;
- Test optimal risk allocation and incentives;
- Stimulate innovation in the design and delivery of the solution; and
- · Understand market capacity, capability and trends.



#### **Procurement Framework**

The World Bank's Procurement Framework, launched in July 2016, governs projects financed by Investment Project Financing (IPF). It aims to help Borrowers achieve value-for-money with integrity in delivering sustainable development. The Framework promotes flexibility in tailoring procurement approaches that reflect choice, quality, and value for money in public spending.

The Framework includes mandatory requirements set out in the Regulations, Policy, Directive, and Procedure, governing the procurement of Goods, Works, Non-Consulting Services, and Consulting Services for IPF operations. These documents provide rules and flexibility for Borrowers to design the right market approach, considering specific risks and opportunities.

81. The project's procurement risk is assessed to be 'Substantial' after mitigation measures are in place. The procurement activities financed by the World Bank under the project shall be carried out in accordance with the World Bank's 'Procurement Regulations for IPF Borrowers: Procurement in Investment Project Financing Goods, Works, Non-Consulting and Consulting Services', dated July 2016 and revised November 2017 and August 2018 (Procurement Regulations). A project procurement risk assessment has been conducted for the project. The key risks identified by this assessment and proposed mitigation measures are presented in section VI.

# Design-Build-Operate (DBO)とは

- a single organization responsible for the design, build and operation of the works
- Cost efficiencies are gained because the contract is awarded on the basis of the lowest combined capital and operating costs.
- The DBO model will usually ensure improved works performance relative to public operation.
- The DBO can also provide for skills transfer to the Employer's staff if this is specified in the contract, through training and even on the job training of Employer staff in the latter years of the operation period can be included.

#### Appendix 4. Rated Criteria - Evaluation Process



#### **Evaluation Process**

#### **Approach Market**

- All Evaluation Criteria must be finalized and set before the Bid/Proposal is released
- Ensure Procurement Documents detail the Evaluation Approach (i.e. how will Bids/Proposals be evaluated), including Rated Criteria, weightings etc. (usually the more detailed the better, err on transparency)
- Use open questions, generally better to assess quality and provide differentiation
- Ensure information is requested on all the aspects that require evaluation
- As needed, use Bid/Proposal briefings to reinforce procurement objectives and Evaluation Approach etc. (and provide an opportunity for any questions to be asked)
- Only Evaluation Criteria specified in the Procurement Documents shall be applied
- After a Procurement Document has been issued, any change to the Evaluation Criteria shall be made only through addenda (to maintain transparency and integrity)

#### Forming an Evaluation Panel

- Outlined as part of the evaluation approach in the PPSD, finalized before opening
- Include a combination of financial, technical and procurement expertise within the Evaluation
   Panel expertise should match the subject matters for evaluation
- Ensure chairperson has appropriate leadership, facilitation and organizational skills
- When identifying members check early for any Conflict of Interest (see Bank Guidance)
- Prior to evaluation commencing, conduct an Evaluation Panel briefing on:
  - Conflict of Interest (COI) control and double check no COI arising (complete declarations)
  - Evaluation Approach including Rated Criteria, weightings etc.
  - How moderation will be handled and determining the 'panel's score' (e.g., average)
  - Capturing scoring rationale (comparative strengths and weaknesses of each proposal) that shows logic to substantiate the scoring (important for audit/addressing complaints)
  - Ensuring the same evaluator evaluates all responses to a particular question

#### Checklist prior to evaluation

- Ensure evaluators are clear on the evaluation approach and understand:
  - the issues they are evaluating and the Evaluation Criteria to be applied
  - the scoring scale and how to use it
  - the need for independent initial scoring (must not collaborate with other evaluators at initial scoring stage)
  - the need for confidentially, e.g., not sharing documentation, or discussing bids with third parties including work colleagues and securing documentation
  - how to transmit emails and electronic documents securely
- Need to capture the strengths and weaknesses of each Bid/Proposal to justify scoring

### Evaluation process - managing integrity

- Borrowers need to ensure:
  - Technical requirements and evaluation approach is impartial, objective and fit for purpose
  - Evaluation Criteria are not anti-competitive or discriminatory
  - Scoring scale has clear descriptors
  - Consistency of application of Evaluation Criteria to avoid subjectivity and arbitrary scoring
  - Moderation to ensure consistency and fairness of evaluation approach
  - Documentation of the relative strengths and weaknesses of each proposal and against each criteria
- Consider the use of simultaneous independent probity advisors for contentious procurements
- Once approved, notify bidders of outcome of technical evaluation (option for a technical evaluation standstill period)
- Seek to address any complaints prior to opening of financial cost envelope

### Managing Conflict of Interest

1.Declaration

- Each person appointed to the Evaluation Team must make a formal declaration
- Good practice to require members to complete and sign a COI declaration in advance of the evaluation process being initiated
- Declaration should be revisited once identifies of the bidders/proposers are known

2. Identify conflict of interest

- Each member (including the chairperson), must submit their signed COI declarations to the head of the PIU
- The head must ensure that each declaration has been properly completed and signed

3. Managing conflict of interest

- Where a conflict has been identified it should be managed and resolved quickly
- Management plan should be drafted for approval by the head of the PIU
- The process for managing the conflict should be recorded in writing


#### Independent Probity Assurance Advisors

- Borrowers may engage an independent Probity Assurance Advisor to provide support and assurance (good practice in high integrity risk situations and/or contentious procurements)
  - Due to risk, the <u>Bank may require a Borrower to appoint an independent Probity</u>
     <u>Assurance Advisor</u>, in which case, the Borrower will obtain the Bank's agreement on selection and appointment
- If appointed, independent Probity Assurance Advisor should be present at different stages of the procurement process (simultaneous probity assurance), including inter alia:
  - Setting of the evaluation approach prior to issue of Bids/Proposals
  - Early market engagement
  - Bid/Proposal opening
  - Bid/Proposal evaluation (review the Bid Evaluation Report)
  - Negotiations
  - Contract award recommendation (and any subsequent changes to recommendations)

- Get involved with early market engagement and pre-proposal briefing – if any

- Emphasize your methodology for delivery innovate if you can
- Propose a strong project manager and experienced experts
- Cite relevant technical and regional experience similar to the project – the more significant and similar the better
- Identify and involve in-country "local partners" where possible, consider joint ventures
- Demonstrate understanding of project E&S risks and how they could be mitigated
- Offer suggestions for reducing GHG emissions
- Don't deviate from standard bidding document forms and conditions
- Carefully review qualification and evaluation criteria and use these to help write the content and detail of your proposal
- Failure to meet pre-qualification conditions leads to rejection

### Preparing bids & proposals

Top tips (cont.)






- Check your understanding if in doubt about anything contained in the bidding documents seek clarification from the Borrower's implementing agency undertaking the procurement
- Use trade missions and Executive Director's team for other concerns and questions
- Understand local laws and taxes be aware of local customs
- Don't change Key Personnel without consent
- Submit a professional proposal that is:
  - comprehensive (covers all information requested) if joint venture, ensure all JV provisions
  - includes all supporting documents
  - signed by an authorized individual
  - submitted before the deadline

- if joint venture, ensure all JV provisions are met
- properly mark all envelopes enclosing the proposals
- Be fully prepared before going into a negotiation
  - cover all bases e.g. operational, legal, financial, project-specific risks & opportunities

#### Avoiding calamity





#### Common problems with bids/proposals:

- no Bid Security
- insufficient amount of Bid Security
- lack of supporting documents
- incomplete proposals
- incomplete bills of quantities
- proposals not signed
- JV partner as proposer in another proposal
- conflict of interest
