

Thank you for your letter on the issue of municipal solid waste disposal.

As I am sure you have discovered, most of the research in this field, here in the U.S., has been carried out by the universities and various consulting organizations under contract to the Environmental Protection Agency. There is a Solid Waste Management office in E.P.A., which I assume you have contacted.

However, it is true that research funding sources in the United States are presently very limited. The National Science Foundation has an Office of Research Applied to National Needs, and I understand that Mrs. Josephine Dougherty would be an appropriate person to speak to in that office. In the Ford Foundation, Mr. Cordon Harrison deals with these issues.

Following the discussions between UNIDO and the IBRD for the establishment of a co-operative program between the two organizations and having received your assurance that the Secretary-General of the United Nations had approved the principle of the proposed program and that all other necessary clearances have been obtained by you to implement the substance of the co-operative program along the lines of the memorandum of understanding that was tentatively agreed upon between the two organizations on May 30, 1972, I am pleased to inform you of the Bank's agreement to contribute an amount of \$50,000 for the setting up by the United Nations of a fund-in-trust under the following conditions:

- a) It is the purpose of the Bank's contribution of \$50,000 to assist in the financing of the initial expenditures of the co-operative program until December 31, 1973 as agreed upon between UNIDO and the IBRD and in conformity with the timetable contained in Annex B to the record on the discussions between UNIDO and the IBRD dated May 30, 1972.
- b) The fund-in-trust shall be charged with the costs of salaries, allowances and other benefits and travel costs of staff appointed by UNIDO in conformity with the schedule contained in Annex B of the note for the record on discussions between UNIDO and the IBRD dated May 30, 1972, provided that the expenditures to be borne by the fund-in-trust for the period up to January 1, 1974 shall not amount to more than 75 per cent of the total expenditures for work under the provisional co-operative arrangements.

- c) The fund-in-trust shall be operated under the United Nations Financial Regulations and Rules, particularly those of Regulations 7.2 and 7.3, which govern the financial administration of the funds-in-trust.
- d) The IBRD will be provided by UNIDO with detailed reports showing utilization of the credit to the fund-in-trust.
- e) UNIDO will return to the IBRD any uncommitted balance remaining in the fund-in-trust at the expiration of its validity on December 31, 1973.

It would be appreciated if you would signify your acceptance of the proposed contribution by the IBRD to UNIDO under the terms and conditions set forth herein. On receipt of your confirmation, the Bank will make an initial deposit of \$20,000 to a bank account to be designated by UNIDO, such deposit to be replenished by further deposits up to a maximum aggregate of \$50,000 upon certification by UNIDO to the Bank from time to time that such additional deposits are required to meet expenditures to be borne by the fund-in-trust as provided above.

SUBJECT: Egyptian Railways Tender

I refer to your memorandum to me dated October 12, 1972. The facts of the case are briefly as follows. Egyptian Railways (ER) obtained international bids which were publicly opened on July 5, 1972. ER, whose tendering procedures were reviewed by the Association and found to be satisfactory, made an evaluation of these bids and made its proposals to the Association in its letter dated August 14, 1972. A summary analysis of the offers was also furnished along with the proposals. The proposals and the analysis of ER were reviewed by the Association Staff to ensure conformity with the guidelines and the provisions of the Credit Agreement. The proposals of ER were considered acceptable. However, before the ER was informed accordingly, MLW Industries' representations were received with your memorandum of September 11, 1972. The substantive points raised by MLW were considered by the Association Staff and it was concluded that sufficient reasons did not exist to justify the Association's objection to the proposed award to the lowest evaluated bidder, General Motors, whose bid was 6% to 8% below those of MLW. On October 5, ER was notified of the Association's "no objection" to the proposed award.

The main technical points raised in MLW's "Aide Memoire" are briefly dealt with below:

- (a) Engine room pressurization This aspect of the GM offer had been noted by ER and by the Association Staff; this is a minor matter and ER took the view that this discrepancy did not merit rejection of the GM offer. The Association reviewed the matter and found ER's decision to be reasonable.
- (b) Cab visibility An elevated driving cab was "preferred," but was not an "essential" requirement, and non-provision thereof cannot be construed as failure to meet the specification.
- (c) Cooling air for generator and traction motor The point raised is a minor one. In any case, all air entering the GM locomotives is filtered.
- (d) Tractive effort ER has few wagons of 25-ton gross weight. A train of 1500 tons composed entirely of 25-ton wagons could occur only in exceptional circumstances and the effect

on operation would be insignificant as the main line has gradients much less than 1%. The GM offer substantially meets the specification requirements, including derating.

(e) Traction motors - There is no reference in the specifications to the need for "three years" of proven service for traction motors. In any case, the traction motors included in the GM offer have been in use for over three years in a number of countries with varying climates.

- (f) Brake gear The variation here is a very minor one, and both ER and the Association agreed that it did not constitute grounds for rejection of an attractive offer.
- (g) Fuel consumption Here the claim of MLW was not that the GM offer did not meet the specifications, but that the MLW product was superior in this respect.

I am satisfied that the Association Staff did review the substantive points made in MLW's memorandum at, or prior to, the time they were raised by MLW, and that they weighed these and other factors responsibly in concluding that the Association should not object to the proposed award. Subsequently, and in accordance with normal procedure, the Association's views were communicated to the Borrower. I regret we did not inform you at the same time. Moreover, when we did inform you, a more complete statement than that provided in Mr. Votaw's memorandum of October 6 would have served you better. I hope that the present memorandum will more fully respond to your concern.

Dear Mr. President:

Last July you wrote to me concerning the Bank lending program in Paraguay. In your letter you requested that the proposed project for highway construction be financed with 50 percent IDA (soft term) and 50 percent IERD (hard term) resources. I subsequently advised you that we were reviewing your request. He have now completed our review and, while we would very much like to be in a position to make the financing available on softer terms, we must advise you that we are able to consider the highway project for financing only with IERD resources. Our reasons are the following:

(a) The scarcity of IDA resources greatly limits their availability to countries at Paramay's level of development. Paraguay, with an annual per capita GNP of the equivalent of US\$240, is in a relatively better economic position than many of the poorer less developed countries which wigh to share in the very limited amounts of IDA resources available to us. Asia and Africa, in particular, contain many countries, including some extremely large ones, which are clients of the Bank and which have per cepite incomes below US\$200. In the Latin America and Caribbean region, the number of countries with equally low per capita incomes is relatively small and the only country in the region that has been receiving a more favorable mix of IBA and Bank financing than Paraguay is one with a per capita GNP of considerably less than US\$200. Because of this heavy demand in the face of soarce IDA resources, we are unable to adequately provide much needed soft-term resources to even the poorest countries, and are confronted with a situation which leeves no room for going beyond the 50/50 blend of IDA and Bank resources for a country with Paraguay's level of per capita GNP.

(b) <u>Favorable sconcele prospects for Paraguay should pareit its</u> <u>servicing of HED debt</u>. Paraguay's increasing foreign exchange earnings creates confidence that it will have the capacity to repay the harder-term HED loans. We have been particularly impressed with the recent marked gains in beef and oil seeds exports. Paraguay's abundant land resources and capacity to expand agropastoral and forestry production present a good basis for future economic growth. Assuming your Government is successful in its fiscal reform program and the fiscal goals it has agreed

to with CIAP, it should be able to achieve the six percent annual economic growth target it has set for this decade. In 1971, the amount required to service Paraguay's external debts stood at 13.1 percent of gross foreign exchange earnings. Our projections indicate this percentage may decline to 10.8 percent over the next five years. Under these circumstances we are optimistic that your Government can service a reasonable amount of IMED debt.

-2-

(c) Financing the highway construction project with THED funds will bring the IHRD/IDA financing ratio into balance. Paraguay has received USS43.0 millions of loans and credits from the World Bank Group. This smount has been almost equally divided between IDA credits (US\$21.4 million) and IEED loans (US\$22.4 million). We are presently processing a US\$5.1 million IDA credit for education and a US\$1.2 million IDA credit for tourism. In order to maintain the 50/50 blend for the two sources of funds, it would be necessary to base our next lending operation of US\$5.6 million for the highway construction project on IBAD financing. Members of my staff have emplored with officials of your Government various alternative patterns for blending IERD and IDA resources in our forthcoming lending operations in Paraguay. Unfortunately, they could find no other mutually satisfactory pattern which would keep the 50/50 balance. Financing the three new projects education, tourism and highway construction - in the manner proposed by us, would give Paraguay US\$27.7 of IDA credits and US\$25.0 of IBHD loans.

Permit me to refer again, Mr. President, to another matter directly related to the highway project and to the proposed loan for the secondary education project. As you know, in view of Faraguay's tight fiscal situation and in order to assure that complementary local resources would be available as needed, these two projects have been related to the fiscal targets which your Government has agreed upon with CIAP. We intend to present the education losn to our Board of Directors for approval in Movember, if your Coversment has substantially met its fiecal target commitments through the third quarter of 1972. The highway construction loan could go ahead early in 1973 if the targets for 1972 have been substantially met and if there are satisfactory expectations that 1973 targets will be met. My staff informs me that your Government has begun taking steps recently that are designed to bring about substantial fiscal improvements. Please be assured that I share your connect hope that these efforts prove successful and that we will be able to proceed on schedule with the education and highway projects.

We are pleased to participate in Paraguay's economic development program and would like to assure you that we have attempted to provide President Stroessner

I am writing to let you know the outcome of our consideration of Mr. Christopher Egwim, concerning whom you were good enough to write to me on June 9.

As I mentioned in my earlier reply, we considered Mr. Egwim for entry to the Bank through our Young Professionals Program. From all accounts he certainly is an attractive individual and comes well recommended both by you and by his professors at Georgia. His academic record, however, although pretty good, was not quite up to the standards we have come to expect from the top-flight candidates for this Program. Nevertheless, in view of your warm recommendation and his good references, we brought him to Washington for a full series of interviews. Unfortunately, these interviews did not go at all well. His personality and manner were beyond reproach but none of his interviewers felt that his intellectual capacity and analytical ability were of the same order.

Particularly since the competition for entry into the Program remains intensely keen - there are some 795 applicants from whom we shall select only 16 for the current intake - we are therefore unable to consider Mr. Egwim further and have written to him in this vein.

I very much appreciate your bringing this man to my attention. The fact that we are not taking him is not really a reflection on him but just a measure of the competition. I personally know of a number of quite outstanding young men and women whom we have had to turn down. Please do not let this deter you from letting me know of any other good people - we are always on the lookout for them.

Your Highness:

I was concerned to learn from your letter, and from other messages I have received from your Government, that the changes consequent on the reorganization of the Bank are being read as a sign of lessening interest in the affairs of Asia, and in Indonesia, particularly. May I confirm, in the strongest possible terms, that this is not the case. One of my first acts as President of the Bank was to plan an active program of assistance to Indonesia, placing special responsibility for initiating it on a resident mission of unusual competence. I am delighted to know from you that this mission, and our efforts generally, have been helpful.

For my part, I have watched the efforts of your Government during these four years with keen interest and have the greatest admiration for the singleminded and effective way in which the problems of stabilization and rehabilitation have been tackled. But I know that this is only a beginning and that the combined efforts of Indonesia and her friends will be needed in the coming phase no less than in the past. This is clearly not the time when either we or the other members of the IGGI can afford to reduce our own support, either financial or technical. Speaking for the Bank Group, I intend to see that Indonesia continues to get her proportionate share of what will, I hope, be a rising volume of IDA resources.

As to the organizational changes, you may know that Mr. Bell's return to Washington was first discussed at this time last year but he and I decided that it was too early at that time. Now with the creation of a series of new Vice Presidential appointments, I was anxious to have him fill one of them, and this is the reason that I have felt unable to agree to a further extension of his stay in Djakarta. He will, however, be available to attend the next IGGI meeting in Amsterdam, which will agree on the scale of assistance needed for the forthcoming year. The remainder of the team in Djakarta will be unchanged and the new Director, Mr. Gordon, is one of our most experienced men, in whom I have great confidence. At headquarters, he and his associates will continue to have the full support of the present area department, including a division solely concerned with the affairs of Indonesia. The fact that they will be able to work directly with project personnel assigned to the Asia region should significantly speed up our operations in your country and lead generally to a more effective use of the financial and human resources we will be devoting to the task.

In closing, let me respond to your kind suggestion that I visit Indonesia again soon. I am certainly anxious to come and see for myself how things have improved in the four years since my last visit. It would also give me an opportunity of talking with the President, yourself and your associates about some of the matters that were touched on in recent correspondence. I will be in touch with you again as soon as my plans are firm.

Mr. Prime Minister:

Thank you for your letter which you sent on August 2, 1972, shortly after your nomination as Prime Minister of the new Government of Burundi.

I have followed with consternation and sorrow the tragic events which have taken place in your country since May, and I am fully aware of the magnitude of the task of reconstruction and especially of national reconciliation which is facing your Government.

I assure you, Mr. Prime Minister that we will explore every possibility to assist your country in its economic development. We have maintained our contacts with your Government in order to evaluate the consequences of the recent events on the execution of ongoing projects, especially the coffee project. We have done the same in regard to the Road Construction and Maintenance Project, which was negotiated last April. We hope that you will soon obtain UNDP's confirmation of the financing of the important technical assistance component included in this project. In the meantime we propose soon to send a technical mission to Burundi to review with your Government's representatives the administrative, economic and financial data which were obtained in the course of preparation of the project. Moreover, we look forward to the opportunity to discuss other projects with your delegation to the Annual Meetings of our institution, at the end of the month.

I hope that these contacts will be fruitful and will permit us to remain associated with the economic development of your country.

Your Imperial Majesty:

When I had the pleasure of meeting with you in Tehran, you invited me to communicate with you directly on matters which I considered of special importance and significance in the Bank's relationship with Iran.

Last January Ministers Rouhani, Vahidi, Valian and Dr. Farmanfarmaian visited the Bank and conveyed to me your increasing concern about the problems of the agricultural sector and your intention to initiate a special campaign during the Fifth Plan period to deal with them in order to improve rural living standards. To this end, the delegation requested increased Bank assistance.

We welcomed the invitation to participate more actively in this challenging task, and as I informed Dr. Farmanfarmaian in my letter of May 17, 1972, we proposed creating a special task force within the Bank to work with your authorities on the preparation of programs and projects which would assist in accelerating agricultural development in Iran and also provide opportunities for increased financial assistance from the Bank. A Bank mission visited Tehran in early June to discuss with the Ministers concerned, in a preliminary way, the form and content of the assistance the Bank should provide.

As you will appreciate, I had to satisfy myself that an intensification of the Bank's assistance to Iranian agriculture should be under leadership of the highest calibre. We were very pleased, therefore, when Sir John Crawford, presently Vice Chancellor of the Australian National University in Canberra, agreed to undertake this assignment. Sir John enjoys an outstanding international reputation in the fields of agriculture and public administration. We in the Bank have had the benefit of his advice on problems of agriculture and have worked closely with him for several years. He has served as Senior Advisor to the Bank from time to time, and has played a key role in developing Bank supported agricultural programs as, for example, for India. I consider him eminently suitable for directing and guiding any effort the Bank might make to increase its assistance to Iran's agricultural sector. Sir John is planning to visit Iran in October of this year to explore further how the proposed effort should be developed. I believe it would be extremely useful for him to have an opportunity to exchange views with Your Majesty during his visit and I should be most grateful if this could be arranged.

After I have had Sir John's report, I will write to Your Majesty further on the nature and timing of the assistance proposed, which will be determined in the light of Sir John's discussions.

Dear Rudy:

You have asked for my suggestions for subjects to be discussed at the meeting planned for Friday evening, October 27. I suggest the following:

1. Will the flow of Official Development Assistance to the developing countries reach the UN objective of .7% of the developed countries' GNP by 1975. If not, what will be the level of such aid and what will be the effect of the failure to meet the objective. What, if anything, can be done to increase the level of ODA and/or minimize the adverse effects of deficiencies.

2. Is there a conflict, in the LDC's, between maximizing economic growth on the one hand and achieving a reasonably equitable distribution of income on the other. What are the facts regarding distribution of benefits of growth in the developing countries. What action, if any, should the UN agencies recommend to increase the equity of the distribution of the benefits of growth.

3. Would it be desirable to establish some mechanism for producing a periodic "State of Development" report by an outstanding, objective, non-political group of people (along the lines of the Pearson Commission, but with broader geographic representation). If such a report is desirable, what sort of machinery for its production should be established.

There are many other subjects which we might discuss during our evening together, and I will quite understand if you do not include any one of the above suggestions on the agenda.

BEFORE DECIDING UPON THIS IMPORTANT NEW ASSIGNMENT FOR MR BELL COMMA CAREFUL CONSIDERATION WAS GIVEN TO THE EFFECT IT WOULD HAVE ON INDOMESIA. OUR CONCLUSION WAS REACHED WITH GREAT RELUCTANCE BUT WITH CONFIDENCE THAT IT SERVED THE BEST INTERESTS OF ALLOGENDERS OF THE EARK INCLUDING INDOMESIA. AS MUCH AS I THEODIALLY WOULD LIKE TO ACCEDE TO YOUR REQUEST TO DELAY MR. BELL'S DEPARTURE COMMA HE CONSIDER IT ESSENTIAL THAT HE ASSUME HIS NEW DUTIES ON OCTOBER ONE. WE ARE COMMA HOMEVER COMMA COMPIDENT THAT MR. DAVID GORDON COMMA AN EXTREMENT ABLE AND EXPERIENCED MEMBER OF THE STAFF COMMA WILL BE ABLE TO TAKE OVER HIS NEW RESPONSIENTIAL PEDIOD BEFORE YOU. MR. BELL WILL HOWEVER BE ASSOCIATED WITH THE DECEMBER IGGI MEETING.

LET ME REASOURE YOU THAT NO IMPORTANT CHANGES ARE INTERDED ON OUR PART IN THE TERMS OF REFERENCE OF THE RESIDENT BANK STAFF NOR IN ITS RELATION TO YOUR

GOVERNMENT. WE ARE VERY PLEASED WITH THESE ARRANGEMENTS AND LOOK FORWARD TO THEIR CONTINUATION. AS A COROLLARY OF THE REORGANIZATION VICE PRESIDENT SHOAID'S NAME WILL BE REPLACED ON OCTOBER 1 WITH THE NAME OF VICE PRESIDENT CARGILL. WE APPRECIATE YOUR CONCERN THAT AFTER THE REORGANIZATION INDONESIA WILL BE GROUPED WITH A LARGER NUMBER OF COUNTRIES THAN AT PRESENT. HOWEVER YOU SHOULD CONSIDER THE FACT THAT AS A RESULT OF THE REORGANIZATION COMMA MR. CARGILL, WELL HAVE UNDER HIS DIRECT CONTROL NOT ONLY THE LOAN OFFICERS AND ECONOMISTS BUT ALSO MOST OF THE PROJECTS STAFF WHO SUPPORT THE INDONESIAN PROGRAM. THIS NEW ARRANGEMENT WILL INCREASE THE RESPONSIVENESS COMMA SPEED COMMA AND EFFECTIVENESS OF THE BANK'S SUPPORT FOR INDONESIA'S DEVELOPMENT PROGRAMS.
