Dear Alvaro:

With further reference to your letter of September 21, 1966, I have now discussed with Mr. Adler, Director of the Bank's Economic Development Institute, the question of our possible participation in a seminar on industrial project evaluation. Before reaching a conclusion, we should like to obtain a clearer idea of the precise nature and scope of the seminars you have in mind.

If the conferences your institution intends to promote are to give instruction in the general subject of corporate finance, we believe it would be more appropriate for you to turn for assistance to, say, a local or fereign university, than to seek it from the World Bank family. I have no doubt that such courses would serve a very useful purpose; my point is that others are more qualified than we to give help.

On the other hand, if your intention is to focus discussions more specifically on the subject of industrial project appraisal, the Bank's Economic Development Institute might be able to help, both in the construction of a curriculum and by contributing one of the lecturers. However, since members of Norte's staff who might be interested in such lectures will necessarily be limited in number, we would not feel that it was appropriate for the EDI to participate in this way unless the seminar could be offered to a broadened group. It occurs to me that all of the Colombian financieras might cooperate in this scheme as well, perhaps, as staff members of CAVENDES, the Venezuelan development finance company with which IFC is also associated. If you think well of this idea, why den't you get in touch with the Presidents of the other financieras, and with Dr. Luis Vallenilla, President of CAVENDES, and discuss with them matters such as the location of the seminars, the criteria for selecting participants, availability of Colombian lecturers to join with the EDI man, and the general subjects to be covered by the seminars. If there is indeed an interest in such a series of joint conferences, and if such

conferences can be set up within dates and in a way agreeable to all parties concerned (namely, the five financieras and ourselves), the EDI would be prepared to participate.

One final point: I have serious doubts as to whether seminars lasting only a few days are of much value. In our minds, it would be difficult to delve very far into the subject of project appraisal in sessions lasting less than 3-4 weeks.

I would welcome your views on these comments, for I carnestly hope that cooperation between us can be achieved in this field.

The second matter concerns the Conference of Development
Finance Companies which was held here last October. You should
have received the précis of that Conference, two weeks ago. That
document and the agenda notes produced by each participant in
advance of the Conference, contain a mine of valuable experience
and views. They have been available only to the participants.
Our thought is that it should be made available to a much wider
audience. Needless to say, we would not send to any others the
documents themselves (the agenda notes and précis) which were intended to be kept confidential.

It has, however, occurred to us that each of the items discussed at the Conference could be subject of a thoughtful, analytical essay, based on the experience of the companies represented at the Conference. I have in mind, not condensation of the Conference material, nor a personal paper by the person who does the work, but rather, a systematic review of the material that became available, analytically presented and thoughtfully commented on. At the end, we would have a group of essays which we could publish separately in pamphlet form or together in book form.



b) Technical Assistance from friendly countries.

As you know in PICIC we have been able to obtain on two-year assignment basis services of Experts from number of friendly countries under the Technical Assistance Programme. Other development banks might also consider strengthening their staff training by similar means;

c) Freedom to DFC to pick and choose their projects and clients within the framework of Government policies for industrialisation.

As you know, in Pakistan we have Industrial Investment Schedule issued by the Government from time to time and for any projects financed by PICIC and IDBP falling within the framework of the Schedule, all Government formalities such as sanction for the establishment of industries, etc, automatically follow. This arrangement greatly facilitates the establishment of factories by private enterprise-s who do not have to run to various Government Departments for numerous permissions required before an industry could be set up. In fact, this is one of the secrets of the growth of private sector in Pakistan. This procedure is worth study in other countries; and

d) Special tax free reserve for bad and doubtful debts.

In number of countries bad and doubtful debts reserve could be built up by the Development Finance Companies ranging from 3% to 10% of the loans outstanding free of payment of any tax. It is important that the Development Finance Companies which provide risk capital should have such reserves. The idea is worth consideration in number of other countries, including India and Pakistan where such tax reserves are not allowed. I am moving in the matter with our Government.

The above are some of the points that occur to me as I read the record of the discussions held at the Conference. I am sure when somebody from IFC studies the discussions, he will be able to draw out number of other points. Each of these points could then be progressed by the Development Finance Companies to the extent applicable and possible in their respective cases. Material incorporated in the discussions on each such points could be very helpful to these institutions in making a move in the matter.



MR. BENKIRANE said that B.N.D.E. did not make the grant of its loans subject to a place on Company Boards of Directors, as such a step would constitute interference with the management of the firm and might involve the Bank in assuming direct or indirect liability in the event of a crisis or result in some degree of pressure being exerted in the case of a loan application.

B.N.D.E. was able to exercise supervision without representation on the Board of Directors of borrowing firms through the obligations assumed by them to transmit annual statements of account and full reports on the firms' operations and through their agreement to be subject to on-the-spot inspection without warning; in that respect B.N.D.E. preferred to act as an objective inspector, rather than to depend for its information on the generally incomplete reports placed at the disposal of Boards.

In the event of a capital participation, B.N.D.E. representation on the Board was required in order to put B.N.D.E. on the same footing as other shareholders.

MR. BENKIRANE put a number of questions to DR. TEUFENSTEIN. In particular he asked how private loans could compete with State loans with all the advantages possessed by the latter. He said that he had also wondered in what relationship the yield of State bonds in Austria had stood to that of private shares in that country and, lastly, that he would like to know the volume of I.VEX. lending in order to compare it with that of B.N.D.E.

In reply, DR. TEUFENSTEIN stated that it had been possible to place private bonds with insurance companies, as the latter had realized that it was in their interest to develop industrial investment, although it was difficult to sell such bonds without giving them greater advantages. He said that State bonds had a fixed rate of interest of 6% and that they were sold at 98% of par.

MR. BENKIRANE said that he considered that the level of debt/equity ratio was primarily a question of fact, depending on whatever valuation the D.F.C. made of the structure of its assets. That structure involved at one and the same time their distribution by type, by amount, and by date of realization.

If, at the outset, the 50:50 ratio had appeared orthodox, after having acquired enough experience of the "investment market," a 3:1 ratio appeared reasonable and even prudent. It seemed that it would be possible to reach a ratio of between 5:1 and 10:1 after the seventh year of operation when the risks had been sufficiently spread by industrial and economic sector and by type of undertaking in each sector. Some had even advocated a ratio of more than 10:1 and less than 20:1 when the 2.F.C. had proved the soundness of its judgments and the quality of its management.

It should be pointed out here that prudence was the rule whenever there was any risk of depreciation in the nation currency when there was a significant volume of foreign borrowings on the liabilities side.

B.N.D.E. enjoyed a sufficiently wide range of financing resources. Its capital, resources and quasi@capital in the form of a State grant, amounted to DH 56.3 million.

On the other hand, its medium and long term indebtedness had amounted on

31 July 1965 to DH 48.5 million At the end of the year, it would reach DH 98.5 million

The difference of 50 million arose from the line of credit from IBRD. That would be fully taken up by the end of 1965 as by 14 September it had already been used for the refinancing of 34 million dirhams.

Thus, the debt/equity ratio would mise from 86% to 175/100.

B.N.D.E. still had a broad margin of debt capacity if it were accepted that a 3:1 ratio was consistent with prudent management.

MR. BENKIRANE considered that it was not only a problem of a mathematical nature but that other qualitative factors should come into play. A development bank was not required to enter into commitments arising out of its loans that exceeded the average duration of its borrowings. The nature of its assets, their composition, their distribution over the various sectors of the economy and the fact of whether or not they were guaranteed by the State or backed by effective and readily realizable sureties, as well as the date of their payment, should also be taken into consideration.

Although B.N.D.E. had not yetrreached its ratio limit of 4:1, MR.BENKIRANE nevertheless considered that as a company developed and built up its reserves to an appropriate level, its debt/equity ratio might increase. Such a ratio could not be fixed in an arbitrary manner and, moreover, the scope for action of the less-developed countries was also limited in this respect by monetary instability, a factor that should remind them of the need for caution whenever their liabilities were in the form of lowns from abroad.
