#### The Global Launch of the GovTech Maturity Index (GTMI) Report




The GovTech Maturity Index: The State of Public Sector Digital Transformation report was introduced through a global launch event on September 16. This report provides a snapshot of GovTech maturity in 198 economies, along with a diverse set of good practice examples to assists practitioners in the design of new digital transformation projects. The launch event featured a panel of experts from the government, international organizations to academia to discuss the key findings and recommendations of the report.



#### GTMI Data Bites: The Scale of Digital Divide

The digital divide is significant, especially in low- and middle-income countries. According to the report, on average, countries in the A Group (GovTech leaders) have the highest index score, and the gap between A (GovTech leaders) and D (minimal focus on GovTech) is wide, as presented below. Similarly, a substantial gap exists between the average GTMI scores of high- and low-income countries.

This guidebook aims to provide development practitioners and governments with steps and actions to mainstream accessibility concerns in the development of GovTech projects and adopt accessibility as a systematic feature of digital solutions in the provision of public services.

The economic costs of non-competitive public procurement and state capture, using digitalized public procurement transaction data.

This project aims to design and set up a mechanism for the early detection of public procurement malpractice with the use of data and technology.



#### Improving Selected User Centric e-Services

This project aims to optimize existing cross-cutting government administrative e-Services by promoting interoperability, universal accessibility, and transparency.



#### Digital Government Readiness Assessment of Justice Sector

This project aims to determine the infrastructural, institutional, and technological factors needed to increase ICT adoption to improve the quality and efficiency of justice services through a sectoral Digital Government Readiness Assessment.



## Digital shared services for a modern and efficient public sector

This project aims to support the evaluation of the feasibility and cost-effectiveness of adopting digital shared services in core government functions.



## GovTech Country Assessment, Dialogue and Engagement

This project aims to assess digital and GovTech readiness through the implementation of the Digital Government Readiness Assessment.



## Western and Central Africa Regional GovTech Community of Practice

This project aims to develop a regional GovTech community of practice to share knowledge, build capacity and incentivize collective action to advance GovTech reforms in the AFW Region.



#### Preparing the groundwork for Enterprise Architecture

This project aims to support scoping Enterprise Architecture (EA) including study of existing EA frameworks, advisory, and knowledge sharing.
