

SUBJECT: Visit of Representatives of Group of 77

You will recall that recently in Algiers there was a meeting of the Group of 77 to coordinate the positions of the developing countries in the issues which are to be discussed at UNCTAD II. This meeting agreed upon a statement of views embodied in the so-called Algiers Charter.

Arrangements were made for small teams of representatives of the Group of 77 to visit the U.N. and various developed countries to present and explain the Charter. One such team is visiting the U.S. Government, the World Bank and IMF on December 7 and 8. The group will be headed by Ambassador Cunha of Brazil and will include:

The Executive Directors of the Bank today unanimously adopted a resolution selecting you to be President of the Bank, effective on such date and with such contract of service as the Executive Directors shall approve. The Articles of Agreement of IDA provide that the President of the Bank is also President of IDA. I expect that a similar resolution will be adopted by the IFC Board in the near future.

A copy of the resolution is enclosed, from which you will note that Messers. Pieter Lieftinch and Luis Machado, who are Executive Directors of the Bank, have been appointed to arrange with you the terms of your contract of service, including the date of your assumption of office. They, with Mr. Aron Broches, General Counsel of the Bank, worked out the details of my arrangements five years ago. Mr. Broches is out of the country and is due back in Washington on December 22. Upon his return, Messrs. Lieftinck and Machado expect to be in touch with you for the purpose stated in the resolution. Meanwhile, if you have any questions about the matter or if you would like any documents, I suggest that you communicate with Dr. Lieftinck or Dr. Machado.

Congratulations, and every good wish for success in your new post. I will at all times stand ready to assist you in any way possible.

Dear Gagan:

Thank you for your letter of October 31. I am always happy to hear from you but am particularly pleased this time, because of the tangible evidence that we continue our close relationship and can communicate frankly, but also because the tone of the letter indicates that you are again enjoying vigorous good health.

I confess that I do not understand the "worm's-eye view" of the Bank with respect to ICICI for several months earlier this year. Usually the fact that it is one of our oldest and most successful "sponsorships" plus the fact that we have encouraged it to train excess personnel to be of assistance in new finance companies throughout the world, is reflected in the staff approach to your financing. I have been thinking about it and the only rationalization I can make is that some of our men operating on a level or two below the policy-making level were improperly concerning themselves with the sequence of events which might follow a moratorium on amortization payments due to the Bank from India. I think it may be possible that such people would feel they were justified in delaying ICICI, as well as other Indian loan proposals -- until the over-all situation was clarified. I recall that one or two members of the Board, during the discussion of my proposal to open Bank deposit accounts in India for the purpose of handling amortization payment funds to the Bank in fiscal 1967/68 in a fashion which would not affect the Indian foreign exchange situation, expressed the viewpoint the Bank should not make further loans in India until the economic situation was clarified. I immediately and forcefully expressed disagreement with this viewpoint and said, quite to the contrary, that I intended to continue to recommend loans for Indian entities during the then current troubled period, particularly for the construction of fertilizer plants and for other projects in the private sector. You will recall that about this time you communicated with me to say that there was some gossip that the new ICICI loan would not eventuate. Be all this as it may, I regret the atmosphere which you report. I am not going to inquire into it at this time, but in due course an opportunity will present itself and I will do what I can to bring the viewpoint with respect to ICICI back into what I consider a proper perspective.

I am sure you appreciate that the question of the amount of the new loan was an entirely different matter. Capital is in short supply throughout the world. We are having our problems in obtaining the funds we require and I have instructed all of our loan officers to reflect the world-wide situation by thoroughly examining and reducing to a realistic minimum the amounts requested in our loan applications.

Agricultural Financing

Justice Douglas of the U.S. Supreme Court has had a long-standing interest in developing countries and is delivering a lecture on the subject at New York University sometime in January.

He asked me to lunch today for the purpose of inquiring with respect to what he referred to as "a narrow segment of finance for agriculture, i.e., cooperatives for marketing agricultural products." He wanted to know if we or any other international agencies were interested in this area and if any financing had been arranged for it. I said that a marketing operation was undoubtedly part of some of the cooperative agricultural undertakings with the financing of which we had been identified, but that I was not qualified to be more specific.

I undertook to give him a file on this subject which he could read. It seems to me that such a file should include descriptions of examples of agricultural financing which we or other entities have undertaken, with particular reference to the ocoperative market features. I would make the file sufficiently complete to give him a little education about what we do in the agricultural field.

I told him that the file would go forward in the next week or so and I would include in it the names of one or two of our men best qualified to answer any questions which he might have after reading it.

Will you please get this under way. If you have any questions you can reach me in New York through Wednesday, the 15th. I will be back in Washington on the 16th.

IDA Replenishment

I have your note of the third and am glad to hear about the editorials. I saw the one in THE TIMES, and the one in THE FINANCIAL TIMES has just reached my desk as I dictate this memo.

The ECONOMIST in the current issue (received here on November 6) was excellent and I am sure will be helpful. Barbara Ward talked to me from London when I got to New York last Wednesday and I understood from her that there was to be an editorial in last Sunday's (5th) OBSERVER, although my memory may be faulty on the name of the paper. Please have someone send me a copy.

In a separate story in the current ECONOMIST, on the "unpublicized" meeting of officials on the IDA matter, there is a petulant note which was along the same lines in a piece published shortly after the Rio meeting. I assume you saw them both. They deal with what the writer considered, in the first article, the absence of a meeting and, in the second, the long delay in arranging a meeting with sovernment officials on IDA. I don't mind the Bank -- or me personally -- being pushed around where the pushing is justified. However, I will appreciate it if sometime in an informal way when there is a graceful opportunity, you will let the lady know that we had a two-day meeting chaired by Burke last May or June; that clearly there was no point in having another meeting until certain budget and related matters had been decided in the U.K., Germany and France; that these decisions were taken in the U.K. during the last week of July, in France during the last week in August, and in Germany during the first week in September. In the interim I was doing the "one-by-one" meetings, which I still think laid a useful groundwork. With the decision-making on budgets completed, we were awaiting developments on the IDA matter when the several ministers met in Rio. We had such a Rio meeting with a group of ministers, and it became apparent that the matter should then proceed through meetings with officials--in fact this was the ministerial suggestion. It took most of October to arrange the meeting of officials which is being held yesterday and today. I am not looking for any retraction or special stories. I simply feel it does us no good in our campaign to replenish IDA to have this "snapping at the heels" when, on the basis of facts, it is not justified.

This was on the theory that young men from the financial community would be of assistance in the then understaffed World Bank operation and at the same time would acquire some knowledge of international matters. It worked out particularly well in the case of Mr. Newman.

If your schedule permits, I would appreciate it if you would take the time to meet Mr. Newman and give him the benefit of your views with respect to PICIC, ICP, and the place of the private sector in Pakistan.

I thoroughly enjoyed visiting with you in Rio. I think the meetings which were held between the Bank officials and your colleagues before, during and after the Governors' Meetings were helpful and should prove to be fruitful.

Dear Governor Carli:

As we discussed in Rio, there follows some information concerning World Bank leans to the Western Hemisphere which indicates the importance of the Western Hemisphere countries in the operations of the Bank. First, let me mention that, of the approximately \$10.6 billion of leans made by the Bank to June 30, 1967, more than \$2.9 billion (or roughly 25%) of such leans have been made to Latin American countries. Also, of the 82 countries to which the Bank has made leans, 20 of them are Latin American countries. Furthermore, when listing Bank leans by amounts leaned to individual countries you find that Mexico received the third largest amount, Brazil the fourth and Colombia the fifth of any countries. Only India and Japan have received a larger amount of Bank leans than these three countries. It should also be mentioned that on leans made to Western Hemisphere countries, disbursements to June 30, 1967 amounted to just over \$2 billion, leaving an undisbursed amount of \$833 million, which will be disbursed in the next few years.

For your further information, I am attaching three tables. Table 1 shows the individual loans made to Western Hemisphere countries in each of the last two fiscal years. Table la classifies the loans made to Western Hemisphere countries since 1963 by major purpose, and Table 2 classifies all loans made to Western Hemisphere countries to June 30, 1967 by major purpose. You will also find on Table la a breakdown by purpose of \$617 million of loans which were at June 30, 1967 being proposed for further lending to Western Hemisphere countries. As you will see from the table, three of these loans totaling almost \$73 million have actually been made since June 30, 1967.

I trust that you will find this information useful.
