Dear Mr. McKenzie:

Having safely returned to Washington from an exceedingly interesting and informative visit in your part of the world, I hasten to write to assure you that I completely understood the compelling reasons for the change in your travel plans at the time mine called for me to be in Nairobi.

You and the Finance Minister had no alternative but to continue in London and, considering all the conditions and circumstances, I congratulate you both on the results of your attendance at the Coffee Meeting. While I was disappointed at not seeing you, I am sure this will be compensated in the future, and in fact I expect to have the pleasure of seeing Mr. Gichuru here in Washington next week.

On the other hand, I thoroughly enjoyed the opportunity of meeting and lunching with President Kenyatta at Mombasa. I am completely taken with the beaches north of that city, and could easily be persuaded to get into a negotiation with a local real estate dealer. We flew at an altitude of between 150 and 250 feet practically the entire distance between Mombasa and Mlindi, where we went up to the normal altitude and continued our flight to Nairobi. There are half a dozen spots where a stretch of 100 or 200 yards of beach is bounded on either side by protruding rocks, forming a protected, private beach, which would appeal to me very much.

In the absence of the Finance Minister and yourself, I met in Nairobi with the Planning Minister and a number of his colleagues, including the Education Minister. The conversations and exchange of views, from my point of view were constructive and worthwhile. With hindsight, the program which I attempted was on the ambitious side, and I was quite happy with the cancellation of the Kenya inspection trips, receptions, etc. Next time I will start at Nairobi and be full of the bounce and energy which is present at the beginning of such a trip. Nevertheless, I appreciated the arrangements which had been made, and assure you that I benefited from those portions of the program which were unchanged-particularly the afternoon and evening at Kilaguni Lodge, where the wildlife and the view were both spectacular.

Dear Dr. Nyanbongo:

I recall with pleasure our meeting at the reception given at the Uganda Club, Kampala, by the Uganda Electricity Board in honor of Mrs. Woods and myself and I am now writing to you, as promised, to give some further information regarding the economic mission which the World Bank is sending to East Africa. The mission will make a thorough study of the development programs and policies of Uganda, Tanzania and Kenya and also make recommendations regarding possible development assistance from the World Bank Group. The report, when available for wider release, should be of use to friendly countries which may wish to cooperate in promoting economic development in East Africa.

The economic mission will be headed by Mr. John C. de Wilde, Program Adviser to the Director of our Africa Department. Mr. de Wilde has a varied experience over sixteen years in the World Bank. He spent a considerable part of the years 1963 and 1964 in Africa and has a wide knowledge of the continent, particularly of the problems of agriculture. It is expected that Mr. de Wilde and his team will be in East Africa for a period of approximately six weeks beginning October 24--the exact date of Mr. de Wilde's arrival in Kampala has not yet been fixed. The mission will carry on its work simultaneously in all three countries and will include general economists and specialists to deal with various factors of the economy including agriculture, industry, education, tourism, transport and electric power. Mr. de Wilde expects to have a deputy in each country who will be in charge, under his over-all guidance, of preparing individual country sections of the report.

Mr. de Wilde and his associates on the mission will be interested in canvassing the views of a wide range of informed persons, both inside and outside governmental circles, on the development plans of the three countries and the most effective means of promoting these through external aid. I have informed Mr. de Wilde of our conversation and he is looking forward to the opportunity of meeting you and hearing your views. The detailed list of members of the mission is not finalized as yet but, as soon as it is available, Mr. de Wilde will write you direct with a copy. Also Mr. de Wilde will write you to arrange Dr. A. Nyanbongo

Notes on Meeting between Mr. Woods and Dr. A.M. El Kaissouni, September 4, 1966

1. While changing planes in Cairo on Sunday, September 4, 1966, Mr. Woods met with Dr. Kaissouni, U.A.R. Deputy Prime Minister for Financial and Economic Affairs. The following notes record some items of the conversation; they are not necessarily a full record of the talk since I had to be absent, from time to time, to arrange our onward bookings.

Dr. Kaissouni referred to the draft report of the economic mission to the 2. United Arab Republic under Mr. Collier. Dr. Kaissouni said that the draft report seemed to him to be objective and, in general, to be favorable in tone to the U.A.R. The U.A.R. was making progress in putting its economic house in order and Dr. Kaissouni referred to reductions in government expenditures, encouragement of savings and certain increased prices, especially that of rice. Mr. Woods said he had talked with Mr. Collier and his impression also was that the U.A.R. was making progress. However, Mr. Woods pointed out that the expenditures for military purposes had proved to be higher than the Bank had expected. Dr. Kaissouni went on to say that the mission had not been "stingy" in recognizing and appraising the accomplishments. He thought however that too great emphasis had been laid on the foreign exchange picture and that, in particular, references to the shortcomings of the U.A.R. had been repeated in the report more than was necessary. Mr. Woods invited Dr. Kaissouni to make his points frankly to Mr. Collier who, he was sure, would take good note of them. The purpose of the report was to be helpful not only in the relations between the U.A.R. and the Bank but also to assist the U.A.R. in its relations with bilateral lenders.

3. Dr. Kaissouni referred to the land reclamation and irrigation projects and to recent approaches from the Food Machinery Corporation. He understood that the FMC was depending mainly on United States AID to come in with the bulk of the financing. He (Dr. Kaissouni) had been hoping that this might be a joint operation with both U.S. AID and IDA. Mr. Woods said that, at the moment, he could not forecast whether Bank/IDA might participate. There were still various outstanding issues, such as the military expenditure one.

4. Dr. Kaissouni referred to other developments:

(a) It was hoped to make a start in May 1967 in exploiting the oil from the Gulf of Suez and, by the end of 1967, oil production should be running at the rate of 7.5 million barrels annually. There would also be opportunities for making fertilizers from the gases.

(b) Both Germany and Italy were interested in assisting the expansion of the existing fertilizer plant and Dr. Kaissouni hoped that the World Bank Group might find this an interesting project. (c) U.A.R. Government and the Board of Suez Canal Company had agreed to spend about EL60 million in improving the Canal in order to allow it to accommodate bigger tankers.

5. Dr. Kaissouni referred to the talks which had been going on between the U.A.R. and the IMF. These had been progressing well and it was hoped that an agreement could be reached during the coming week.

6. Mr. Woods asked regarding progress on the various nationalization issues. Dr. Kaissouni said good progress was being made. The President of the U.A.R. had ratified the Act of Parliament which empowered the U.A.R. to enter into an agreement with the Shell Company. This agreement was due to be signed on either September 13 or 14. As regards the issues between the U.A.R. and Belgium, Dr. Kaissouni said that conversations are still in progress. All matters relating to sequestration issues had now been settled. There was one matter outstanding in regard to a nationalization issue which concerned the value to be placed on one undertaking. Dr. Kaissouni said that he thought the Belgians were being undully difficult on this issue because they were relying on the Bank to bring pressure on the U.A.R. to settle at the Belgian figure. He felt the Belgians should negotiate and sign agreements covering all items with respect to which there were no differences and leave the one item still to be settled for the future.

7. In regard to possible projects for the Bank/IDA, Dr. Kaissouni said that Mr. Cope had indicated willingness to start looking at a railway project. Dr. Kaissouni said that, although the railways needed further financing, this project did not fall within the U.A.R. top priorities which are irrigation, drainage and fertilizers. Dr. Kaissouni also pointed out that land projects are most suitable for Bank/IDA financing since they require a fairly lengthy term. It would be a mistake to accept short-term money for these projects which do not become profitable for at least seven years. Dr. Kaissouni summed up by pointing out the great potential of the reclaimed land---this is not desert land but land in the Nile Valley.

I have cabled Sir Ernest Vasey with your reply to his cable and have left a note advising Lejeune that you wish to take this matter up with the Executive Directors in September.

Schmitty has ascertained that David Bell will be in Nairobi and Lagos as follows--cable addresses as shown:

Dave Gordon's last letter to me on this subject said "As it appears now, formal clothing will not be needed." To make quite sure of the position, and in case he has fixed up anything since then, I am cabling him that we do not intend to bring dinner coats unless he advises to the contrary immediately.

You asked regarding the status of the draft Operational Memorandum on "Disputes over Defaults on External Debt, Expropriation & Breach of Contract" which was discussed at Senior Staff Meeting on Wednesday, July 27. Mike Hoffman informs me that no further SSM discussion is contemplated. The draft is now in practically final form and the Operational Memorandum should be issued shortly.

You may have received a personal message at Paco de Arcos from the Philippines. The Philippine Embassy asked for your overseas address which we were reluctant to give out and, accordingly, I asked Peter Cargill to speak with them. He did so and was able to read them your cable indicating that you had received the message inviting you to visit the Philippines before September 12 and that you had replied you would be unable to do so but would look forward to seeing the President of the Philippines here. We thought that had finished the matter. However, Mr. Mejia-Palacio telephoned later and insisted on having your overseas address. I thought you would like to know the background on this.

Thank you for your letter No. 461 dated August 8 which came in this morning. Hursit Calika, Norman Horsley and I have had a quick meeting together to consider what you write and the following are our views. As the man on the spot, you are in the best position to judge what is feasible and our comments merely reflect our reactions to the itinerary you have put down on paper. If our coments do not make sense to you, please disregard them.

On going through the draft itinerary, we would make the following points:

August 25

I suggest that the first meeting might well start later than 10:00 a.m. We shall not get to bed before 3:00 a.m. that morning and Mr. Woods would prefer a later start, I feel sure. Presumably, the meetings you are scheduling are with ministers.

August 26

The Washington Post this morning mentions that President Nyerere is paying a visit to Somalia for a weak starting August 22. You will know whether this is accurate.

August 29

As we are to be staying at Entebbe, will there not be quite a bit of double driving from Entebbe to Kampala to fit in these meetings and the reception? Could we not rearrange the times of meetings to avoid this or, perhaps, you propose that some of the meetings are held at Entebbe.

August 30

The program for that day seems rather full to us, especially considering the driving involved. Calika has queried how good the road is from Owens Falls to Bujagali Falls.

August 31 - September 2

We have the feeling that the program from leaving Entebbe to arriving at Nairobi is really fuller than Mr. Woods may wish to undertake. You indicate fairly long periods (two of two hours each) flying around looking at schemes from the air. Also, we wonder if it is not overdoing it to have two nights watching wild animals at their evening sports. Finally, the early morning of September 2 is quite strenuous as it means leaving Treetops early, stopping for a wash and shave at Nyeri and then on to Nairobi in time for a mid-day lunch with the President. We would be inclined to try and streamline these two days, August 31 and September 1, and possibly leave out one of the game-watching nights, thus getting to Nairobi on September 1. Another advantage in cutting down on these days would be that we could schedule the morning starting times a little later.

As I said to begin with, you are the chap who knows the country and what is feasible, and these are comments from 7,000 miles away. But I thought you would like to have our thinking as soon as possible.

While I haven't read your paper "DEVALUATION; A DISASTER" carefully, I did thumb through it, and one statement struck my eye and I feel impelled to comment on it.

In paragraph 3, the following sentence appears: "I have it on unimpeachable authority that we were going to get \$900 million as nonproject aid through the World Bank consortium, with or without devaluation, and I find that the same figure, if not less, has stood even after devaluation."

This statement is incorrect. I can tell you of my own knowledge that the World Bank share in the \$900 million non-project aid figure would not have been the same if the program for decontrol and relaxation had not been adopted. I have no ppinion about other members of the Consortium, but speaking for the World Bank alone your "unimpeachable authority" is impeached.

Regardless of the honest differences of opinion on the complex and difficult problems involved, I would hope that with the decision taken all concerned will face in the same direction and try to bring a new surge, a new enthusiasm, a new dedication, to the task of sound economic development in India.

Dear Harold:

Just because the letter was from you, I really did give it some thought, but the more I have thought about it the clearer it is that my response must be a negative one. It will not be feasible for me to accept your invitation to speak at the 1967 Business Outlook Conference on November 15.

There is more than one good reason for this response, but I think it is based principally on the proposition that I have absolutely no competence on the suggested topic, i.e., "International Monetary and Credit Problems." In the international field, these matters are the responsibility of the International Monetary Fund, the Managing Director of which is Mr. Pierre-Paul Schweitzer. In the World Bank group of entities we are concerned with long-term finance in connection with facilities designed to increase productivity in the underdeveloped countries. But even if the subject could be amended to cover the activities of the World Bank, I would not wish to make a firm commitment in the period between mid-October and the year end, as I am keeping reasonably flexible on the theory that I may do some traveling on behalf of the Bank.

In the United States Treasury, the recently appointed Assistant Secretary for International Affairs is Mr. Winthrop Knowlton--formerly identified with White, Weld & Co. The Under Secretary is Mr. Frederick L. Deming, who represents the United States at the seemingly endless series of international monetary conferences. Mr. Charles A. Coombs, a long-time senior on the staff of the New York Federal Reserve Bank, is exceedingly knowledgeable in the international monetary and credit area. There are one or two college professors at Yale and MIT who are also highly regarded.

Perhaps these random thoughts may be helpful to you. I wish I could help you by accepting the invitation--that would be easier all around--but it really is not possible.

My dear Mr. Minister:

I am writing you to tell you that I am looking forward to meeting you during the forthcoming Annual Meeting of the World Bank and the International Monstary Fund here in Mashington in September. At that time I hope we can have an extensive discussion on the ways in which Kuwait and the World Bank group of institutions can cooperate in the important task of assisting economic development in some of the many places where it is a pressing need.

Recently I had the opportunity to have a very useful talk with Mr. Abdlatif Al-Hamad in his capacity as Alternate Governor for Kuwait in the World Bank. I was very much interested in hearing from him about the activities of the Euwait Fund and this conversation left me even more firmly convinced of the importance of our working closely together in the future.

I am very pleased that Kuwait is included among the countries in the International Development Association which are designated "Part I" member countries, by which is meant that these are the capital exporting countries which are the important providers of usable resources to carry on the work of the IDA. I am sure that, especially in your role as Minister of Foreign Affairs, you are familiar with the great needs of the developing world for additional capital resources and what is, I believe, the useful role played by IDA in meeting these meeds. Mike Hoffman has passed on to me your letter of July 7 regarding your talk with Dr. Sarwate of the International Telecommunications Union. I discussed it with Mr. Woods.

Mr. Woods and I have the same recollection of the matter. Dr. Sarwate spoke to Mr. Woods during the London ACC Meeting and, on his return to Washington, Mr. Woods asked me to telephone you (you were in New York) to try and find out more of the background to these complaints. My recollection is that you informed me that the members of the ITU were not really criticizing the Bank, with which they had few difficulties, but that they were mainly concerned with the administrative procedures of other arms of the U.N., especially UNDP. Having passed this information on to Mr. Woods, he decided that he need not take Dr. Sarwate's request further. On reflection, you will no doubt recall our talk on this matter--I am almost sure that it was you I spoke to.

Naturally, Mr. Woods would not like to leave Dr. Sarwate under any impression that he (Mr. Woods) is not ready to investigate properly a matter which Dr. Sarwate referred to him. Accordingly, I enclose a letter from Mr. Woods to Dr. Sarwate for you to hand over to him, if you think that desirable. If you would prefer to handle this matter in another way, say, in conversation with Dr. Sarwate without delivering Mr. Woods's letter, Mr. Woods would have no objection.

When Mike Hoffman replied to Dr. Sarwate's letter of April 19, he was of course unaware of the conversation between Dr. Sarwate and Mr. Woods--in fact, Mike replied to Dr. Sarwate's letter probably on the very day when Mr. Woods and Dr. Sarwate were having their conversation in London.

Mr. Consolo has written about his recent conversation with you regarding a resolution passed by your Plenipotentiary Conference last November. I remember very well your speaking to me about this matter during the April meeting, in London, of the Administrative Committee on Goordination. You told me, at that time, of the discussion which took place at your Conference and I made a note to look into the points raised. On return to Washington, I instituted enquiries and was informed by my staff that the complaints raised by your members regarding troublesome administration procedures and delays in the consideration of requests for financing were not directed to the World Bank Group--the information I received was that your members were referring rather to other agencies of the United Nations' family. That being so, I took it that no further action was necessary on my part.

It may be that I was misinformed. If you should wish me to go into this matter further and if you can give one or more specific instances which have been brought to your notice, I will welcome the opportunity of investigating further. I agree entirely with you on the importance of insuring that World Bank procedures are, to the maximum extent possible, so arranged as to simplify the tasks of would-be borrowers.

In conclusion, I would point out that when Mr. Michael L. Hoffman responded, on my behalf, to your letter of April 19, 1966, he was unaware of the conversation we were having in London, probably on the very day he was writing to you.

My dear Mr. Minister,

I have just received a letter from Mr. Ernest-Picard of the National Association of French Security-Holders reporting that the Brazilian Government and representatives of the Port of Para Company have reached an agreement on the compensation to be paid for the nationalized assets of that Company. This is one of the disputes about which I have written you earlier, and I am delighted to hear that it has been resolved.

This agreement is further evidence of your Government's desire, expressed in your letter to me of November 23, 1965, to expedite the settlement of those claims which can be resolved through administrative action. The memorandum accompanying that letter indicated that in the case of Ceara Tranway Light and Power Company, a commission to determine the amount of the claim had been directed to report by the end of December 1965. I would be grateful if you could inform me when there are any new developments in this case. The memorandum also indicated that negotiations were still pending in two other cases, the Mortgage and Agricultural Bank of Minas Gerais (bonds) and the Itabira Iron Ore Company. I trust that recent developments in these cases are encouraging.

As you know, the World Bank is interested in the resolution of disputes of this kind, among other reasons because their continued existence interferes with the flows of capital necessary for economic development. I am very pleased to hear of the resolution of the Port of Para dispute, and I hope that the few remaining claims can soon be satisfactorily settled.

Dear Paul:

Thank you for your letter of June 22. I regret as much as you that it was impossible for me to make the journey to Milan. I am sure that the meeting went well and will look forward to John Miller's report on it.

We were a little bit puzzled about the report which Mr. Siriwardene gave to you about the Bank's work in Ceylon. In the past year we have organized two meetings of donor countries at which nearly \$100 million of non-project aid was pledged. The goods under this aid program started flowing about a month ago and should lead to a considerable increase in foreign exchange reserves by the end of this year. At the same time we helped the Government of Ceylon to draw up an import program which was designed to make a start in relieving the shortages which had brought the economy almost to a standstill. A large part of these imports is intended for private entrepreneurs.

We have already studied the Development Finance Corporation of Ceylon with the idea of making a loan later this year provided that the Government continues to introduce appropriate economic policies. This will provide foreign exchange to private industrial enterprises of the kind to which Mr. Siriwardene refers. I might add that our estimate of the number of entrepreneurs likely to take advantage of these fresh resources is much less than Mr. Siriwardene's.

As you know, it takes time to revive an economy which has reached the extreme position Ceylon was in a year ago, and it is easy to understand that people get impatient. I am hopeful, however, that in another year there will be visible significant improvements in all parts of the economy, as a result of the work which we and several friendly countries are now doing on Ceylon's behalf.
