INSTRUCTIONS

- 1. Department and Division Names: Type complete names of the department and division hiring the consultant, as spelled out in the current Master Organization Code list.
- 2. Prepared By: Enter name, room number and telephone extension of the person preparing the Form 74 (not of the division chief or the department director).
- 3. <u>Consultant's Full Name</u>: If a firm is hired, enter the firm's name first followed by the full name(s) of individual consultant(s) working for the firm.
- 4. <u>Specialized Field</u>: Select one of the fields listed below, as applicable to the consultant and enter it here. If none is applicable, enter Management Specialist. Corresponding speciality code should be entered only in the coding section as explained in para. 14B below:



- 5. <u>Nationality and Residence</u>: Nationality of a firm, an individual consultant or one who is working for an international organization MUST be entered. If no individual can be identified with the international organization, enter its base country.
- 6. <u>Type of Action</u>: Mark one of the boxes as applicable. Termination can be marked together with any of the other four types of action. Correction can be used for changing the following information only: (a) Name (b) Nationality (c) Country of Work) (d) Speciality (e) Activity and (f) Beginning and ending dates without change in number of billing days. When a reduction in previously committed costs and/or billing days is required, mark the "uncommitment" box. Use a negative sign with the amounts being uncommitted. - 3. The host to a representation luncheon, a staff hospitality luncheon, a staff activities luncheon, or a group luncheon on personal account should complete the accounting side of a menu form; he need not record the guests' names (for luncheons over four), but he should refer to the list of names on the "Request for Dining Room Reservation" form.
- 4. Each individual who is to pay for his own luncheon or the luncheon of others will also be requested to complete a menu form to enable the personal charges to be recorded.

SPECIAL FUNCTIONS:

- 1. This form should be filled out when requesting the use of a private dining room or one of the main dining rooms for an evening reception. All evening receptions for less than 75 persons will be held in the "D" building Executive Dining Room; all evening receptions in excess of 75 persons will be held in the "E" building, 2nd floor Gallery.
- 2. When requesting the use of a private dining room or one of the main dining rooms for an evening reception, please consult the Dining Room Manager in the first instance regarding the availability of the dining room on a specific day. This should be followed by completing this form indicating the date, number of guests (do not record the names of guests' on this form), the department to be charged, the type of charge, and the purpose of the reception. This completed form should be forwarded to the Dining Room Manager no later than five working days in advance of the reception.
- Notes "Representation" relates to hospitality extended to guests outside the Bank Group in accordance with policies contained in the Administrative Manual Statement No. 4.02 administered by the Director of Administrative Services.

"Staff Hospitality" relates to the entertainment of staff within an organizational unit by the head of that unit or his designee against specific budget allocations for this purpose provided by the Programming and Budgeting Department.

"Staff Activities" covers farewell luncheons and parties for staff members of long service and often social functions--the cost of which is borne by the Personnel Department. Reservations in this connection, should be routed through and approved by the Staff Relations Division of the Personnel Department.


