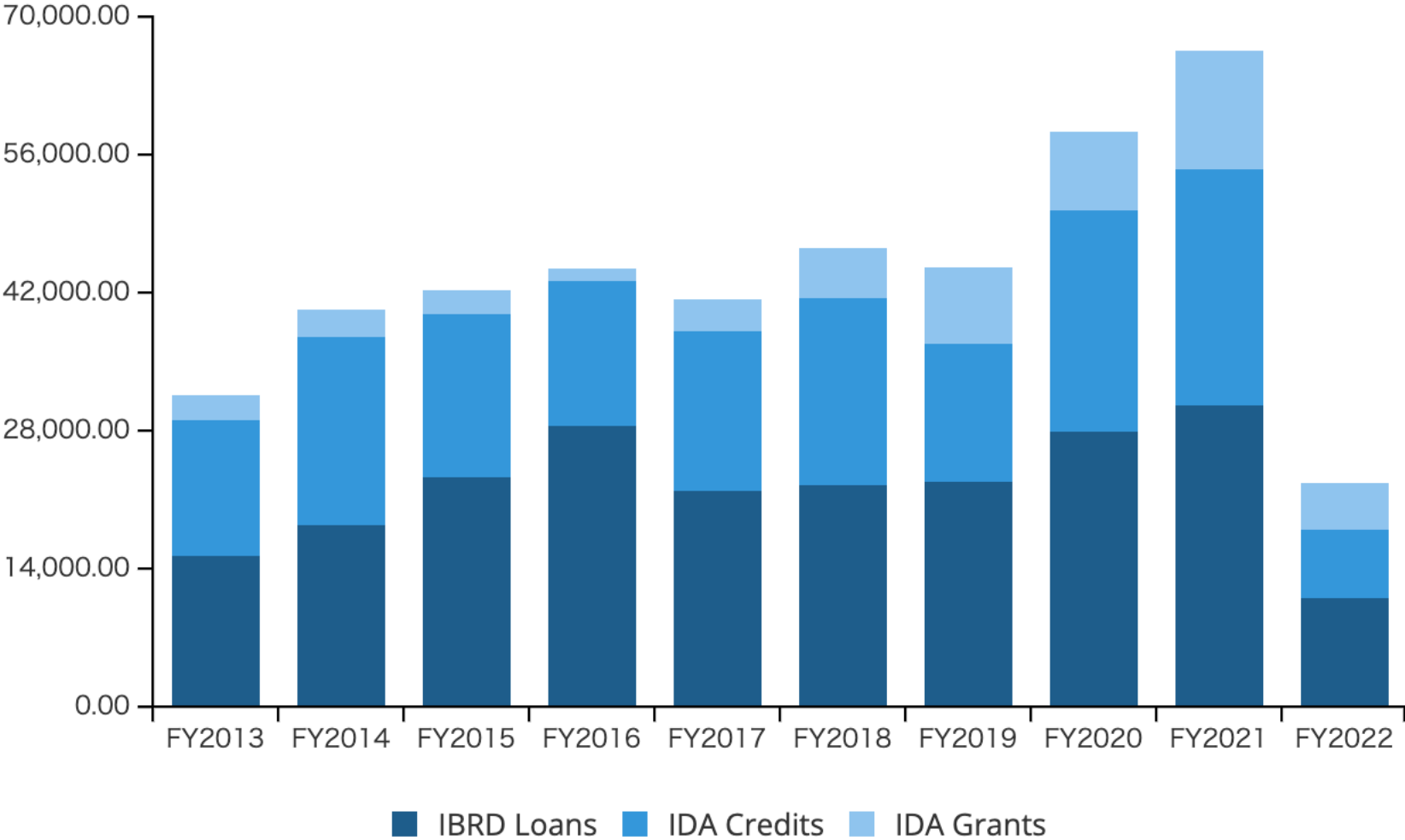
投資プロジェクト融資

- 世界銀行の資金は投資プロジェクト融資 (IPF) を通じて受入国に提供される。その形態としてはIBRD貸付、IDA融資、グラント、保証がある。
- 商業貸付とは異なり、世界銀行のIPFは、借入者に必要な資金を供給するだけでなく、持続的かつグローバルな知識移転及び技術協力的手段にもなる。
- 例えば、プロジェクト準備の構想段階での分析・設計業務に対する包括的支援、実施中の技術支援や専門的意見(プロジェクト管理、信託やセーフガードの活動などの領域を含む)、プロジェクト全体を通じた制度構築などがある。

世銀プロジェクト調達とは？

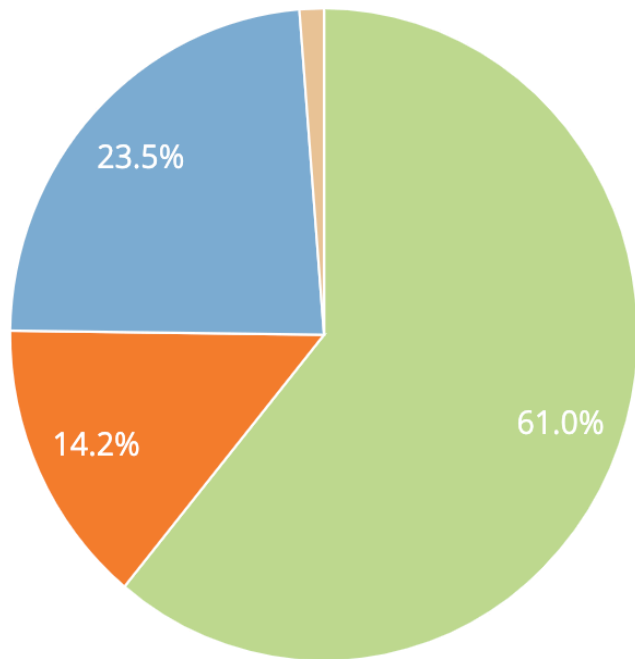
- 毎年US\$15-24 billionの調達案件132か国から発注
- コンサルティング・サービス：技術設計・技術監督、徴税に関する助言、研究開発
- インフラ：鉄道、発電所、浄水場
- 大規模設備：発電機、風力タービン、大型ポンプ設備、鉄道車両
- ハイテク情報技術：コンピュータ、携帯電話ネットワーク
- 非コンサルティング・サービス；航空測量、地図作成、現地調査
- 非常用供給品：緊急時の医療用品、避難所、食糧

Lending Amounts by FY (US\$ mil.)

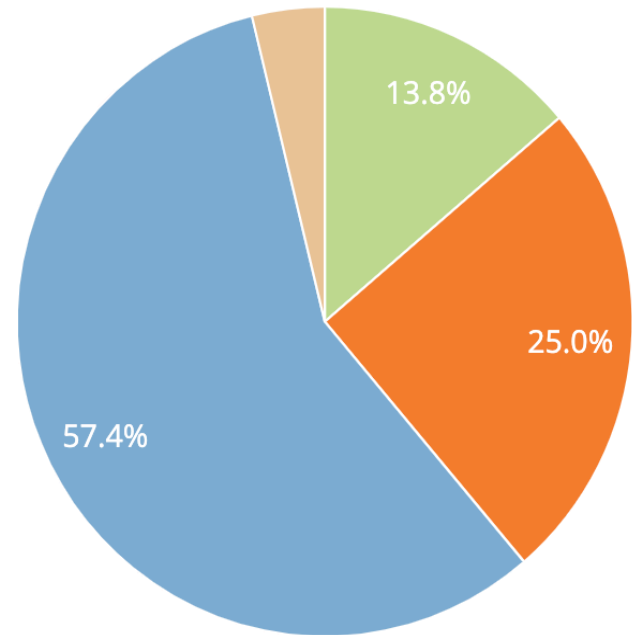

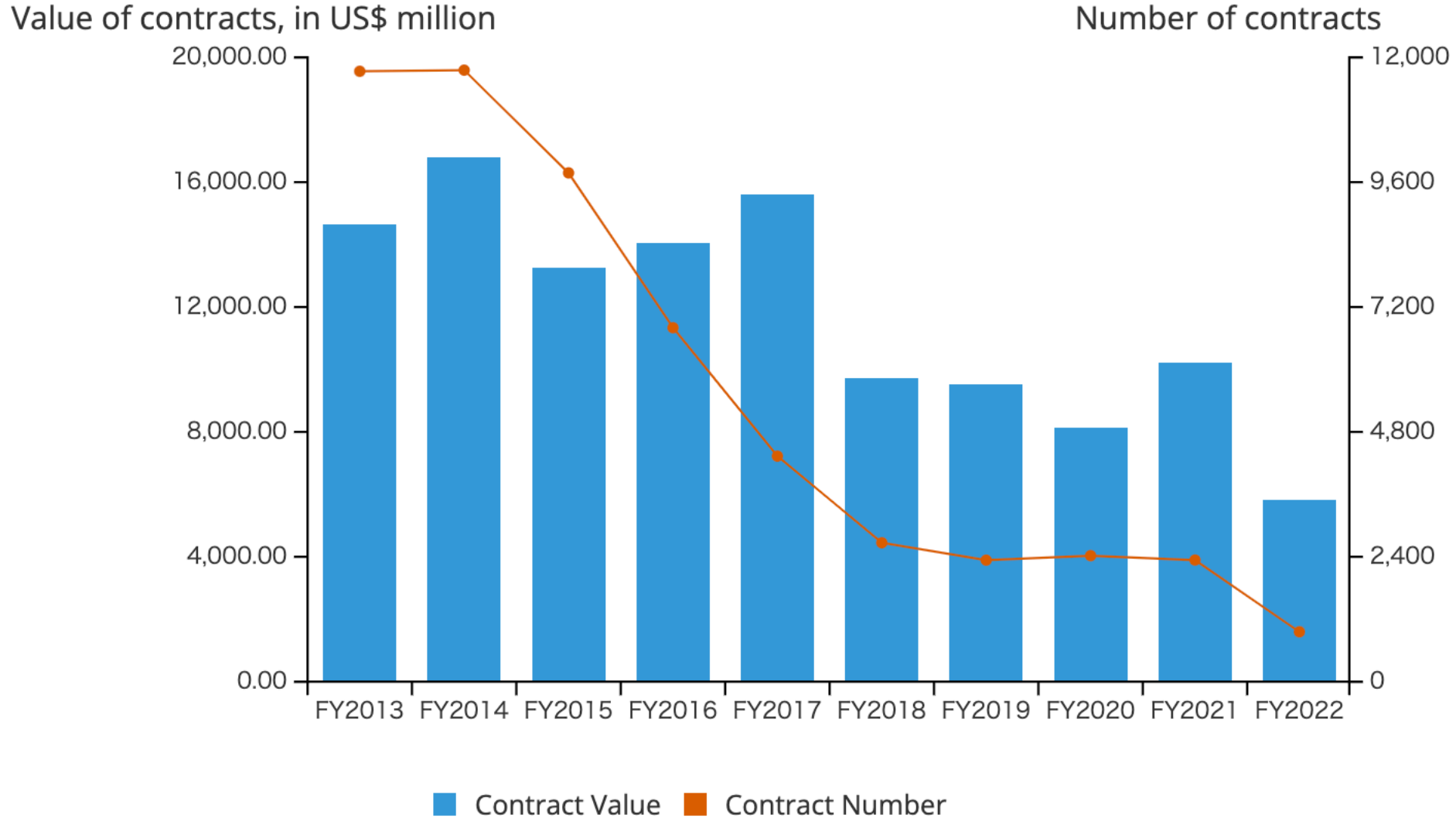

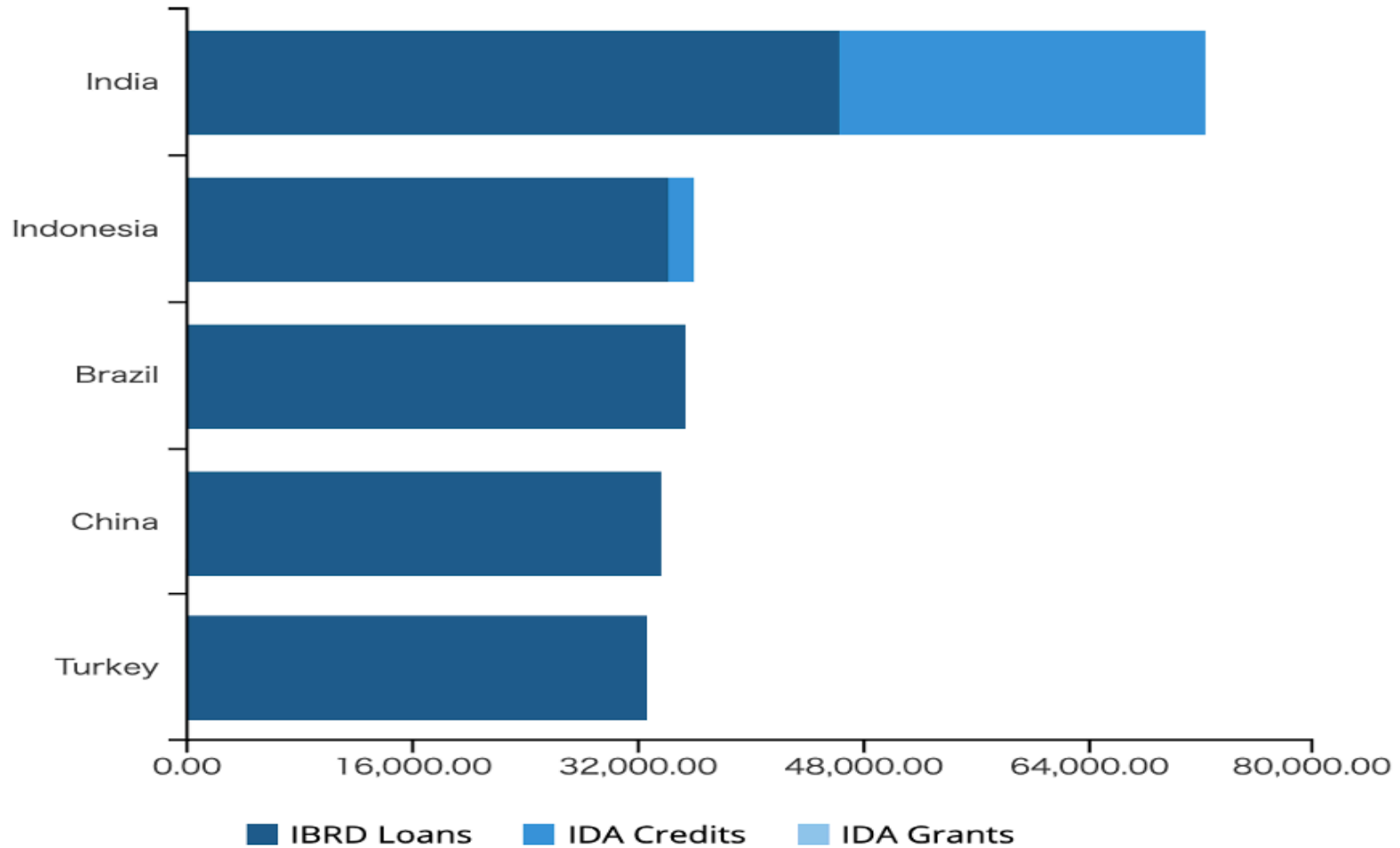

Prior Reviewed Contracts By Fiscal Year



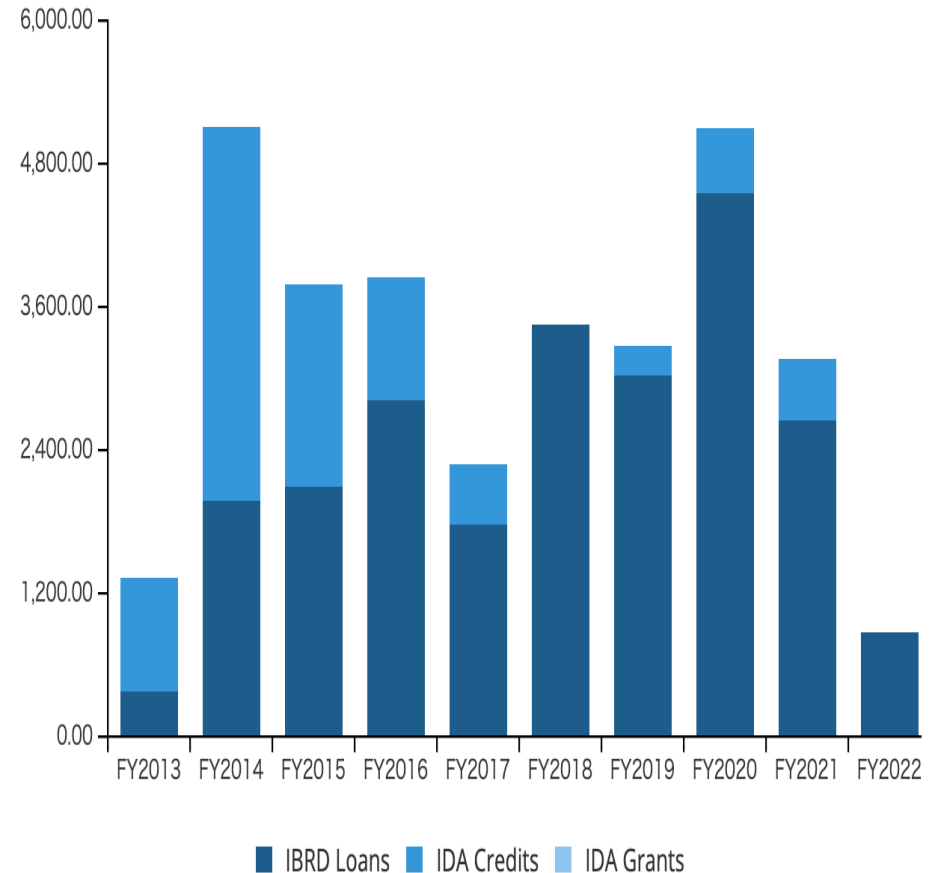
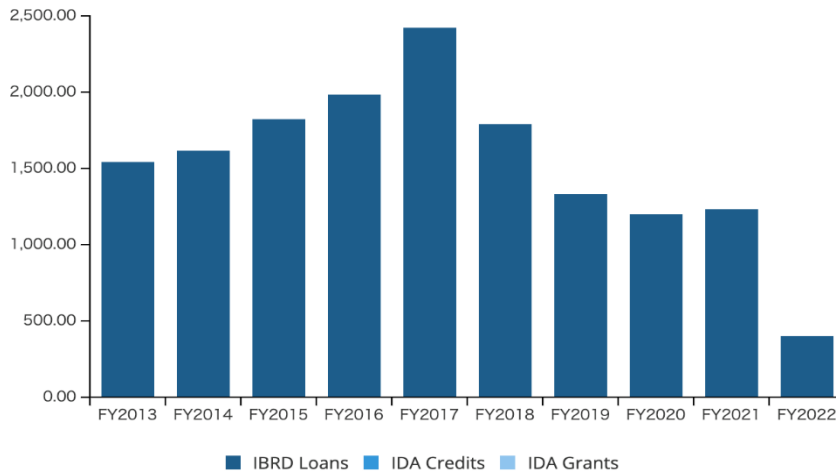
Lending by Country (US\$ mil.) FY2000-FY2022

- Commitments of **\$45.6 billion** from IBRD, to middle- and low-income countries

IFC and MIGA private sector financing includes:

- **\$42.7 billion** from IFC, to private companies and financial institutions
- **\$7.6 billion** in gross issuance of MIGA guarantees

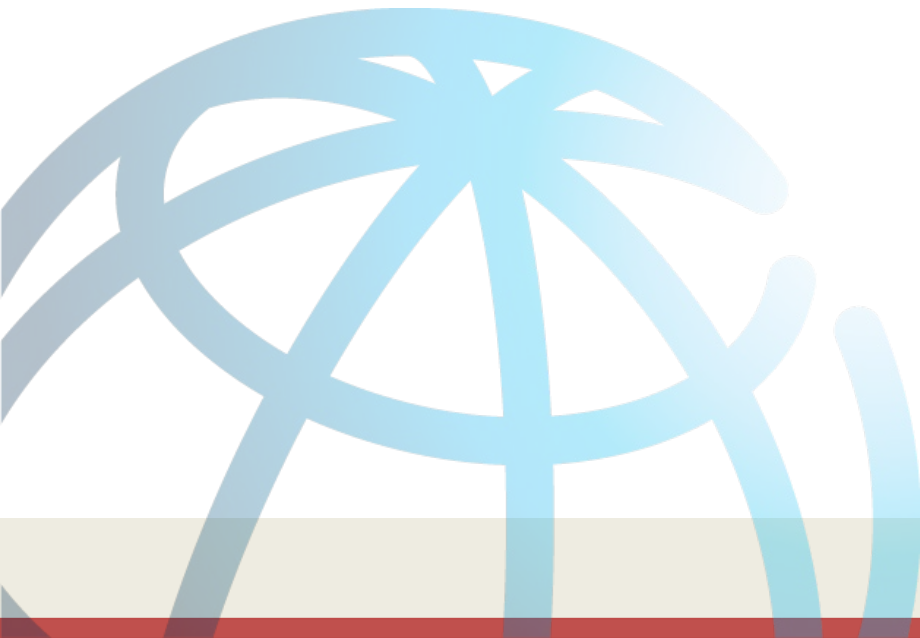

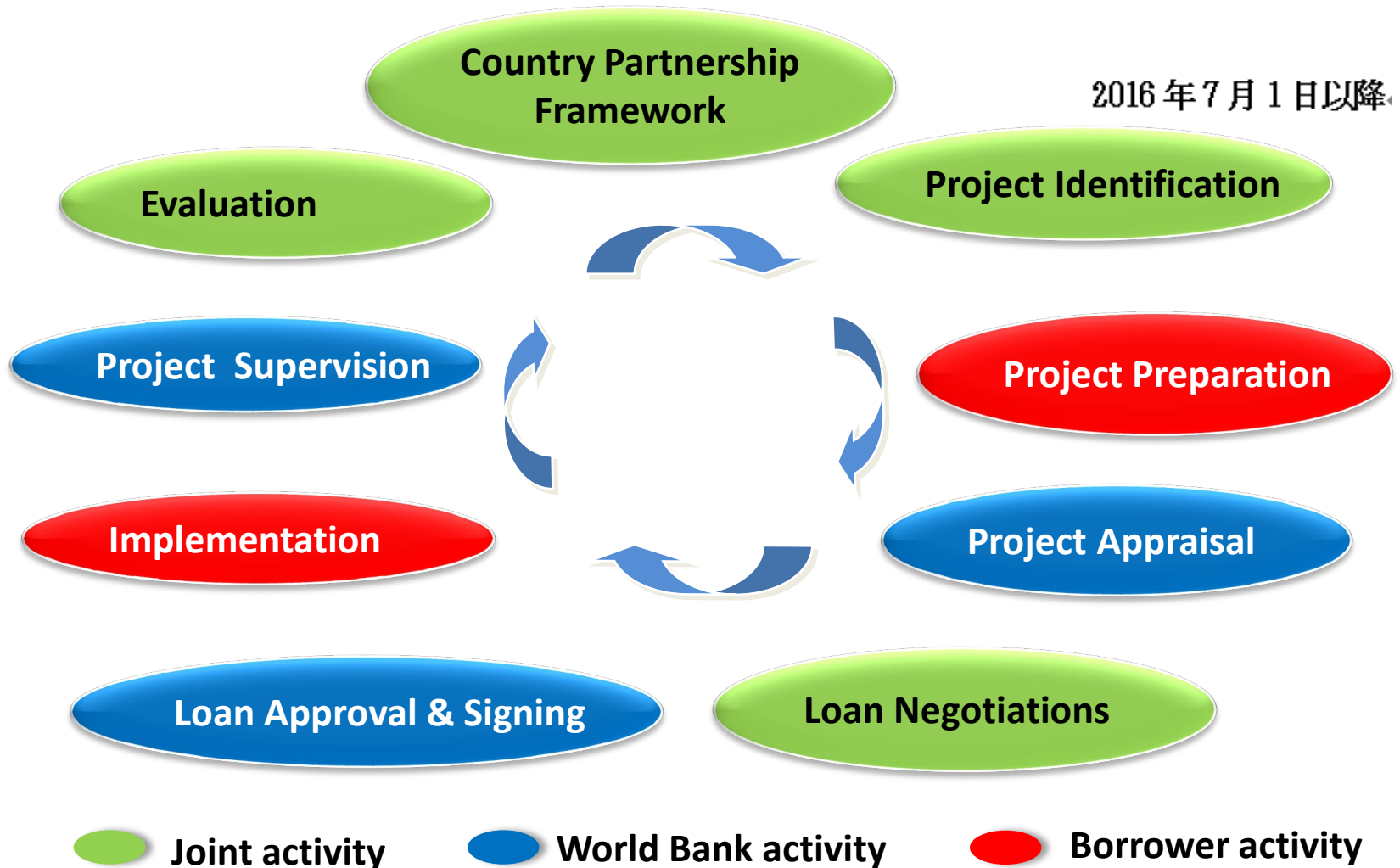

調達プロセスとビジネス機会

Stage 1- Identification

- 借入国政府と世銀がプロジェクトの発掘。
- プロジェクト情報(PID)世銀サイトで公開。
- PID:プロジェクト実施機関、TTLが記載される。

注:プロジェクト・パイプライン段階に従事するコンサルタントは、利益相反のおそれがあるため、同一プロジェクトの実施段階で借入者との契約から除外されることがある。ただし、そうした利益相反が世界銀行が納得する形で解消される場合はこの限りではない。

調達プロセスとビジネス機会

Stage 2- Preparation

- 借入者が準備段階の作業の責任を負う。
- 準備段階では通常、**フィージビリティ・スタディ**や**環境アセスメント**も実施される。
- 準備段階では、借入者は、コンサルタントを雇って業務の一部を遂行させることがある。
- **市場分析と調達戦略 (PPSD) の策定**も、この段階で開始されるのが一般的である。

調達プロセスとビジネス機会

Stage 3- Appraisal

- 世界銀行がプロジェクトの技術面、制度面、経済面、財務面)からの包括的レビュー実施。
- プロジェクト実施のための調達アプローチの詳細がPADに含まれるので、この段階で民間との対話が行われる可能性がある。
- この段階で、世界銀行による融資が承認される前に調達を開始する借入者もいる。これは「事前調達」と呼ばれ、その機会はUNDBウェブサイトにて公開される。

調達プロセスとビジネス機会

Stage 4- Negotiation & Bank Approval

- 世界銀行と借入者がIPFについて交渉を行う。その合意は、貸出、融資の文書に記録される。
- 世界銀行はプロジェクト審査の一部としてPPSD及び調達計画を精査する。融資交渉の完了までに調達計画に合意する。
- 交渉が完了すると、プロジェクトは、理事会で承認の可否を検討する。承認されると、貸出、融資、またはグラントの契約が締結される。

調達プロセスとビジネス機会

Stage 5- Implementation

- 世界銀行による承認を受け、貸出、融資、が有効となったことが宣言される。
- 「プロジェクト調達」を借入者が主導する。調達計画が世界銀行ウェブサイトに公表される。一般調達通知書もUNDB及び世界銀行ウェブサイトにて公表。
- 借入者に対して具体的なプロジェクトに対する関心を表明する良い時期である。こういった調達機会があるのか、それらが公表されるのはいつ頃になりそうか、入札またはプロポーザルの提出時期やその方法に関する情報を求めてもかまわない。

Bank Role and responsibility

Task Leaders

- プロジェクト調達関係のリスク評価、適切な調達アレンジの提案、リスク軽減策実施の監視。
- 開発プロジェクト調達戦略(PPSD)及び調達計画の策定における借入者支援。
- 調達許可を必要とする借入者の決定に対する世界銀行の「異議なし」の交付。
- 調達関係の異議の検討
- 実地調査の実施など、契約管理の監視
- 契約紛争の監視
- 当該プロジェクトに関係するあらゆる調達問題についての申立制度の維持
- ハンズオン型の拡大実施支援の提供

Bank Role and responsibility

Global Practice Specialist/Country Officer

- グローバル・プラクティス・スペシャリストは、教育、運輸、水、都市開発といった分野の専門家であり、世界銀行の融資を受けたプロジェクトに関してTLに技術協力を行う。
- カントリー・オフィサー（国別局長と国別マネージャー）は、借入者との連絡に加え、特定の国における世界銀行の貸出ポートフォリオを戦略的に監視する責任を負う。CPF はカントリー・オフィサーが策定する。大半のカントリー・オフィサーは担当する国に駐在している。

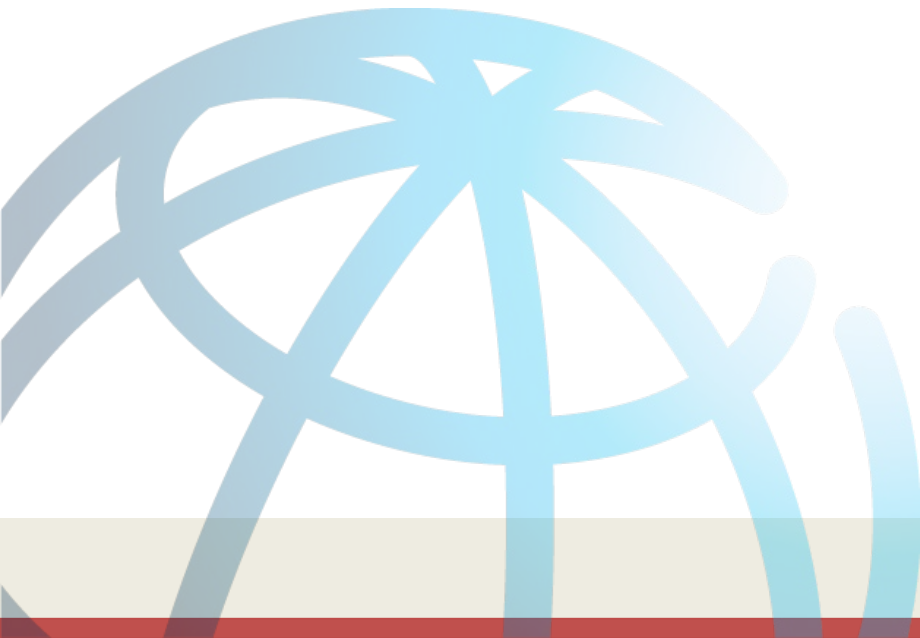
Procurement Specialist

- プロジェクト調達実施と借入者キャパシティ・ビルディングの職務は、公正成長・金融・制度総局を通じて提供される。
- 調達スペシャリストは、タスクチームの一翼を担い、世界銀行の融資を受けたプロジェクトにおける調達で借入者を支援する。
- プロジェクト調達に加え、調達改革、教育プログラム、その他の開発プログラムの推進を通じて借入者の調達能力構築などを担当する。

81. **The project's procurement risk is assessed to be 'Substantial' after mitigation measures are in place.** The procurement activities financed by the World Bank under the project shall be carried out in accordance with the World Bank's 'Procurement Regulations for IPF Borrowers: Procurement in Investment Project Financing Goods, Works, Non-Consulting and Consulting Services', dated July 2016 and revised November 2017 and August 2018 (Procurement Regulations). During the project preparation, a Project Procurement Strategy for Development (PPSD) was prepared. This PPSD recommends that the

following procurement approaches be followed to achieve the project objectives and maximize value for money: (a) the two largest civil works contracts for the WWTP and wastewater collection pipelines should be procured through Request for Proposals using the DBO contracting form (for the WWTP contract) and Request for Bid (RFB) method (for wastewater collection pipelines), using the traditional (admeasurement) contract form with an international market approach; (b) major consulting services for construction supervision and technical assistance and so on should be procured using the Quality- and Cost-Based Selection method with an international market approach; and (c) lower risk, low-value civil works contracts should be procured through the RFB method using the e-Bidding process in the Vietnam National Electronic Procurement System (VNEPS). A project procurement risk assessment has been conducted for the project. The key risks identified by this assessment and proposed mitigation measures are presented in section VI.

Quality Infrastructure Project Design-Build-Operate (DBO)とは

- a single organization responsible for the design, build and operation of the works
- **Cost efficiencies** are gained because the contract is awarded on the basis of the **lowest combined capital and operating costs**.
- The DBO model will usually ensure **improved works performance** relative to public operation.
- The DBO can also provide for **skills transfer to the Employer's staff** if this is specified in the contract, through training and even on the job training of Employer staff in the latter years of the operation period can be included.

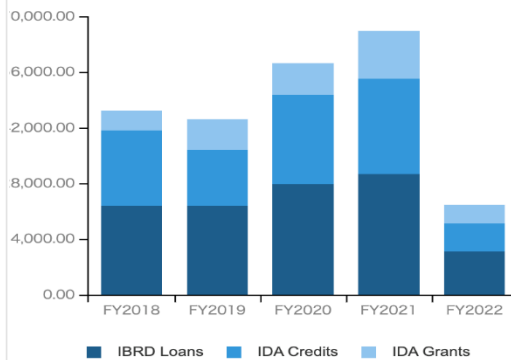

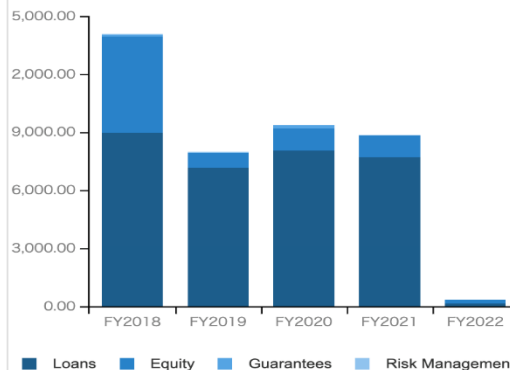
IBRD/IDA: Lending Amounts by FY

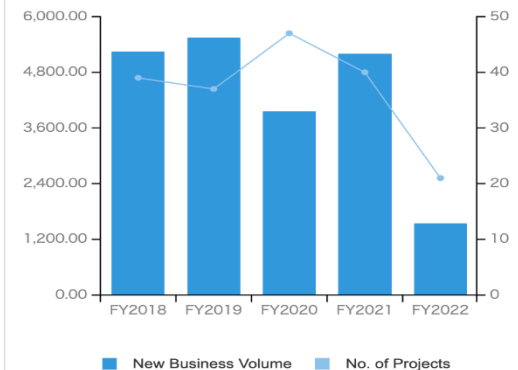
