HC survey carried out in Q1–Q4/2021

Machinery & Equipment

M&E survey carried out in Q3–Q4/2021

Construction

- Construction materials survey for regional comparison carried out in Q3–Q4/2021
- WB Survey «Construction and Civil Engineering», 2021 data – in Q3/2022

Non-market services and Housing – 2021 annual data were submitted by NSOs to the CIS-Stat in Q1/2023



Expenditure compilation status

GDP classification for CIS ICP 2021 consists of 190 BHs

A regional meeting to discuss methodological issues of GDP expenditures by BHs was organized in online format on December 12-13, 2022

Test GDP expenditures – submitted by NSOs in April-May, 2023

CIS-Stat carried out test PPPs computation

A regional meeting to discuss the test data on 2021 GDP expenditures was organized on June 27-28, 2023 in Astana, Kazakhstan

Preliminary GDP expenditures – submitted by NSOs in August, 2023

CIS-Stat carried out preliminary PPPs computation

Preliminary expenditures and PPPs submitted to the WB in September, 2023

Final GDP expenditures and PPPs – validation in Q4/2023



Data and metadata submission and validation status

Household Consumption

- NSOs submitted annual average prices for 2021 to CIS-Stat in March, 2022
- Price validation was completed in January, 2023
- Final data for Global and Regional items were submitted to the WB in May, 2023; confirmed in September

Machinery & Equipment

- NSOs submitted annual average prices for 2021 to CIS-Stat in November, 2021
- Price validation was completed in November, 2022
- Final data for Global and Regional items were submitted to the WB in May, 2023; confirmed in September



Data and metadata submission and validation status

Construction (*regional RTM approach*)

- NSOs submitted price data on construction materials (for 2021) in Q2–Q3/2022
- Validation of price data was completed in March, 2023
- Calculation of construction projects' value was carried out by a specialized consulting institution in April, 2023 (work being organized thanks to the WB financial support)

Construction (*WB approach*)

- NSOs submitted price data (for 2021) on WB «Construction and Civil Engineering» items in Q3–Q4/2022
- Primary validation of price data started in January, 2023
- Data for WB «Construction and Civil Engineering» items were submitted to the WB in September, 2023; validation is still being in progress



Non-market services

NSOs submitted the data in Q4/2022 – Q1/2023

Data validation process was completed in May, 2023

Housing – Volume measures (quantity approach)

NSOs submitted the data in Q4/2022 – Q1/2023

Data validation process was completed in May, 2023



Metadata questionnaire submission status

All questionnaires on metadata requested by the WB
were submitted in 2023
in accordance with the agreed time schedule



PPPs estimation status – 2021 time series

2021 Household Consumption and Machinery & Equipment

Test PPPs (BHs) were discussed at the regional ICP meetings in online format on March 1-2; and April 14-15, 18-20, 2022

Checking and improving data quality – final PPPs (BHs) – were computed in January, 2023

2021 Construction (RTM approach), Non-market services and Housing – final PPPs estimations carried out in Q2-Q3/2023

2021 GDP expenditures

Test PPPs estimations discussed at the regional ICP meeting in June 27-28, 2023

Preliminary PPPs estimations computed in September, 2023

Final PPPs will be computed in Q4/2023



PPP estimation status – 2017 time series

Revised 2017 CIS ICP results were published in June, 2021

All the detailed results are accessible at the CIS-Stat website in database format

Revised 2017 PPPs and expenditures were submitted to the WB in May, 2022

Some updates for the Moldova's 2017 GDP expenditures are published

A new 2017 revision is needed; it will be done simultaneously with the 2021 PPPs' computation in Q4/2023

Recent

2 meetings of the Council of Heads of the CIS NSOs

May 24, 2023, Almaty, Kazakhstan:

- The 2021 CIS ICP status was approved
- The 2024 CIS ICP start was given

September 12, 2023, Sankt-Petersburg, Russia:

- CIS-Stat in cooperation with NSOs will compute and publish annual PPPs for GDP and AIC based on extrapolation estimates
- Possibility to introduce rolling surveys into the CIS ICP will be explored after 2024
