#### Transparent, impactful, and accountable – reform of the World Bank Group's approach to disclosure

Reform of the World Bank Group outlined in the Evolution Roadmap is both necessary and timely, but the success of any reform efforts can only be ensured if there is sufficient transparency of the design, implementation, and impact of projects. Increases in quantity of funding from the World Bank Group must be matched with increases in quality of funding. The newly launched DFI Transparency Index scores the World Bank at 65.4/100 and IFC at 54.4/100 (albeit in 1st place among their peers), leaving room for improvement, especially in light of planned reforms and expanded lending, where transparency of how success is measured will be vital.
