Implementation Status

I. Survey Status

01

Price Data is almost final and has gone through different validation rounds

02

A few updates are still expected to be made to completely finalize the price data

03

This round was full of challenges in the Arab region for the first time:

- Budget issues
- Team changes
- Conflicts and wars in many of our member countries affecting data collection, revision or communication
- Other technical challenges

04

More collaboration with AfDB during this round to make sure data is consistent between the 2 regions

Under this frame, all data for Sudan will be provided from AfDB

Household Consumption

Some countries have collected actual HHC in both 2021 and 2022

Some countries have collected actual data in 2021 with extrapolation to 2022 using corresponding CPI (with some providing actual FETIs in 2022)

Some countries have collected actual data in 2022 with retrapolation to 2021 using corresponding CPI

Some dual countries have provided prices as collected for Africa

UAE: after many national trainings and workshops, we were able to obtain data from most Emirates which were averaged and retrapolated accordingly

Sudan: Because of the conflicts, we had problems in validating the prices with the country and receiving updated data

Pending updates on HHC

Importance has been reviewed and validated and the importance for Syria was updated

Dual country data is expected to be updated based on the regional validation exercise in Africa

Endorsement of prices from the UAE and/or updates are still pending

Rentals and Private Education

Data was received from all countries either for 2021 or 2022 (and treated and retrapolated accordingly)

Pending updates include Egypt, which adopted a wider geographical range; Sudan; any other updates on dual countries' final data to be consistent with AFR

Construction and Machinery & Equipment

Non-Dual Countries

Actual data for both surveys was received

Dual Countries

Actual data for both surveys was received for Egypt

Actual data for construction was received for Mauritania

Others were provided by AfDB

II. Expenditure Compilation Status

Expenditure data for the timeseries 2017-2021/2022 was received from most countries

New data for Kuwait, Sudan and UAE was estimated by our office at the detailed level using their general aggregates and previous percentage decomposition

Data for Lebanon and Syria was estimated by our office at the detailed level using their general aggregates and percentage decomposition from a close country

Validation is still ongoing with updates for Lebanon, Syria, Palestine, Mauritania, Qatar, Saudi Arabia and UAE

III. Data and Metadata Submission and Validation Status

Data for Exchange Rate,
Population, Prices,
Importance, Availability,
Current Expenditures and CPI
have been submitted

Validation is still ongoing

Validation data (coefficient of variation, minimum and maximum prices and ratios) have not been provided as countries have made updates on annual averages directly

Once preliminary results are computed during the coming two weeks, an updated submission file will be sent

Potential updates on price data for UAE and dual countries might be made

V. PPP Estimation Status

Revised PPPs for 2017 to 2020 will be computed within the next week

Preliminary PPPs for 2021 and 2022 will be computed in the next couple of weeks and revised within the next month

Forecasted PPPs for 2023 will be computed in the next couple of weeks and revised within the next month

Preliminary linking to the US Dollar will be estimated

We are planning to compute our final PPP timeseries in December 2023
