4. Major Challenges

Major challenges of the project faced within the quarter are:

- Caseworkers and supervisors were not available due to the current national issues and structure changes;
- Improvement ideas came frequently from pilot testing participants of the services which took prolonged time to finalize service pilot testing;
- Government institutions were in structure change where service providing officers might need to merge or split;
- Intermittence of the e-service system;
- Lack of adequate support and follow-up from management of service providing institutions.

The major challenges encountered during the quarter include but not limited to:

Pre-operationalization Challenges

- Intermittence of the e-service system, service Congestion and data loss;
- Caseworkers and supervisors were not available due to the current national issues and structure changes;
- Improvement ideas came frequently from pilot testing participants of the services which took prolonged time to finalize service pilot testing;
- Government institutions were in structure change where service providing officers might need to merge or split;
- Lack of adequate support and follow-up from management of service providing institutions.
- Lack of timely response from MINT to issue letters, conduct physical visit and set up management meetings.

Post-operationalization Challenges

- Lack of timely response from MINT to set-up meeting with service providing organizations that have high level of intermittence of online service provision;
- Server congested particularly when additional services are added to the system; the problem is still not solved;
